## **Department of Public Safety**

During the month of June, the COVID-19 pandemic problem continued to impact Department of Public Safety operations. We continued to work on the Biological Threat Plan and the Emergency Operation Plan revision draft. Many problems we had not encountered before in normal operations strategies and deployments continued to create the need to develop new strategies and protocols.

EMS and Public Safety Executive Assistant Dianna Knisley continued to assist with the procurement of N-95 and surgical masks and coordination of supplies to all public safety. We worked collectively among all public safety disciplines to determine what I refer to as the "burn rate". That is the normal daily, weekly, and monthly usage of PPE and sanitizer. Once determined from historical user, the goal is to develop a secure storage of an inventory of those products for future use. When the pandemic erupted the normal supply-chain was severely impacted and we could not order and receive those products in a timely manner. Establishing an inventory will allow us to maintain operations from the inventory (equivalent to the concept of the national stockpile) until the supply chain can begin normal operations again.

Overall call volume continued to increase again and return to pre-COVID numbers. Much of the meeting schedule for public safety continued to be online Zoom or Web-ex meetings. Most of my time, as Director and Emergency Management Coordinator, focused on monitoring the public safety preparedness and response to the potential virus impact on the employees and the Lower Allen Community. I continued to remotely join the daily briefings by the Governor and the Secretary of Health when possible. I also monitored the PEMA, FEMA, and county EMA releases. As we moved to the Green Phase in Cumberland County, I ended the daily ICS 211 report. Closure of the Township Building and non-essential services ended, and we began to restore normal, yet guarded operations.

The highlights of June included:

June 2nd- Civil Service Commission meeting

June 17th – Pre-inspection of the new Ambulance 1-74 at the vendor's location in Pittsburgh by Charlie, Capt. Deaven and myself.

June 18th – Attendance at the state 911 Advisory Board meeting via Web-Ex.

Attended numerous staff meetings, the Public Safety Coordination meeting the Captains' meeting, and the Directors meeting on June 26th.

As the seriousness continued to progress during June, it became evident that the stay at home order would continue into June.

#### **DEPARTMENT HEAD:**

The agency continues to cope with rapidly changing COVID-19 guidelines and local/county-level guidance on enforcement. Additionally, officers continue to deal with the aftermath of police events occurring around the nation that they have had no personal involvement with but are still placed in the position of bearing the brunt of people's frustration and anger. The number of incidents where officers are being berated and provoked has been steadily increasing. Officers continue to base actions on sound legal principles and continue to exhibit extraordinary patience in the face of adversity. Community support for our officers has been expressed in ways big and small over the last few weeks and is much appreciated.

Meetings were a mix of face-to-face and virtual, including: Board of Commissioners Meetings, Department Head Meetings, Police Department Command Staff Meetings, a Civil Service Commission meeting, civil unrest response meetings, and planning meetings, along with various ad hoc meetings regarding current issues.

Significant time in June was spent with ongoing testing of the UCR interface with our records management system. Issues were resolved and July should be the first month in a long time where we are able to submit and retrieve timely information from that resource.

Patrol Officer of the Month is Officer Laura Tamanosky. During the month of June, Ofc Tamanosky handled 57 documented calls for service, eight of which were UCR's. This is more calls than anyone else on her squad, and the third most UCR's for the department.

Not only did she handle a high quantity of calls, but she also went above and beyond in the quality of some calls. One of note was the service of an involuntary mental health commitment (302). The subject had shown clear signs of being in a disturbed mental state and was possibly a danger to himself inside the house. He was observed inside the house screaming and tearing apart furnishings. Ofc Tamanosky was able to speak with him through a closed window, and over the course of time, calm him down and persuade him into letting officers into the home, which eventually led to him going to the hospital voluntarily.

During the same shift, Ofc Tamanosky also conducted a traffic stop on a vehicle believed to be involved in marijuana sales (due to multiple factors in the stop). Ofc Tamanosky did a great job in interdicting criminal activity through self-initiation and traffic enforcement.

Ofc Tamanosky was also involved in a foot pursuit of a mentally ill woman who was trying to get into her mother's house. Ofc Tamanosky initiated the pursuit and once the subject was apprehended, she was able to calm her down and have her go to the hospital voluntarily.



The Lower Allen Twp. Police Dept. (LATPD) had 1,319 dispatched calls for service from Cumberland County Communications in June 2020. Of those calls, 101 were UCR related.

During the month of June 2020, LATPD made arrests or filed criminal charges on 39 individuals, issued 9 non-traffic citations, 104 traffic citations, 140 warnings, and 5 parking tickets.

In June EMS was finally able to begin transitioning from being fully focused on CVODI-19 to resuming projects that advance the LATEMS system. COVID-19 is still requiring vast amounts of time and dedication of all personnel in EMS. EMs is still treating and transporting COVID-19 patients on a regular basis. COVID-19 remains a threat and will continue to do for the foreseeable future. The demands of COVID-19 will continue to impact EMS in terms of dedicated time, usage of personal protective equipment and decontamination. EMS continues to rapidly change and adapt to meet the needs of the residents of Lower Allen Township.

EMS has positively impacted the residents of Lower Allen Township since the beginning of the COVID-19 public health crisis. One of the many tangible examples of EMS being actively involved in the community is the contribution EMS has made to Bethany Village. On June 29, 2020 and June 30, 2020 Bethany village tested all of their skilled care residents and their staff. Bethany villages ability to do the testing was only possible because EMS provided the fit testing for nine (9) registered nurses. EMT Amy Nye was detailed on three (3) occasions to provide fit testing to meet the needs of Bethany village.

In addition, our on-going partnership with Bethany Village we are also in contact on a weekly basis with "The Woods and the SCIC. We have strong communication and partnerships with all the facilities to ensure we notified early and if possible, assist in mitigating any community spread of COVID-19.

EMS has made progress in developing and establishing consistent and reliable supply chains for PPE, medical equipment, and medications. The availability of supplies improved during June. Our overall preparedness has improved. The remaining stress on the system is the continued high use of PPE across the nation which adversely affects the entire supply chain.

On Wednesday June 17, 2020 Director Holl, Fleet Manger Reynolds and Captain Deaven went to LifeLine facility for the final inspection on the new ambulance replacing the aging 1-74. The unit was accepted, and delivery is anticipated at the end of June or beginning of July. One the unit arrives it will require installations of radios equipment and supply transfers and inspection by the Emergency Health Services Federation to obtain licensure. The unit is expected to be in service by July 15, 2020.

One of the projects which was delayed by the COVID-19 Public Health Emergency was implementation of BLS optional skills. These are skills performed by EMT's who have received additional training and completed competencies. This project is anticipated to be completed in July and will expand the clinical capabilities of Lower Allen Township EMS improving our ability to serve the residents of Lower Allen Township.

A second project delayed by the COVID-19 Public Health Emergency was the implementation of expanded peer review clinical performance improvement. Education for the staff as well completed development of the process was provided to the staff. Initial testing was completed, and the peer review clinical performance improvement went into effect on June 19, 2020.




# Request for Service 2015 to 2020



# June -Request for Service by Hour of Day




