During June, the COVID-19 pandemic practices placed in effect through the Public Safety Administrative Order 2021-01 at the end of May continued in effect. That order provided for:

- a) COVID-19 health screenings are suspended immediately for all public safety personnel.
- b) All screening logs will be archived effective immediately.
- c) A screening log and form will be created for screening as a result, of known exposure.
- d) Personnel with known contact of a COVID-19 person will make notification based on their department guidance immediately.
- e) Non-vaccinated personnel will be screened for 10 days following an exposure.
- f) Vaccinated personnel will self-monitor and make notification based on their department guidance immediately if symptoms develop.

Captains continued to keep in contact with staff and assisted in coordination of this effort. As case counts continued to decline, I continued to follow the statewide statistics on the Department of Health dashboard. The Department of Health case stats will be continually monitored as we return to "surveillance" mode. I continued to monitor the PEMA, FEMA, and county EMA releases daily. Public Safety Planner Strawser and I continued to meet via TEAMs as he works on various annex plans to our EOP.

The highlights of June included:

June 3rd – I attended the State 911 Advisory Board online.

June 7th and 8th – Myself, Capt. Wirth, Chief Murdoch, Deputy Chief Sheely, HR Cord. Paul and I conducted interviews with the Fire Admin applicants.

June 14th – Capt. Deaven and I requested approval from the Board to initiate the IALS program and move Jackie Dougherty to the AEMT rate, which the Board graciously approved.

June 16th – I attended a Smart Board Webinar with command staff to view options in considering the EOC Smart Board budgeted in 2021.

Attended numerous meetings throughout the month including Board of Commissioners, department head, Chiefs of Police, EMS Council, staff meetings, and alarm standards meetings for the AVS-01 TMA ANSI standard development.

June saw some return of events that we have not seen in a while: Graduations at West Shore Stadium. Officers were detailed to these events, which were carried out without any major incidents.

The body-worn camera project continues. As familiarization with equipment and software evolves, policy tweaks are in progress. Overall, the devices are well-received, but not without some technical glitches. Lt. Sentman and Tech. Ickler are doing an excellent job of getting issues resolved.

Throughout the month, Captain Crone attended Police Command Staff meetings, a Police Department Supervisors' meeting, Board of Commissioners Meetings, Department Head Meetings, a County Chiefs' meeting, a Public Safety Captains' meeting, and various personnel-related meetings.

Captain Crone attended the monthly PPAC meeting and a meeting of the PLEAC Standards Committee. That committee is working on an update to the Pennsylvania accreditation standards that will be published in 2022.

Background checks on police candidates are ongoing. We are having much difficulty with applicants not making it through the background checks, with a variety of disqualifications being discovered. It is the hope that enough clean backgrounds can be presented in July so that the three positions we need to fill can be filled.





Here is a list of activities I attended or performed in addition to my normal responsibilities.

Continued Training with Corporal Scarlato to take over as CI Corporal.

Worked with WATCHGUARD on the previously ordered Mobile Video Recorders, (MVR), as well as the Body Worn Camera (BWC) issues. Worked with Technician Ickler to repair/replace equipment in patrol vehicles to include Watchguard Video equipment and minor radio issues.

Began process of inventory for all major equipment. Started with portable radio documentation.

Completed training process for all sworn officers as well as Community Service officers on functions of and use of prisoner transport van. Process completed with all offices being trained.

Arranged for CPR/First Aid Training for Officer Fitzkee.

Arranged and set up VASCAR training for Officers who are in need.

Continued the process with Dianna Knisley for ordering replacement vests for officers with vests that expire in 2021. Prepare list for potential orders in 2022. Process included assistance with Grant funding information and preparation.

In June, the Lower Allen Twp. Police Dept. (LATPD) had 1,217 dispatched calls for service from Cumberland County Communications resulting in 598 reports. Of those reports, 100 were UCR related.

During the month of June, LATPD made arrests or filed criminal charges on 32 individuals, issued 17 non-traffic citations, 102 traffic citations, 122 warnings, and 35 parking tickets.

There were 37 crashes reported to LATPD in June. Of those 37 crashes, 12 were reportable crashes and 25 were non-reportable crashes.

The EMS professionals of Lower Allen Township EMS are solely dedicated to the residents of Lower Allen Township this dedication and commitment provides the best Pre-hospital care for the residents of Lower Allen Township. Ensuring high quality excellent patient care is an essential component of the Lower Allen Township EMS mission. Lower Allen Township EMS provides the residents of Lower Allen Township with pre-hospital care exceeding the established Pennsylvania Department of Health standards.

Developing patient care standards which exceed Pennsylvania Department of Health standards was accomplished with staff input and Dr Modi's collaboration and approval. These standards of care were developed as department clinical orders. The standards of care focus on clinical care but are fiscally responsible to meet all the needs for the residents of Lower Allen Township. The updated clinical standards were effective June 11, 2021.

As part of the continual improvement process the LATEMS orientation program was evaluated and restructured. Several gaps were identified and corrected to ensure new personnel have a solid foundation. Additionally, the demonstration of patient care and equipment competencies were incorporated. The revised program is currently being tested and evaluated.

The implementation of the Hexagon Mobile responder application on May 19, 2021, has been successful. The system is new for Cumberland County Communications and EMS agencies. We have been working with Cumberland County Communications to overcome any challenges. The Hexagon Mobile responder app is an improvement and will continue to add value as all the systems become fully functional. Hexagon Mobile responder is new for Cumberland County Communications as well as the responders but the long-term benefits and enhancements to communications are mutually beneficial.

Lower Allen Township EMS hosted an Advanced Burn Life Support class on Saturday June 26, 2021, with eight personnel attending from LATEMS. Much of the cost of the ABLS Courses was covered by an American Trauma Society grant.

The Advanced Burn Life Support (ABLS) programs provide knowledge for immediate care of the burn patient up to the first 24-hours post injury. ABLS programs also support emergency preparedness and mass casualty incidents focusing on triage, burn survivability, prioritizing transport of patients, and patient treatment.

Executive Assistant Dianna Knisley and Captain Deaven received notification from the Office of the Sate Fire Commissioner that all the eligibility requirements have been meet and LATEMS will be able to apply and receive grant funding in the fall of 2021. The grant will potentially provide \$5000 to \$10,000 of funding based on state identified priorities.

On Tuesday June 29, 2021, Captain Deaven participated in a round table discussion hosted by Harrisburg Area Community College (HACC) with representatives of HACC, Department of Health, Office of work force development and the Secretary of Labor and Industry. The round table



was focused on the workforce shortages in all Public Safety Disciplines. Emergency Medical Technician, Paramedics and Police Officers are on the High Priority occupation workforce list.

Captain Deaven participated in several Emergency Health Services Federation (EHSF), PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute meetings and education to ensure the continued development of the EMS system in Lower Allen Township.



Monthly Request for Service 2020 and 2021




June-Request for Service by Day of the Week

The stroke feedback information provided by UPMC outlines the critical role of LATEMS in the treatment of a stroke patient. The metrics are comprised of National standards, PA DOH standards, and the health system. The excellent care provided by LATEMS is indicated by the patients symptoms which were reported to the ED physician prior to arrival, the time the patient arrived in the ED to being evaluated by the ED physician (0 Minutes), Stroke alert called by the ED physician prior to the arrival of the patient as a direct result of the information provided by the LATEMS crew, the patient going immediately to the CT scanner (3minutes) the patient was moved from EMS stretcher to CT scanner and the patient being seen by the neurologist in 5 minutes.
