During June, the COVID-19 pandemic continued. The acuity impact stabilized to the point that we are seeing reports of infected staff members, non-job related, but the severity has been marginalized. In general, positive cases were less impactful and infected people were less sick in general. No changes to personal protective device (PPE) requirements changed however and maximum precaution continued to be urged. All staff were kept up to date with statistics on infection rates and hospitalizations. The Emergency Health Services Council continued with their COVID briefings via an online presentation that remained at every two weeks instead of weekly due to the case declines. There continued to be fluctuations in the daily case counts resulting in the rates not being consistent.

Captain Deaven and I continued to monitor the PEMA (PA Emergency Management Agency), FEMA, EHSF, and any county EMA releases daily. Staff continue strict protocols with personal protective equipment and sanitation. To date, public safety has had no work-related COVID infections of staff despite numerous contacts and work-related exposure. This fact clearly illustrates our ongoing diligent proactive preventive measures work and the professionalism of the staff.

The highlights of June included:

June 2<sup>nd</sup> – I attended the PA 911 PEMA Advisory Board Meeting via Zoom. The Pennsylvania transition to a statewide Next Generation 911 system is under development and progressing well. I represent the PA Chiefs of Police on this Board.

June 4th – I attended the 'Quint' Housing at Station 2 as the new Pierce Quint was ceremonially dedicated and backed into station.

June  $14^{\text{th}} - 17^{\text{th}} - I$  attended the ESX meeting in Dallas as President of the PPVAR Board of Directors and presented a program on then TMA AVS-01 standard and what it will mean for alarm central station reporting to 911 centers intrusion alarm information.

June  $22^{nd}$  – Met with Phil Kearney and all the public safety captains for a workshop presentation of new proposed radio subscriber options.

June 29th – Met with Becky Davis to discuss options for County ARPA Grant to fund the Township's 2023 radio purchase on the new Cumberland County Radio System.

Throughout the month I attended various meetings internally and externally concerning administrative and operational topics for law enforcement, fire, emergency medical services, emergency management, and Township activities.

Throughout the month of June, Captain Crone took a lengthy vacation. Still, he attended Command and Staff meetings, a Board of Commissioners Meeting, a Department Head Meeting, a radio workshop meeting, and various personnel-related meetings.

Captain Crone also attended a PPAC meeting and chaired a PLEAC Standards Committee meeting.

CSOs Still and Bixler were hired and began training.

The June Patrol Officer of the Month is Johnathan Newcomer. During the month of June, Ofc Newcomer made two self-initiated arrests, one for drugs (marijuana) and the other for a DUI. He handled a total of 7 UCR investigations.

One of his UCR investigations involved multiple graffiti tags at the Capital City Mall. Ofc Newcomer utilized the LPR to locate and identify a juvenile suspect who lived nearby. Investigation led to the arrest of that subject for this and several other local graffiti incidents in the Arcona area for two separate cases. Instead of just charging the child, Ofc Newcomer took the time to figure out alternatives to misdemeanor charges, while still holding the youth accountable for his actions, and is engaging in ongoing mentoring with the youth, who is dealing with significant issues at home.

Ofc Newcomer also made a possible connection between a detained suspect for credit card fraud and an unsolved robbery. This is currently being investigated further by C.I. as the main lead in that case.



#### **COMMANDER**

Here is a list of the jobs/duties that I completed for the month of June 2022.

I was on vacation for two weeks in June 2022. Prior to my departure we worked on many projects and tasks related to both Watchguard. This included the final numbers and figures to support the grant process for the BWC award. All hours spent working on the system were tracked and logged.

For the month I assisted Evidence Technician Ickler with various vehicle maintenance projects. This included work on radios, Watchguard, as well as the computer systems. Normal maintenance of these items was completed during the times I was at work.

Interviews and the hiring process completed for two new Community Service Officers (CSO's) were also completed during this month. CSO Jane Bixler and CSO Ethan Still were hired. Start date for Still was 6/13/22 and Bixler started 6/20/22. Both will welcome additions to the Community Service Officer Staff.

We also interviewed another candidate for the position of Community Service Officer. Chelsea Barrick was interviewed on 09 June 2022. Her application is pending based upon a successful background check.

During this month, NDI arrived to install the mobile License Plate Reader, (LPR), on one the new patrol vehicles that were received. New Car 3 was chosen for the mobile LPR, and installation took place on or about 09 June 2022. This vehicle will be sent for upfitting and equipment installation as time and the schedule permits.

I participated in the scheduled range training for the month and received a new firearm. The department changed over to a different firearm. Training and practice were completed and eventually all officers were certified on the new weapons.

I attended several meetings for the month. I participated in the Safety Committee meeting for the month of June, and we performed a tour of Station 2. I also participated in another meeting in reference to the upgrade to the fitness room. This meeting also involved a discussion on what to do with the new weight room equipment received from Dicks Sporting goods. Planning to incorporate two separate areas of weight room use, (Highway Garage as well as the Municipal Services Center), were discussed and plans to move equipment were done accordingly.

Equipment ordered earlier in the year was received during the month. Equipment is now logged and accounted for via spreadsheet.

New CI computer for use in the Lieutenant's office was received and will be installed at the convenience of Scott Emerson and Dave Ickler. This will help to connect me to the crime room for cases and case tracking.

### **CSO PROGRAM**

The Community Service Officers provided coverage for a total of 247.50 hours to include special details, church details, and street coverage. The special details could have been a barn detail, park detail, or one of the pavilion details. We have experienced a shortage of CSO's to cover street shifts, so some hours went uncovered for the month. We hope to remedy this by hiring a few additional CSO's soon.

# Operational Services Bureau LOWER ALLEN TOWNSHIP

In February, the Lower Allen Twp. Police Dept. (LATPD) had 1,056 dispatched calls for service from Cumberland County Communications resulting in 483 reports. Of those reports, 100 were UCR related.

## **LOWER ALLEN TOWNSHIP**

Department of Public Safety

In June LATEMS personnel provided <u>2,210.75</u> hours of readiness and service to the citizens of Lower Allen Township. LATEMS staff participated in training with the Public Safety Officers when call volume allowed.

In June EMS participated in as many trainings with the Public Safety Officers as possible based on availability. All Full-time staff and the most active part-time staff completed the Certified Ambulance Documentation Specialist Course offered by the National Academy of Ambulance Compliance on-line.

- The Certified Ambulance Documentation Specialist (CADS) certification is specifically geared for EMTs, paramedics and other EMS field practitioners. It is also appropriate for EMS QA/QI personnel, supervisors/managers, compliance officers, billers and anyone else involved in EMS clinical care or any aspect of the ambulance service revenue cycle. Having providers at your agency with the CADS credential shows a true commitment to quality care and top-notch documentation by your agency.
- The CADS certification can give providers the edge by:
  - ✓ Opening new doors
  - ✓ Advancing their career
  - ✓ Improving their status as a healthcare professional
  - ✓ The CADS course is designed to be completed in 5-6 hours of course instruction, followed by a final exam.

LATEMS continues its participation in the national "EMS Quality Improvement Partnership: Reducing Lights-and-Siren Use in EMS" by assessing EMS providers beliefs on the value of lights and sirens and impacts on clinical outcomes. The information from the LATEMS survey and data is being compiled along with the other forty-nine (49) participants across the nation to determine ways to reduce lights and sirens, while maintaining standard of cover.



Captain Deaven was one of four EMS speakers at the 2022 EMS Call to action on Monday June 6, 2022.

Lower Allen Township EMS actively participates in state and regional EMS initiatives developing relationships and fostering partnerships to ensure the highest quality of pre-hospital care to the citizens of Lower Allen Township which demonstrates the excellent value of EMS to the citizens of Lower Allen Township. Captain Deaven actively participated in the Emergency Health Services Federation (EHSF), PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute and 911 commission meetings and education to ensure the continued development of the EMS system in Lower Allen Township.






### Monthly Request for Service 2019 and 2022




June-Request for Service by Day of the Week


