During the month of December, the COVID-19 pandemic continued to be an integral part of Department of Public Safety operations. I followed the statewide statistics on the Department of Health dashboard, which was sent daily by PA Chiefs email. During the month, infection rates continued to escalate causing public safety to return to the strict universal precautions protocols we initiated in the early months of 2020. Work from home policies were liberally permitted for staff whose job responsibilities, and technology, would allow that practice.

As continued practice throughout 2020, we maintained the highest levels of safeguard to the public and our public safety personnel who may be exposed to citizens infected with the virus.

Much of my time, as Director and Emergency Management Coordinator, continued to focus on monitoring the public safety preparedness and response to the potential virus impact to the employees and the Lower Allen Community. I also monitored the PEMA, FEMA, county EMA releases daily, and attended the Wednesday National COVID-19 White House Briefings offered virtually.

Overall call volume continued to increase throughout the month. Many of the meetings scheduled for public safety continued to be online through Zoom or Web-ex both within the department and externally. We have been using Microsoft TEAMS through our Township accounts, at times even office-to-office within the building. This practice further limits face-to-face exposure.

The highlights of December included:

December 3rd – Conducted oral interviews of the six candidates for Lieutenant and/or Sergeant promotion.

December 7th – Attended the Civil Service Commission meeting and presented the findings from the Lt/Sgt written exam and Oral interviews. The Commission recommended certification of the proposed lists. Attended numerous staff meetings and the public safety coordination meeting.

Despite 2020 being a very trying and difficult year for public safety with the emergence of the COVID-19 virus and all the safety factors surrounding it, public safety persevered and rose above the conditions to achieve some amazing outcomes. Each discipline Captain performed in an outstanding manner to lead their areas throughout the year.

Below are some highlights of the accomplishments in each discipline for 2020:

- Implemented Peer Performance Improvement for documentation and clinical.
- Expanded the capabilities of BLS to include CPAP, Glucometers, Epi pens, Narcan.
- Replaced Ambulance 1-74
- Implemented Community Paramedicine.
- Formalized a partnership with UPMC to provide Community Paramedicine to UPMC patients.
- Effectively initiated a response to the COVID-19 pandemic.
 - Implemented new policies and procedures to ensure staff and patient safety.
 - Provided training to meet the requirements of the new policies and procedures.
 - Effectively obtained PPE by using alternate supply chains
 - Assisted all Township Departments with COVID-19 supplies and PPE.
 - o N-95 fit testing for Public Safety
 - ESF # 8 functions (Bethany Village, The Woods, SCIC and Encompass)
 - Assisted Bethany Village and The Woods with N-95 Fit Testing
 - Participated in Regional and State committees and data collection for the COVID-19 pandemic response.
 - Participated in "Project ECHO" a national education collaboration specific to the COVID-19 pandemic response between the US Department of Health and Human Services and National EMS associations.
- Implemented and exercised the EMS COOP plan.
- Implemented new BLS bags for all units.
- Became a training site for AEMT and Paramedic students for Harrisburg Area Community College and the Reading School of Health Sciences Paramedic program
- Replaced the Ferno stretchers with Stryker stretchers improving staff safety.
- Implemented Legal Blood Draw Program with the Police Department.
- Establishment of an American Health and Safety Institute Training Center.
- Three Cardiac Arrest Clinical Saves.
- Delayed hiring replacement personnel lost in 2019 and 2020 due to the COVID-19 pandemic.
- EMS provided Flu vaccinations to Township personnel.
- The EMS Capital Budget plan was updated reducing future capital expenses by \$400,000.
- \$31,865.00 was received in grant money.
 - \$983.00 from a private philanthropist for the purchase of gloves due to the COVID-19 pandemic.
 - \$19,826.00 of Federal EMS CARES funding for Debt relief due to the COVID-19 pandemic.
 - \$5,856.00 from the Office of the State Fire Commissioner COVID-19 pandemic relief grant for EMS Debt relief.

2020 Public Safety Accomplishments (Captain Wirth):

- Implemented Public Safety Officer (PSO) Levels I, II, III at the beginning of 2020.
- Lower Allen Fire Company hosted a "Front Seat Rider" Class from Harrisburg Area Community college (HACC) to develop fire command skills on January 29th and February 5th.
- COVID-19 Response (March Present)
 - o COVID-19 Policies were developed for Public Safety and both fire companies.
 - Personal Protective Equipment and Supplies were distributed, when available, to PSOs and the fire companies.
 - o Fire company meetings were initially cancelled and eventually went virtual.
 - PSOs focused on completing Driver/Operator Training on Lower Allen and Lisburn fire apparatus. All training was completed.
 - Suspended Car Seat Installs and Smoke Alarm installations (March June; Nov. Present).
 - Suspended Fire Inspections (March June).
- Lower Allen Township Department of Public Safety hosted a Public Safety Career Field Trip from Cedar Cliff High School on February 27th.
- Fire Captain Frank Wirth completed the Building Code Official Academy on February 7th, 2020.
- Live-In Firefighter Marketing Program with a website was completed for rollout in 2021.
- Lower Allen Fire Company responded to a structure fire on March 9th that resulted in the Line of Duty Death (LODD) of Firefighter Jeremy Guise from Citizen's Fire Company of South Middleton Township.
- Lower Allen Fire Company and Lisburn Fire Company participated in LODD procession on March 10th and assisted with fire protection coverage during the funeral services on March 14th.
- At the request of the Lower Allen Fire Company Officers PSO coverage became 24/7 starting on March 30th.
- Part-Time Public Safety Officer Program was implemented.
 - Hiring process started in April with interviews and selections.
 - Driver/Operator Training started in June.
 - Part-Time PSOs assigned to shifts in August.
- Lower Allen and Lisburn Fire Companies submitted information for the FEMA 2019 SAFER Grant for Firefighter recruitment and retention through CapCOG. This grant was not successful.
- Fire Captain Frank Wirth submitted for the FEMA 2019 Fire Prevention and Safety Grant for a Fire Prevention Safety House and Fire Extinguisher Trainer in May. This grant was not successful.
- Live-In Firefighter program.
 - o Robert Yeagley was a Live-In from January September.
 - Brian Petkash came on board as a Live-In Firefighter from June Present.
- Annual Hose Testing was completed in July for both fire companies.
- The Full-Time PSOs have transitioned from Law Enforcement to becoming more fire centric in their duties and responsibilities starting in July and completing in December.

- Lisburn Community Fire Company conducted a Drive-Thru Food Festival in place of its Annual Festival on August 6th, 7th, and 8th, which was received very well by the community and was a success.
- Annual Ladder testing was completed for both fire companies in September.
- EMT Amy Nye and PSO Bryce Landis completed the National Honor Guard Academy on September 18th.
- Lisburn Community Fire Company and Lower Allen Fire Company No. 1 conducted a Gun Raffle as a joint fundraising event for both fire companies on September 19th. The Gun Raffle was held virtually.
- Lisburn Community Fire Company received a grant from Energy Transfer Solutions on September 25th for the purchase of York County Radios.
- Fire Captain Frank Wirth, Codes Coordinator/Fire Inspector Bill Yeagley, PSO Bryce Landis, PSO Keegan Toot, PSO Josh Zeiders, PSO Tom Kidd, and PSO Justin Kettering were sworn in a Code Inspectors by District Justice Chris Delozier on September 29th.
- Lower Allen Fire Company hosted a Foam Firefighting Basic Class from Harrisburg Area Community College (HACC) on October 11th.
- HACC Instructor Mike Taylor conducted a Hazardous Materials Operations Refresher Class from Harrisburg Area Community College (HACC) at Fire Station #1 on October 25th.
- Lower Allen Fire Company and Lisburn Community Fire Company finalized policies and procedures for a Volunteer Firefighter Recruitment and Retention Incentive Program for implementation in 2021.

2020 Police Accomplishments (Capt. Crone):

- 2020 started with an assault that eventually turned homicide, solved.
- The township, and the entire West Shore area, were plagued by vehicle entries, including stolen firearms and a stolen car.
 - Diligent investigation by our personnel, in cooperation with other local agencies, yielded arrests
 of suspects from at least four independently operating groups of individuals.
- An officer received training on detection of fraudulent inspection stickers and shared this with our other officers.
 - o This resulted in literally hundreds of traffic stops with additional offenses discovered.
- The Automated License Plate Reader continues to be successful and yielded hundreds of stops with offenses, ranging from regulatory violations to stolen vehicles, to identifying suspects in other crimes within our jurisdiction and neighboring agencies as well.
- Several fights and robberies occurring at Dave and Busters, some that spilled over into the mall, were quickly solved and a gang nexus established. Work with other agencies and mall management to curb this issue is ongoing.
- The successful use of the "flex officer" position: Numerous cases that may not have gotten the attention or intense investigation they needed were afforded this attention and many have been solved.
- Served as beta test site for new UCR reporting through CODY.
- 64% Clearance Rate for Part 1 UCR Crimes.
- Part 1 UCR crimes reported were down from 398 last year to 358 this year.

- Total UCR cases for 2020 were 1096 of which 77% were cleared. 2019 had produced 1142 incidents and experienced a 77% clearance rate.
- Arrests were at 795 for 2020, compared to 699 in 2019.
- 2 Pursuits (7 in 2019).
- 22 Use of Force incidents (same as 2019) with police suffering 3 minor injuries and 1 more significant, resulting in longer time off work, and 8 suspects experiencing only minor injuries in the form of scrapes, scratches, and taser probe penetration.
- Replaced two front line patrol vehicles with hybrid models.
- Acquired a prisoner transport van to accommodate very busy court days.
 - The pandemic has shifted the paradigm for what court days entail, but this will be extremely useful and necessary when the court systems return to normal, full operation.
- Hired 3 officers (2 new, one retirement replacement).
- Completed the promotion process for Lieutenant, with Sgt Foltz and Cpl Sentman to be promoted on 1/11/21. The selection process for the vacancy at Corporal, created by this promotion, had commenced, and will also be completed in January of 2021.
 - While not all participants could be promoted, the process revealed much about the applicants and, in many cases, highlighted the leadership we are fortunate to have within the front-line ranks of our agency.
- Court systems were just one example of the challenges and pivots required by the ever-changing pandemic guidelines. The agency adapted to all and continued to perform at a high level.
- While there were several instances of exposures that required quarantine, occurring both on the job and at home, we were blessed by having only one active case among the officers for 2020.
- Working with EMS, the police department was able to set up for DUI blood draws, in-house, saving time and resources for these otherwise long-in-duration events.
- Use of technology, including enhanced ability to download phones, through use of the DataPilot, and
 access to additional databases and information sharing through services provided by TransUnion, have
 been critical to solving numerous crimes.
- Widespread civil unrest rocked the nation, and our region was not untouched.
 - Officers from our agency participated in the major Harrisburg riot, and assisted at several smaller demonstrations, locally. Our officers performed admirably in all these instances, safeguarding first amendment rights, while ensuring safety and maintaining order.
- Captain Crone was the only law enforcement representative to participate in a Virtual Youth Town Hall
 event, among all who were invited. The event served to answer questions about social issues and police
 reform. Among the participants from that day, it appears, to date, that only Captain Crone responded
 to the follow-up questions.
- Police reform measures were a hot topic. Our agency is proud to say that nearly every measure that was pressed for was already a part of our policy.
 - Those that were not directly addressed had been implied but have been since re-worded to unequivocally address the issues.

2020 Emergency Management Accomplishments (Director Holl and Public Safety Planner Strawser):

- Drafted and implemented a Biological Threat Annex for the Township's Emergency Operations Plan for guidance in the COVID-19 crisis.
- Drafted and implemented a completely rewritten Township Emergency Operations Plan (EOP) for realignment of emergency management practices with the National Response Plan and Incident Management System.
- Began conceptualizing additional annexes to the EOP that will be developed in 2021.
 - o Included will be an adverse weather annex, pipeline/natural gas emergency annex, debris management annex, and others yet to be identified.
- Began planning for an integrated response full-scale exercise at Capital City Mall.
 - The exercise was tabled as the COVID crisis escalated in early 2020 and will be conducted at some point in the future when possible.
- Participated in the development of the updated Cumberland County Hazard Mitigation Plan as it relates to Lower Allen Township.

Thank you, Commissioners for your tremendous support of public safety during 2020. We are looking forward to great successes and achievements in 2021 as well.

DEPARTMENT HEAD:

While Captain Crone was on leave for the latter half of the month, much was still accomplished. As is often the case, time off rarely is, as the business of the department must march onward.

Officer Chimel-Freeburn and Officer Fitzkee continue to progress through their field training. Officer Walters has returned from his deployment, thankfully safe and sound, and is re-acclimating to the department and his job. The Lieutenant, Second-line supervisor interviews were held on 12/3/2020. We are pleased to report that, from that exhaustive process, Sergeant Doug Foltz and Cpl DJ Sentman will be promoted to Lieutenant on 1/11/21. First-line supervisor written exam was held on 12/11/2020. Interviews are scheduled for January 14, 2021.

Throughout the month, Captain Crone attended Board of Commissioners Meetings, Department Head Meetings, and Police Command Staff meetings. Captain Crone, as a subject-matter expert, was asked to aid in the selection process for the PLEAC Coordinator at the Pennsylvania Chiefs of Police Association. Additionally, on the accreditation front, Captain Crone and Compliance Specialist Echterling have been working diligently to ensure CALEA and PLEAC files are up to date.

December proved challenging, schedule-wise, as there were two officers on light duty, another out for medical reasons for the later portion of the month, and a variety of other issues. Through it all, the members of the agency performed admirably.

The patrol officer of the month is Officer Jonathan Newcomer. With Officers Read, Justh, and Milletics out for much of the month, the majority of consistent workload fell on Officer Newcomer. Mostly on minimum coverage, Officer Newcomer maintained good work ethic in harder than normal circumstances over the holidays. He handled 13 UCR cases for the month, the most in the department.

Also, on 12/17/20, he located and stopped a suspect vehicle from a Walmart retail theft as it drove onto the highway while he was the only available patrolman on duty. December is not the only month Ofc Newcomer worked the-majority-of his shifts at minimum coverage this year, and his extra efforts are worth commendation not just for December but for the year-as-a-whole.





The Lower Allen Twp. Police Dept. (LATPD) had 922 dispatched calls for service from Cumberland County Communications in December 2020. Of those reports, 74 were UCR related. During the month of December 2020, LATPD made arrests or filed criminal charges on 34 individuals, issued 16 non-traffic citations, 26 traffic citations, 31 warnings, and 34 parking tickets. There were 37 crashes reported to LATPD in December 2020. Of those 37 crashes, 8 were reportable crashes and 29 were non-reportable crashes.

EMS – DECEMBER 2020 Captain Tony Deaven

December was dominated by the response to the COVID-19 Pandemic. Response to patients suspected of or confined to have COVID-19 occurred multiple times during a shift. Caring for these patients requires additional time and a higher use of supplies and Personal Protective Equipment. Additionally, extra time is required to decontaminate and clean the unit. In December EMS provided care to 40 confirmed COVID-19 patients. This number does not reflect the patients who meet the Persons Under Investigation (PUI) COVID-19 criteria and require all treatments and precautions.

The community spread of COVID-19 has significantly impacted staffing in December. In all of December there were staff unable to work due to COVID-19. The policies and procedures implemented have been effective in ensure staff safety with no COVID-19 exposures being traced directly to an occurrence on the job.

The staff is working extremely hard to remain safe on and off the job and stepping up to cover short notices unexpected schedule changes to ensure coverage.

The wide community spread of COVID-19 has impacted is now impacting most of our high call volume facilities. The Bethany villages complex has been able to maintain control and prevent an outbreak. The other high call volume facilities and locations are now experiencing widespread COVID-19 outbreaks resulting in an increased EMS call volume. We are actively working with the facilities and helping ensure the best care of their residents.

In late December EMS was provided the opportunity to receive the COVID-19 vaccine. The opportunity for EMS to receive the vaccine was due to the efforts of Dr. Modi, and UPMC. The full-time staff eligible to receive the vaccine were offered the opportunity and all of them chose to get vaccinated. Staff who have had or currently have COVID-19 are not eligible to receive the vaccine for 90 days. The staff who are currently ineligible because of the COVID-19 virus are planning to get vaccinated as soon as they are eligible. We have several part-time staff members who have received the vaccine or are planning to be vaccinated the next time it is available.

Captain Deaven continues to actively participate in EHSF, PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute.


EMS call volume is not decreasing because of the COVID-19 second wave. The steady call volume and the addition of COVID-19 patients has increased the workload of the EMS staff. This trend is expected to continue and increase over the next two (2) to three (3) months.

Request for Service 2015 to 2020





December-Request for Service by Month




December-Request for Service by Day of the Week
