During January, the COVID-19 pandemic continued to be an integral part of the Department of Public Safety operations as planning continued for 1-A vaccinations. Continued to follow the statewide statistics on the Department of Health dashboard. During the month, infection rates began to fluctuate with a minor downward trend. Public safety personnel continued the strict universal precautions protocols we initiated in the early months of 2020. Work from home policies were liberally permitted for staff whose job responsibilities, and technology would allow that practice. As continued practice from 2020, we maintained the highest levels of safeguard to the public and our public safety personnel who may be exposed to citizens infected with the virus.

Much of my time, as Director and Emergency Management Coordinator, continued to focus on monitoring the public safety preparedness and response to the potential virus impact to the employees and the Lower Allen Community. I also monitored the PEMA, FEMA, county EMA releases daily, and attended the Wednesday National COVID-19 White House Briefings offered virtually.

The highlights of January included:

January 5th – I made Notifications to candidates for Cpl of their written test scores.

January 11th – Promotional ceremony was conducted for Lt Foltz and Lt Sentman at the Board of Commissioner's meeting via Zoom.

January 14th – Cpl Oral exams were conducted.

January 18th – Civil Service meeting to approve the rule of three candidate lists for Cpl.

January 25th – Board approves the Cpl eligibility list and approves promotion of Mike Scarlato as number one to Cpl. From the list.

Attended numerous staff meetings and the public safety coordination meeting.

DEPARTMENT HEAD:

While it is a new year, it is hardly a fresh start. All the issues of 2020 have transitioned seamlessly over to 2021. Fortunately, there is plenty of cause for optimism!

Sergeant Foltz and Corporal Sentman were promoted as Lieutenants this month. Lt. Foltz continues his work as Operations Commander. Lt. Sentman begins is on-the-job training with Lt. Thomas as Support Services Commander. Lt. Foltz continues his exemplary work, while Lt. Sentman is learning at a feverish pace, absorbing as much knowledge from Lt. Thomas as he can before Lt. Thomas' retirement. Lt. Sentman is meeting the challenge, head-on, and performing well.

Selection of the Corporal to back-fill Lt. Sentman's promotion has also taken place. Michael Scarlato prevailed in this process and was also selected to command the criminal investigations office.

Officer Fitzkee was released from field training. Officer Chimel-Freeburn continues to progress through his field training.

Throughout the month, Captain Crone attended Board of Commissioners Meetings, Department Head Meetings, a Civil Service meeting, and Police Command Staff meetings. A law enforcement mutual aid planning meeting was attended, and the Corporal interview process was attended. Additionally, on the accreditation front, Captain Crone and Compliance Specialist Echterling have been working diligently to ensure CALEA and PLEAC files are up to date.

A quote for the body-worn cameras was obtained and purchase approved by the board. The order has been submitted and we are now waiting for delivery. Unfortunately, no estimated delivery time is available due to high demand, manufacturing shortages, and other issues.

We still have one officer on light-duty. As of this writing, nearly all who had expressed interest in COVID-19 vaccines have received one or both shots.

Officer Rennie is the patrol officer of the month. On 1-17-21 at approx. 1409 hrs., Ofc. Rennie heard Silver Spring PD get dispatched to an active robbery at Best Buy. The robbery was to involve 6 suspects who were actively assaulting people. County advised that the suspects fled in a white Toyota with a partial registration. Ofc. Rennie positioned his patrol car RT 15N at RT 581E to see if the vehicle got onto the highway. Ofc. Rennie then observed a white Toyota with multiple occupants meeting the description of the robbery suspects. Ofc. Rennie tried to catch up to the vehicle to see if the registration matched the suspect vehicle. The vehicle continued to accelerate and pull away from him.

All suspects were taken into custody by PSP, Ofc. Cramer and Ofc. Fitzkee, as well as other supporting agencies. The suspect vehicle was stolen out of Maryland, and it was later discovered that this group of suspects were linked to 6 robberies and thefts in PA, MD, and DE. Great Job Ofc. Rennie!

There were two Naloxone administrations by police personnel in Lower Allen Township this month.





POLICE – JANUARY 2021 Operational Services Bureau Lt. Douglas Foltz, Commander Department of Public Safety

In January, the Lower Allen Twp. Police Dept. (LATPD) had 771 dispatched calls for service from Cumberland County Communications resulting in 436 reports. Of those reports, 71 were UCR related.

During the month of January, LATPD made arrests or filed criminal charges on 29 individuals, issued 9 non-traffic citations, 85 traffic citations, 109 warnings, and 9 parking tickets.

There were 27 crashes reported to LATPD in January. Of those 27 crashes, 7 were reportable crashes and 20 were non-reportable crashes.

- ***PPO Fitzkee finished the Shadow Phase and successfully completely FTO.
- ***PPO Chimel-Freeburn began Phase III of Field Training this month.

EMS – JANUARY 2021 Captain Tony Deaven SUMMARY

LOWER ALLEN TOWNSHIP

The start of 2021 was dominated by the response to the on-going COVID-19 pandemic. The numbers of COVID-19 patients remained high until the 3rd week of January. A downward trend began the last week of January which has fortunately continued across the region. We are still treating at least one COIVD-19 patient daily.

Staffing challenges related to the COVID-19 pandemic have improved since mid-January providing some relief to an on-going operational challenge.

The increased call volumes directly related to the COVID-19 pandemic at Bethany Village, The Woods, Encompass, and SCIC all started to trend downward. The implementation advanced safety procedures allowing for effective and safe personal protective equipment reuse and sterilization were completed. The implementation of these practices greatly reduces and, in some cases, eliminates the need for the continual purchasing and associated expanse of personal protective equipment. These solutions provide for a safe workplace as well improve cost effectiveness.

EMS continues to see an increase in cardiac arrest patients which is associated with the COVID-19 pandemic. The increase in Cardiac arrest patients has been an on-going trend across the region and commonwealth. Additionally, there has a been an increase of stroke patients which has been tied to the long-term effects of COVID-19. In addition to the continued increase in cardiac arrest patients a very dangerous trend of people failing to recognize common signs and symptoms of possible cardiac related problems such as chest pain, shortness of breath, arm pain and fatigue has resulted in a decrease of request for heart problems. Attempts to increase awareness on when to call EMS is being done across the commonwealth.

EMS began January short two full-time Emergency Medical Technicians. One of the positions was successfully filled with a part-time staff member providing a seamless transition. Recruitment of a replacement Emergency Medical Technician to fill the vacancy created in early January resulted in several interviews of possible candidates with mixed results. The search will continue until a replacement is found.

IV (Intravenous fluid) warmers were purchased (budgeted item) to provide for warmed IV fluid to be administered to trauma patients and hypothermic patients. Administration of warmed IV fluid is a standard of care preferred for EMS but rarely achieved by most EMS organizations. Achieving this standard of care is a benefit for the residents of Lower Allen Township. The purchase of the IV warmers provided immediate benefit to a resident of the Township during the snowstorm which occurred on January 31, 2021.

EMS has over 75% of the EMS staff choosing to receive the COVID-19 vaccination with currently over 50% of the staff having received both COVID-19 vaccinations and the remaining staff being scheduled to start their COVID-19 vaccinations in mid-February.



LATEMS has continued to deliver high quality, effective, efficient, and safe patient care directly to their side in every location. In January LATEMS touched the lives of 252 people.


Request for Service 2015 to 2021




