During March, the COVID-19 pandemic positive case reports continued to decline. No changes to personal protective device (PPE) requirements changed however and maximum precaution continued to be urged. All staff was kept up to date with statistics on infection rates and hospitalizations. The Emergency Health Services Council continued with their Wednesday morning COVID briefing via an online presentation. The frequency of those briefings however continued to be bi-weekly due to the overall declining case counts. There were however fluctuations in the daily case counts resulting in the decline not being consistent. Captain Deaven and I continued to monitor the PEMA (PA Emergency Management Agency), FEMA, and any county EMA releases daily. Staff continues strict protocols with personal protective equipment and sanitation. To date, public safety has had no work-related COVID infections of staff despite numerous contacts and work-related exposure. This fact clearly illustrates our diligent proactive preventive measures work.

The highlights of March included: March 24th – Drafted an article on the TMA AVS-01 ANSI standard to be public=shed in the spring PA Chief Bulletin distributed to the membership. AVS-01, when adopted, will change how commercial and residential alarm information is provided to 911 Centers throughout the nation.

March 26th (Sat) – Participated in the 2022 Cumberland County Chiefs police officer testing consortium. There were limited applicants this year and we do not anticipate needing to fire any officers in 2022.

March 28th – Jim Adams, the coordinator of the PA Chiefs of Police Accreditation Commission (PLEAC), presented the police department Pennsylvania Law Enforcement Accreditation award at the Board of Commissioners meeting.

March 28th to 31st – Worked daily with Dianna Knisley on finalizing the PCCD Jag grant application for the Crimewatch engineered Law Enforcement Information Exchange Portal (LEIEP) project. The application was then successfully submitted on the 31st with 14 Police Chief letters of endorsement from departments in four countries. A decision will be made on the award by fall 2022.

March 29th to April 2nd - Attended the CALEA training and awards Conference in Orlando Florida in anticipation of receiving the department's 9th CALEA award, the first being in 1995. CALEA Accreditation has been a proud and worthy tradition of the police department that has been the foundation of the agency's professionalism and commitment to community trust.

Throughout the month attended various meetings internally and externally concerning administrative and operational topics for law enforcement, fire, emergency medical services, emergency management, and Township activities.

DEPARTMENT HEAD:

Throughout the month of March, Captain Crone attended Command and Staff meetings, Board of Commissioners Meetings, Department Head Meetings, Public Safety Captains' meetings, a PLEAC Commission meeting, a license plate reader grant meeting, a meeting with mall security, a meeting with Warden Shenk at Cumberland County Prison, and various personnel-related meetings.

Command staff attended the graduation of Officers Lewis and Hughes from the police academy.

Captain Crone was out for a week's vacation this month. He also instructed at the PLEAC conference for two days and was an attendee for one. Captain Crone and Director Holl proctored the written exam for the Cumberland County Police Hiring Consortium. Attendance was underwhelming, as less than 90 applications were received, less than 60 showed up, and less than 40 candidates would be eligible to go on in the process if we were presently hiring. The month ended (and April began) with attendance at the CALEA conference to receive our 9th re-accreditation award from that organization.

The officer of the month for Cpl Read's squad is Ofc Justh. On 3/10, Ofc Justh was dispatched to a burglar alarm at Mallard Run apartments. Officers conducted the usual check of outer doors and found the building to be secure. The alarm, however, was to be coming from the 7th floor. Ofc Justh decided to make an entry and check the interior. She decided to check floor by floor in case the alarm was from a medical pull alarm in one of the apartments. Eventually, she found a room on the 6th floor with a light above the door indicating an alarm pull. She attempted contact at the front door and could hear a yell inside for help. She found that the door was ajar, so she entered the apartment and found a woman lying in the bathroom who needed medical attention. If not for Ofc Justh's thorough check of the building for the source of an alarm (even when the alarm was improperly dispatched, both location and alarm type), the woman would have been waiting for much longer for assistance, possibly to her own physical detriment.

Also, on 3/23, LAPD was dispatched to an overdose at Sheetz. Ofc Justh was the first to arrive on scene. She located the patient's vehicle and found that the car was locked. Utilizing a window punch tool, she broke the window, secured the vehicle keys, and issued Narcan to the patient. Eventually, the patient regained consciousness and was transported to the hospital. If not for Ofc Justh's quick response and quick thinking to get the patient what they needed to survive, the result would have been much different.

NALOXONE

There was one Naloxone administration by police personnel in Lower Allen Township in March.




MONTHLY TOP 40 INCIDENT COUNT BY TYPE and SELECTED OFFICER LOG FIGURES

COMMANDER:

Here is a list of activities I attended or performed in addition to my normal responsibilities.

During the month of March 2022, I continued to work on the fulfillment of the Body-Worn Camera Grant. This included troubleshooting the Body-Worn Camera (BWC) system and the devices assigned to the officers. This included both sending back items for repair and securing a replacement as well as fixing several cameras inhouse. The month of March had several cameras in need of replacement and/or repair. Also, for the month I worked on several problems with the Motor Vehicle Recording (MVR) system. These issues were repaired inhouse by Technician Ickler and me without further issue.

In early March, Evidence Technician Ickler returned to work from his medical leave. I turned back over the fulltime duties of evidence and other related tasks to him at that time. For the first week of March, I did engage in all evidence-related duties and all related responsibilities. During this time, I was requested to join the e-Discovery system by the District Attorney's office. I began using this system for the delivery of electronic evidence including videos. This system is now being used by several officers to send electronic data to the District Attorney to cut down on the number of discs that are needed.

During the month of March, Command Staff met with the mall managers to discuss the issues that are being experienced at the mall. This included the plethora of fights and other related activities that are being experienced at the mall. This also included the staffing of the mall for the Overtime shifts that are conducted by officers as well as any new ideas or plans to combat the fighting issues. This was done largely in part to prevent the escalation of violence at the mall. Plans discussed with mall management will be implemented as soon as practical for both the mall and police.

Command staff also attended the graduation of two new hires, (Officer Hughes and Officer Lewis). Academy graduation was held at the Dauphin County Technical School. Officers Hughes and Lewis entered the academy in September 2021. They are to start Field Training upon graduation from the academy and will be placed with a Field Training Officer for this purpose.

During March I also attended to several computer-related issues with officers. I contacted 3rd Element Consulting for assistance where necessary and contacted CODY as well as WATCHGUARD.

I attended several meetings during the month of March. I attended the Safety Committee meeting as well as the STOP Grant meeting via ZOOM. There was also a staff meeting at the end of March.

At the end of March, the beginning of April, Director Holl, Captain Crone, and I attended the CALEA conference in Orlando, Florida. Our agency was re-awarded with our CALEA certificate at this conference, and I participated in several classes to help to train me to become the Accreditation Manager. I also learned valuable lessons for Power DMS. Training for this subject was valuable in my transition into the Accreditation Manager for the department.

During March I also worked with Director Holl and Dick's Sporting Goods to arrange the pickup of a large donation of Sporting Equipment for our Fitness Center. The donation was set up by Director Holl and the staff at Dick's and was to be given to the public safety center's fitness equipment room. The donation provided us with new weights, dumbbells, as well racks for storage. They also donated a bench for use in the Public Safety Center. These will be distributed as deemed appropriate by the staff.

In March, the Lower Allen Twp. Police Dept. (LATPD) had 1,256 dispatched calls for service from Cumberland County Communications resulting in 518 reports. Of those reports, 117 were UCR-related.

During the month of March, LATPD made arrests or filed criminal charges on 48 individuals, and issued 24 non-traffic citations, 86 traffic citations, 161 warnings, and 30 parking tickets.

There were 38 crashes reported to LATPD in March. Of those 38 crashes, 11 were reportable crashes, and 27 were non-reportable crashes.

LOWER ALLEN TOWNSHIP

Department of Public Safety

In March LATEMS personnel provided <u>2,250.00</u> hours of readiness and service to the citizens of Lower Allen Township. LATEMS staff participated in training with the Public Safety Officers when call volume allowed on topics related to property maintenance, rope rescue, stokes basket operations, and rapid intervention team operations.

Planning and set-up continued in preparation for limited operations to begin at the Rupp Avenue station. 3rd element is working on the IT requirements. A meeting was held with Cumberland County Communications to determine the EMS system impacts, the required adjustments to the unit listings on the box cards, and unit naming conventions for the 2233 Gettysburg Road and 800 Rupp Avenue. Chief Murdoch, Captain Wirth, and Captain Deaven meet at the Rupp Avenue station to coordinate the future deployment of limited daylight staffing in the future. Development of these areas will be moved forward in April.

The quality assurance process is constantly reviewed to determine the efficiency and accuracy of reporting. The 2021 reporting data was completed, and a review of the process based on requests for additional information or corrections demonstrated a 98.6% accuracy rate.

Captain Deaven provided community outreach to the residents of the woods on Friday, March 4, 2022, providing an overview of the services provided by EMS and a fall prevention program. The fall prevention program focused on tips to reduce falls and assess the risk of falling.

Captain Deaven is submitting data for the "EMS Quality Improvement Partnership: Reducing Lightsand-Siren Use in EMS". This national initiative is aimed at improving the safety of the public and EMS personnel. LATEMS will provide data from September 1, 2021, to the present. The data indicates the current standard of classifying request services is over triaging calls based on outcomes.

Captain Deaven is part of a Cumberland County EMS council committee working with Cumberland County communications on the EMS alternate response dispatch protocol. The protocol has had very limited effect on Lower Allen Township citizens or the Public Safety Department.

Lower Allen Township EMS actively participates in state and regional EMS initiatives developing relationships and fostering partnerships to ensure the highest quality of pre-hospital care to the citizens of Lower Allen Township which demonstrates the excellent value of EMS to the citizens of Lower Allen Township. Captain Deaven actively participated in the Emergency Health Services Federation (EHSF), PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute, and 911 commission meetings and education to ensure the continued development of the EMS system in Lower Allen Township. Captain Deaven provided testimony to the House Veterans affairs and emergency preparedness committee on the EMS crisis in Pennsylvania on behalf of the Pennsylvania Fire and Emergency Services Institute.

LATEMS continues to deliver high-quality, effective, efficient, and safe patient care directly to the side of every patient in need of help providing value for the citizens of Lower Allen Township. In November LATEMS touched the lives of <u>313 citizens</u>.





Request for Service 2015 to 2022




Monthly Request for Service 2019 and 2022



March-Request for Service by Day of the Week




March-Request for Service by Hour of Day



The crew proceeded to open the walls and found a small gas-fed fire and gas leaking throughout the apartment building. The fire was extinguished and the building ventilated. The fire was a result of improper wiring that caused an electrical short which melted a gas line. There was minor damage to the building.

On 3/12/2022 in the afternoon Lower Allen Fire Company and its automatic aid partners responded to a multi-vehicle accident on Route 581 eastbound. The incident involved 73 vehicles and required the shutting down of all lanes of traffic. There were 10 patients with minor injuries. The roadway was opened back up in approximately 4 hours.

On 3/12/2022 in the evening, Lower Allen Fire Company responded to a building fire at 906 Hummel Ave. in the Borough of Lemoyne. Truck 12 responded. The building sustained heavy fire damage.

Live-In Firefighter Activities:

- Firefighter Brian Ariano responded to 25 incidents (43%) this month.
- Firefighter Tyler Rotelle responded to 29 incidents (50%) this month.
- Firefighter Brian Petkash responded to 14 incidents (24%) this month.
- Firefighter Brian Petkash has left as a live-in at Lower Allen Fire Company. He enlisted in the PA Army National Guard and will be leaving for Boot Camp in early April.
- Firefighter Patrick Reidy responded to 24 incidents (41%) this month.
