## **LOWER ALLEN TOWNSHIP**

**Department of Public Safety** 

During the month of September, the COVID-19 pandemic continued to be an integral part of Department of Public Safety operations. I followed the statewide statics on the Department of Health dashboard, which was sent daily by PA Chiefs email. Although the numbers of positive cases and seriousness of the virus continued to decline, we maintained the highest levels of universal precautions to safeguard public safety personnel who may be exposed to citizens infected with the virus.

Much of my time, as Director and Emergency Management Coordinator, I continued to focus on monitoring the public safety preparedness and response to the potential virus impact to the employees and the Lower Allen Community. I also monitored the PEMA, FEMA, county EMA releases daily, and attended the Wednesday National COVID-19 White House Briefings offered virtually.

We also continued to create a stockpile of sanitation products, masks, gloves, and other protective items to safeguard responders. With the unknown in terms of a resurgence of the virus, as well as a history of logistics supply failures. We continue to see a need to have an inventory to prepare for the worst if a spike occurs in the fall or over the winter. EMS was tasked with taking the lead on this and continued to assist with the procurement of N-95, surgical masks, sanitation supplies and hand sanitizers to coordinate all supplies for public safety.

Overall call volume continued to increase throughout the month and return to pre-COVID levels. Many of the meetings scheduled for public safety continued to be online through Zoom or Web-ex, although we did resume some face-to-face meetings both within the department and externally. The exception has been the Cumberland County Chief of Police meetings which returned to being in-person with social distancing.

A great deal of time this month was also focused on working with staff and finance preparing the 2021 budget documents.

The highlights of September included:

September 3<sup>rd</sup> – Attended the PA 911 Advisory Board meeting on which I serve as appointed representative of the PA Chiefs of Police Association

September  $14^{th}$  – Ambulance 1-74 was presented to the Commissioners for demo/tour by EMS prior to the Board meeting, and EMS Lifesaving awards were presented at the meeting.

September 29<sup>th</sup> – Attended swearing in ceremony of PSOs and Township Codes staff by DJ Delozier in Gorgas Hall.

Attended numerous staff meetings, the public safety coordination meeting, and the Captains meeting.

#### **DEPARTMENT HEAD:**

As we continue to adapt to ever-changing conditions, guidance and recommendations, the daily activity level, in terms of calls for service and criminal activity is meeting or exceeding pre-Covid levels.

September saw the completion of background checks for enough candidates to present to Civil Service. This is to happen on 10/2/20. From there, the list will be taken forward to the board for approval to hire.

Throughout the month, Captain Crone attended Board of Commissioners Meetings, Department Head Meetings, Police Command Staff meetings, a Public Safety Coordination meeting, budget preparation meetings, and a Pennsylvania Police Accreditation Commission meeting (PLEAC).

Captain Crone continues to work with Dianna Knisley to fulfill agency obligations regarding preparation to receive the Body-Worn Camera grant. This project is expected to be implemented in early 2021.

A Zoom meeting with CALEA Regional Program Manager, Paul McMillan, was attended. Program changes and standards adjustments were discussed and clarified with a sense of urgency regarding those changes relating to police reform related measures. We are well underway in making these changes. As stated before, we are generally ahead of the curve on these issues and have very little to adjust for letter-of-the-standard compliance. Similar adjustments are nearing completion for PLEAC standards as well.

Patrol Officer of the Month is Officer Laura Tamanosky. During the month of September, Ofc Tamanosky only worked five shifts that were not minimum coverage. Despite handling in a higher than normal workload, she maintained a helpful spirit and a positive attitude.

During the month she participated in two high risk, gun related incidents. The first incident involved a tenant issue at the Motel 6 in Fairview Township. A tenant was refusing to leave after being kicked out by the motel and he had pulled a gun on a Fairview Twp. officer when called to scene. Ofc Tamanosky assisted in both perimeter cover and escorting neighboring hotel guests out of harm's way. The suspect was taken into custody at gun point after brandishing a firearm (later found to be a BB gun).

The second incident was an assist with PSP York after officers engaged in a vehicle pursuit during night-time hours. The Troopers were fired upon by the suspect he stopped his vehicle. Ofc Tamanosky responded to the call for help, but also, maintained the presence of mind to go to station first and get the thermal imaging device to assist in locating the suspect, who had fled his vehicle on foot. After retrieving the device, she responded to the scene and was able to locate and maintain a visual of the suspect as involved officers attempted to track him at a distance. She was able to notify all officers on scene when the suspect began fleeing towards another wood line, and then took part in the arrest team that was tasked with taking the suspect into custody. When the arrest team engaged with the suspect, Ofc Tamanosky utilized a control hold to secure the suspect for handcuffing. His weapon was located only feet from where he was arrested. Had Ofc Tamanosky not

utilized the FLIR (Forward Looking InfraRed), there was a very good chance the suspect would have eluded police and possibly done further harm.

Ofc Tamanosky's work ethic, preparedness for high risk incidents, and performance under pressure were all displayed in September and are worthy of recognition, good job Laura!

There was one Naloxone administration by police personnel in Lower Allen Township this month.



#### MONTHLY TOP 40 INCIDENT COUNT BY TYPE and SELECTED OFFICER LOG FIGURES



# POLICE – SEPTEMBER 2020 LOWER ALLEN TOWNSHIP Operational Services Bureau Sergeant Douglas Foltz, Commander Department of Public Safety

The Lower Allen Twp. Police Dept. (LATPD) had 1,015 dispatched calls for service from Cumberland County Communications in September 2020. Of those reports, 75 were UCR related.

During the month of September 2020, LATPD made arrests or filed criminal charges on 40 individuals, issued 10 non-traffic citations, 73 traffic citations, 56 warnings, and 6 parking tickets.

## **LOWER ALLEN TOWNSHIP**

### **Department of Public Safety**

In September, EMS call volume was back to expected levels. EMS is still treating and transporting COVID-19 patients and persons under investigation. The COVID-19 numbers are on the rise again across the commonwealth. EMS continues to remain vigilant and is doing everything possible to prevent exposure to COVID-19. The increase in community spread and the age of people being infected increases the risk to EMS.

The EMS staff continues to adapt and adjust to the challenges of the pandemic and the upcoming flu season to ensure the needs of the citizens of the Lower Allen Township. EMS is providing the highest quality of clinical care with compassion and is constantly evaluating and learning through continual performance improvement.

EMT Amy Nye assisted at the Woods with N-95 fit testing. The N-95 fit testing will improve the safety for the Woods staff and help reduce future COVID-19 outbreaks.

The Pennsylvania Emergency Health Services Council held the annual state EMS conference virtually on September 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> for free to Pennsylvania EMS providers. Several staff members attended various courses over the 3 days earning continuing education.

Paramedic Schware and Captain Deaven attended training at the Cumberland County Department of Public Safety for the Hexagon mobile responder app. This App. will improve radio communications and time tracking of units. The Cumberland County Communications staff is working on reporting capabilities with the ability to provide monthly reports in the future.

On Monday September 14, 2020, several EMS staff members policer officers and the fire department were recognized for cardiac arrest saves at the Board meeting. The recognition is greatly appreciated and provides firsthand the value of a high-quality EMS system dedicated to providing care to the citizens of Lower Allen Township.

The Community paramedicine partnership with UPMC continues to be active and moving forward. Follow-up was received on visits and all the patients provided with community paramedicine services have not been readmitted in 30 days. The process of accepting, scheduling, and completing visits has been greatly streamlined and refined. Positive feedback has been received from UPMC.

Interviews were held for part-time EMT and paramedics with approximately 50% of the candidates being moved forward in the process. The number of potential new part-time staff is very limited and not expected to cover turnover. The availability of part-time personnel has decreased with COVID-19 and as a younger generation enters EMS. The COVID-19 pandemic significantly reduced the number of EMT, AEMT and paramedic course across the region which directly impacts future recruitment. Additionally, the next generation of EMS providers are not willing to work multiple jobs. The ability to rely heavily on part-time staff has been decreasing over the last few years. The need to rely on part-time staff due to COVID-19 during the last six months to fill two (2) full-time vacancies has reached its limits. Part-time staff is not able to effectively fill the two full-time vacancies.

During September, work continued, on the refinement of the 2021 EMS budget. The 2021 EMS budget request eleven (11) full-time personnel, the same as the 2020 budget. The ability to maintain the personnel at the same level in 2021 EMS Budget is due to, two factors, a highly effective scheduling process which reduces the number of full-time personnel required to cover the schedule and a strategy shift using professional development to provide Intermediate Advanced Life Support.


Captain Deaven continues to actively participate in EHSF, PA Bureau of EMS, Pennsylvania Emergency Health Services Council Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute.

EMS is continuing to treat sicker patients because of people delaying health care because of COVID-19. These delays in seeking health care magnify the importance LATEMS to the residents of Lower Allen Township.

LATEMS has continued to deliver high quality, effective, efficient, and safe patient care directly to their side in every location. In September, LATEMS touched the lives of **220** people.


## Request for Service 2015 to 2020





The Lower Allen Township Department of Public Safety is continuing 24/7 PSO Coverage to ensure consistent Fire Apparatus Driver/Operator coverage during the COVID-19 pandemic.

On 9/2/2020 Lower Allen Fire Company personnel removed all grease from the Aerial Truck and reapplied grease to it, which is an annual maintenance requirement. The fire company performing this maintenance saves approximately \$2000.

On 9/8/2020 Fire Captain Frank Wirth attended the quarterly meeting of the South-Central Task Force Incident Management Team. Personnel were briefed on the local, state, and federal response to the COVID-19 pandemic and future activities that the IMT may be tasked with, such as vaccine distribution.

On 9/10/2020 all gas monitors were serviced by Prime Safety to ensure they are calibrated for use during emergencies.
