During October, the COVID-19 pandemic practices placed in effect through the Public Safety Administrative Order 2021-01 at the end of May continued in effect. All staff were kept up to date with statistics of infection rates and hospitalizations. The Emergency Health Services Council continued with their weekly Wednesday morning COVID briefing via an online presentation. As I continued to monitor the PEMA, FEMA, and county EMA releases daily, it was evident that case rates and hospitalizations continued to increase in Cumberland County and surrounding counties. Staff was advised to continue strict protocols with personal protective equipment and sanitation. To date, public safety has had no work-related COVID infections of staff.

The highlights of October included:

October 4th - Met with the Finance Director, Twp. Manager, Capt. Deaven, and Capt. Wirth to present and discuss alternative scheduling options for EMS and PSOs that would have budget savings when fully implemented. Further review and analysis pending.

October 7th – Attended performance evaluation training hosted by Twp Mgr. concerning new performance evaluation system to be launched for 2022.

October 12th – 14th Attended the Monitoring Association (TMA) Annual Meeting held online virtually. Tuesday, during the Spotlight on Public Safety session, received the TMA Public Safety Award for contributions to the alarm industry in Co-Chairing the TMA-AVS-01 ANSI Alarm Standard underway. Thursday participated in a panel discussion concerning the same standard.

October 22nd – Presented a lecture on how to defuse a hostile situation at the PENNBOC Conf in Reading.

October 25th – Attended Board Meeting with presentation of the facilities study recommendations by Jesse Sudor and Scott Ryno.

October 26th – Attended tour of the Arkview Recovery Center on Wilson Lane with Township Staff.

October 27th – Attended a virtual meeting of the South-Central Task Force Criminal Justice Subcommittee where I serve as chairman.

Attended numerous meetings throughout the month including Board of Commissioners, department head, Chiefs of Police, EMS Council, staff meetings, EOC meetings with Planner Strawser, and alarm standards meetings for the AVS-01 TMA ANSI standard development.

COMMANDER:

Here is a list of activities I attended or performed in addition to my normal responsibilities.

Maintained a log of Computer related work completed for the month of October. This included fix or troubleshoot normal computer related issues, password problems, and any other computer related problems. Fixed or arranged the repair of 15 Computer issues to include Watchguard, BWC, MVR, computer, and other issues.

Prepared and implemented a program to use the old CI Laptop and a Surface Pro that Dianna Knisley was using as an extra computer as "court computers" to make evidence for Preliminary Hearings more user friendly and more cost effective. We were making or using many USB, DVD, and other means of electronic evidence storage for Preliminary Hearings. Now all Body Worn Camera and/or MVR video for Preliminary Hearing will be sent via link to the officer and be stored electronically. Process is evolving and is almost complete.

Discussion with Cpl. Scarlato about chain of command in setting up Court Computer. Corporal Scarlato started to work on issues that I had already addressed and had taken it upon himself to facilitate the Court Computer project. He was cautioned to work on only what was assigned and focus attention on his own duties and responsibilities.

Made list of all EZ Pass devices in patrol cars. All cars equipped with EZ Pass. All vehicles were not found to contact or be equipped with a Turnpike EZPass. Project was started to record all EZ Pass numbers and ensure that each vehicle had an assigned EZ Pass inside the vehicle. Records maintained by Dianna Knisley.

Fourth Probationary Eval for Cpl. Scarlato was done during this month as directed. All progress monitored and noted in the report. Fifth report will be done in December.

Watchguard USB issue with previously recorded data was under-taken during the month. Essentially, WATCHGUARD sent back to police, (faulty equipment replaced), and the "stored data" on the USB was sent back to be uploaded to the WATCHGUARD server.

Attachment Watchguard issues were address as part of the computer repair project. Issues were being reported from multiple officers for Car 1. The BWC would not "connect" and when it did, the dock made

audible noises that sounded as if the BWC was not connected. This was addressed over a period of several days and eventually will result I the dock being replaced.

Flex Badge Project was completed in October. Lieutenant Thomas had started the program to provide all officers with a "flex-badge" for use on their outer vest. The badge project stalled due to problems

with the vendor. An alternative was developed and ordered. Flex Badges came in and were distributed to the officers.

Assisted the CI office and acted as a liaison between CI and the Office of the District Attorney for a fatal traffic accident on Rossmoyne Road. I assisted the CI office with speaking with the District Attorney to establish the type of investigation that would be completed. The District Attorney seemed to be leaning toward a criminal case against the driver. I helped to educate the District Attorney as to the status of the case based upon the report from the officers on scene.

Three New Community Service Officers, (CSO) were sworn in during the month of October. Each is in a different phase of training, and each will be nearing the end of training soon. Also, during the month, I worked with CSO McCoy to schedule the last few hours of training for the new CSO. The plan is to release two of the three off FTO as soon as a few extra shifts can be completed.

New officers currently attending the police academy were contacted to ensure that they have all equipment and supplies they need for the academy. Two cadets have failed out of the academy based upon academics, so our cadets were contacted to ensure they had all they needed.

I covered several football games, (Trinity and CCHS/Red Land) at Trinity High School or West Shore Stadium for the month of October. I also covered a partial street shift after a call off left the street short coverage.

Attended the Cumberland County 2021 DVSCP Candlelight Vigil for the victims of domestic violence homicide on Thursday 21 October 2021.

Ordered replacement batteries for flashlights.

Assisted Technician Ickler with installation of new computer mount in the server room for WATCHGUARD equipment.

Requested permission and started talks between EMS and police for an upgrade to the radio signal to be purchased by EMS and Police to bolster radio signal in the township building.

The month of October was busy. The EMS staff demonstrated their on-going commitment and dedication to the residents of Lower Allen Township by demonstrating the value provided by a dedicated EMS division. The mission of Lower Allen Township EMS is to provide the citizens and visitors of Lower Allen Township with the full spectrum of Pre-hospital care, executing the mission with compassion and competence, as a fully integrated public safety model. EMS strives to meet the mission and exceed the expectations of the citizens of Lower Allen Township.

LATEMS staff participated in fire prevention activities with the Public Safety Offices and Lower Allen Fire company, providing personnel and equipment for two weeks of fire prevention activities. EMS personnel also participated with the Public Safety Officers and Lower Allen Fire company for the Halloween activities across the township. Staff attended the First Responder Appreciation dinner held by Representative Sheryl Delozier.

LATEMS staff was busy with multiple educational activities related to The Pennsylvania Department of Health Bureau of Emergency Medical Services EMS protocols updates for Basic Life Support and Advanced Life Support. Staff also completed the Pennsylvania Department of Health Bureau of Emergency Medical Services required Traumatic Brain Injury (TBI) education. Additionally, staff were busy completing the required pediatric education. Captain Deaven attend the ABC 360 conference held in Hershey. The conference is conducted by one of the nation's leading EMS legal and revenue recovery experts Page, Wolfberg and Wirth (PWW). Additionally, Captain Deaven attended an EMS legal and regulatory seminar held by Widener University.

LATEMS personnel have been participating in a statewide antibiotic pilot program. The pilot program has now become part of the Pennsylvania Department of Health Bureau of Emergency Medical Services Advanced Life Support (ALS) treatment protocols. This is directly due to the work of Lower Allen Township EMS and the other participating EMS agencies. The administration of the antibiotic (Cefalozin) is now the standard of care for the patients of Lower Allen Township.

Lower Allen Township EMS actively participates in state and regional EMS initiatives developing relationships and fostering partnerships to ensure the highest quality of pre-hospital care to the citizens of Lower Allen Township which demonstrates the excellent value of EMS to the citizens of Lower Allen Township. Captain Deaven actively participated in the Emergency Health Services Federation (EHSF), PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute and 911 commission meetings and education to ensure the continued development of the EMS system in Lower Allen Township.

LATEMS continues to deliver high quality, effective, efficient, and safe patient care directly to the side of every patient in need of help providing value for the citizens of Lower Allen Township. In October LATEMS touched the lives of <u>323 residents</u>.





Monthly Request for Service 2020 and 2021


October-Request for Service by Day of the Week
