During July, the COVID-19 pandemic continued. The acuity impact stabilized to the point that we are seeing reports of infected staff member, non-job related, but the severity has continued to be reduced. In general, positive cases were less impactful and persons infected were less sick in general. No changes to personal protective device (PPE) requirements changed however and maximum precaution continued to be urged. All staff was kept up to date with statistics on infection rates and hospitalizations. The Emergency Health Services Council continued with their COVID briefings via an online presentation that remained at every two weeks instead of weekly due to the case declines. There continued to be fluctuations in the daily case counts resulting in the rates not being consistent.

Captain Deaven and I continued to monitor the PEMA (PA Emergency Management Agency), FEMA, EHSF, and any county EMA releases daily. Staff continues strict protocols with personal protective equipment and sanitation. To date, public safety has had no work-related COVID infections of staff despite numerous contacts and work-related exposure. This fact clearly illustrates our ongoing diligent proactive preventive measures work and the professionalism of the staff.

The highlights of July included:

July 5th – Drafted on strategic planning document for long term organization options.

July 7th – Began drafting revisions to the Township Addressing Ordinance. All countries across the Commonwealth are moving toward GIS addressing for 911 call routing in compliance with the NENA Next Generation 911 standard. The Township addressing will need to be compliant with this standard and the ordinance is being reviewed for compliance and possible changes.

July 13th – Conducted police officer candidate interviews for the possibility of establishing a new civil service list. Candidates passing the interview will have background checks completed. A list will then be presented to the Civil Service Commission for approval.

July 21st – Began drafting the School Resource Officer Memorandum of Understanding. We will circulate internally for comment and then submit to the School District for review. The SRO MOU will need to be approved by the Commissioners as well as the School Board before becoming effective. SRO may only become a reality for start of school 2023-2024 year if funding cost share is approved.

July 27th – Attended an IPAWS Webinar to consider compatibility with the LA Alert REGROUP community notification software. IPAWS would allow public safety to make cell phone emergency notification to a defined geo-fenced area. Registration to LA Alerts would not be required for IPAWS. Throughout the month I attended various meetings internally and externally concerning administrative and operational topics for law enforcement, fire, emergency medical services, emergency management, and Township activities.

# POLICE – JULY 2022 Support Services Bureau Lt. Donald "DJ" Sentman, Commander Department of Public Safety

For the month of July 2022, the following is a list of the tasks I performed in July 2022. I continued my work with the BWC project in July 2022. This included multiple requests for video for court, video for the District Attorney's office, as well as for officers for preliminary hearings. This included work to make cases, export cases, and preserve video for posterity.

As part of this, I also fixed various issues with the system and with the BWC. As of late, we are having an influx of battery related issues with the BWC. The battery will swell to a size that makes the attachment on the carrier impossible. To date, we have replaced about 10 batteries.

As part of my daily activities, I review and monitor the various computer systems, (LPR, MVR/BWC,) etc. to ensure that the technology continues to work properly. I can fix certain issues with equipment and/or programs and contact support to remedy the rest. Several issues were resolved or referred for the month of July 2022.

I worked with Technician Ickler to harvest and collect the items from Car 7 which was involved in a motor vehicle accident when a driver pulled out in front of the operator of Car 7. These items were collected, secured, and reappropriated when necessary.

I met with Technician Ickler and the owner/operator of Tactical Wear LLC. This meeting was to provide alternate sources of equipment and/or uniform purchases for the department. Meeting was successful.

Meetings and planning for National Night Out were attended and I did arrange a contingency of Community Service Officers, (CSO's) who indicated they were interested in participating. CSO's were scheduled and assigned as needed.

Meetings and planning for the pending Lisburn Festival were also completed during the month. Outreach to the contingency of Community Service Officers and planning for the event/scheduling was completed.

I attended and completed Defensive Tactics Training on 29 July 2022. This was scheduled for earlier that month but had to be continued due to medical emergencies in the agency.

I attended several meetings and other events as part of my regular shift. I covered the County Chief's meeting for Captain Crone. I attended various meetings to include meetings in reference to the fitness room and the new equipment received. There was also a safety committee meeting during the month.

July 2022, Lt. Foltz and I participated in an interview of a potential Community Service officer applicant. We were able to complete the interview and provided the young lady with her background packet for completion. She has yet to complete her background packet and turn it back in.

During the month of July, I assisted Evidence Technician Ickler with working to get his new printer online. This was a process that continued into August.

# Operational Services Bureau LOWER ALLEN TOWNSHIP

In July, the Lower Allen Twp. Police Dept. (LATPD) had 1,171 dispatched calls for service from Cumberland County Communications resulting in 537 reports. Of those 537 reports, 93 were UCR related.

During the month of July, LATPD made arrests or filed criminal charges on 33 individuals, issued 20 non-traffic citations, 36 traffic citations, 109 warnings, and 41 parking tickets.

There were 37 crashes reported to LATPD in July. Of those 37 crashes, 9 were reportable crashes and 28 were non-reportable crashes.

Department of Public Safety

In July LATEMS personnel provided **2,363 hours of readiness and service** to the citizens of Lower Allen Township. LATEMS staff participated in training with the Public Safety Officers when call volume allowed.

In July, several staff members completed Pediatric Education for the Prehospital Provider (PEPP) course. The course is a national course provided by the American Academy of Pediatrics. The course is a two (2) year certification and provides state and national con-ed.

- PEPP represents a complete source of prehospital medical information for the emergency care
  of infants and children. Developed by the American Academy of Pediatrics, PEPP is an exciting
  curriculum designed to teach prehospital professionals how to better assess and manage ill or
  injured children.
- PEPP is a comprehensive, innovative, and highly visual course featuring case-based lectures, live-action video, hands-on skills stations, and small group scenarios.

In July outreach for the 4-minute city project began with businesses in Lower Allen Township. Presentations were made to H & H sales, Consolidated properties and Straub and Associates Real estate. Positive feedback was received and there is strong interest. Meetings with business will continue in August, September, and October.

On Friday July 29, 2022, EMS along with Fire and Police provided public education for a summer camp held by the Eberly's Mill Church of God.

LATEMS continues its participation in the national "EMS Quality Improvement Partnership: Reducing Lights-and-Siren Use in EMS" by assessing EMS providers beliefs on the value of lights and sirens and impacts on clinical outcomes.

Captain Deaven was invited and participated in a meeting as a member of the Pennsylvania Fire and Emergency Services Institute held by Senator Baker and Representative Pickett on the EMS crisis in Pennsylvania. The meeting was held in Susquehanna County an area where the EMS system is actively failing.

Lower Allen Township EMS actively participates in state and regional EMS initiatives developing relationships and fostering partnerships to ensure the highest quality of pre-hospital care to the citizens of Lower Allen Township which demonstrates the excellent value of EMS to the citizens of Lower Allen Township. Captain Deaven actively participated in the Emergency Health Services Federation (EHSF), PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute and 911 commission meetings and education to ensure the continued development of the EMS system in Lower Allen Township.





### Request for Service 2015 to 2022




### Monthly Request for Service 2019 and 2022




### July-Request for Service by Day of the Week





#### **Emergency Response Incidents:**

On 7/1/2022 in the evening Lower Allen Fire Company, Lisburn Fire Company, and Cumberland County Hazardous Materials Response Team were dispatched for a reported hazardous materials incident involving Carbon Dioxide leaking from a tank at 2700 Yetter Court (Cargill) in the Township. Personnel were removed from the area and the leak was monitored until all 117,000 pounds of the product was released. The leak was the result of a failed filling valve.

On 7/11/2022 in the morning Lower Allen Fire Company, Lisburn Fire Company, and automatic aid partners responded to a reported structure fire at 102 Wesley Drive in the Township. A hole was

burned into the floor from oils-soaked rags spontaneously combusting. Only minor damage to the structure.

On 7/11/2022 in the afternoon Lower Allen Fire Company, Lisburn Fire Company, Lower Allen EMS, and automatic aid partners responded to a report of trees on fire behind 3604 Hartzdale Drive in the Township. Additional resources were needed to extinguish the fire due to proximity to the structure, railroad tracks, and the magnitude of fire. Lower Allen EMS personnel assisted with fire attack. Railroad traffic was disrupted, but no damage to any structures.

On 7/18/2022 in the early morning Lower Allen Fire Company was dispatched to assist with a vehicle accident with entrapment at 217 South Lewisberry Road in Monaghan Township, York County. Rescue 12 responded and assisted with the extrication of the patient.




On 7/22/2022 in the afternoon Lower Allen Fire Company was dispatched to 1416 Market Street in the Borough of Camp Hill for a Structural Collapse. Rescue 12 and Truck 12 responded to assist with search of the building and pulling down unsafe portions of the building. The building sustained substantial damage due to failure of the front brick wall of the building.
