## **LOWER ALLEN TOWNSHIP**

### **Department of Public Safety**

During August, the COVID-19 pandemic practices placed in effect through the Public Safety Administrative Order 2021-01 at the end of May continued in effect. All staff were kept up to date with statistics of infection rates and hospitalizations. The Emergency Health Services Council continued with their weekly Wednesday morning COVID briefing via an online presentation. As I continued to monitor the PEMA, FEMA, and county EMA releases daily, it was evident that case rates and hospitalizations were increasing. Staff was advised to continue strict protocols with personal protective equipment and sanitation. To date, public safety has had no work-related COVID infections of staff.

Public Safety Planner Strawser and I continued to meet via TEAMs as he works on various annex plans to our EOP. Those efforts include the finalization of the pipeline emergency annex to the Emergency Operations Plan (EOP) and the Flood Annex. We continue to work on developing EOC activations and operations virtually under the EOP's concept of operations. The Township's investment in Office 365 with Teams has greatly aided that implementation.

The highlights of August included:

August  $2^{\text{nd}}$  - Public Safety Radio Replacement working group met to evaluate the current radios and the need for replacement in the 2023 Capital budget. Information supplied by the County Radio Committee was used to determine approximate replacement costs.

August 4th – Attended Crimewatch training seminar to look at options for improvement of our Crimewatch site. We have made the decision to use Crimewatch as our principal police webpage with a pointer link from the Township Webpage.

August 17<sup>th</sup> Captain Wirth and I met with Jeff Glass from United Methodist Home for Children. UMHC is reviewing their site emergency plan and requested assistance with that review and any recommendations for updates.

August 25th – Ad Hoc Committee met for a return session for a presentation from consultant Scott Ryno and Dawood consultant Jesse Sudor. The presentation outlined the finding for fire and EMS call volume in the Township and provided a GIS heat map. This call location map was compared in comparison with current station locations and any anticipated need to future station renovations or relocations. Final report to be presented to the Board of Commissioners in September.

Attended numerous meetings throughout the month including Board of Commissioners, department head, Chiefs of Police, EMS Council, staff meetings, and alarm standards meetings for the AVS-01 TMA ANSI standard development.

Ofc Boldosser had limited experience being in the role and handled it very well. I heard from many co-workers how well she did in our absence, and she also did it while on minimum coverage with only Ofc Lightner. Kudos to Ofc Boldosser for taking the reins and being successful!

Additionally, Ofc Boldosser handled 46 calls for service. 8 were UCR reports with 3 cases having charges filed. 2 cases are actively being investigated.





#### **COMMANDER:**

Here is a list of activities I attended or performed in addition to my normal responsibilities.

Prepared for and then executed said preparation at the Lisburn Community Festival. The dates of the festival were August 11-14. Festival staff was full for most of the days, with Saturday being the least full day we had for staffing. I assisted several of the evenings at the festival.

Lisburn set up was also that week. Pre-event planning included photographs from firetruck of the parking and festival/carnival set up.

Preparation for hire of three (3) new Community Service Officers commenced during the month with all three being hired at some point in the month. One new Community Service Officer, (CSO), was brought on for the festival. Other two were brought on after the festival was over.

Assisted with the hire of two new police officers, Officer Lewis, and Officer Hughes. These two new hires were also set up and scheduled for the Municipal Police Academy. This process took over a large portion of the daily activities. Two individuals had to be scheduled for a polygraph examination, psychological examination, as well as a written and physical test for the police academy. All academy gear and uniforms were sized and ordered and all equipment and uniforms for duty at Lower Allen were ordered. Two officers were also brought in a week before the start of academy and taught policy. I will continue to monitor them as they participate and eventually complete the academy.

Budget was finished in August and all new requests for additional funds were justified. I assisted in collecting information and ideas for new budget items for 2022. One of these items was found to be a proposal from Corporal Scarlato for new technology known as Cellebrite. This would assist officers with investigations involving cell phones and other electronic devices. I worked with Corporal Scarlato to put forth a written proposal for Commissioner consideration.

Corporal Scarlato continues his training and work to take over the task of Criminal Investigations Supervisor. He has needed little training or teaching which has made his transition easier. He has needed guidance on certain issues but has performed well in all assigned tasks. He is showing and demonstrating a strong grasp on his newly assigned tasks and responsibilities. Corporal Scarlato's training and mentoring will continue.

Quartermaster duties consumed a lion's share of my responsibility for August. This included getting a new car, Car 1, online and completed to replace the car crashed prior. This also included repair and troubleshooting various Body Worn Cameras as well as the MVR system in the cars.

Training was set up in Power DMS for Use of Force/ Duty to intervene. This was a Power DMS class that was set to publish for officers to complete.

Preparation for First Day of School was started during the month with a meeting scheduled at Highland Elementary School for student crossing guards as well as the crossing guards working at that school. New Crossing Guards were installed at the school for Selwick Crossing. We also implemented a new sign for stationary crossing guards that warns the motoring public of the crossing. This was a suggestion from Retired Lieutenant Thomas.

The EMS professionals of Lower Allen Township EMS are solely dedicated to the residents of Lower Allen Township. This dedication and commitment ensure the best Pre-hospital care for the residents of Lower Allen Township. Ensuring high quality excellent patient care is an essential component of the Lower Allen Township EMS mission. Lower Allen Township EMS provides the residents of Lower Allen Township with pre-hospital care exceeding the established Pennsylvania Department of Health standards.

Lower Allen Township EMS is continually working to advance patient care and ensure clinical excellence. In August Lower Allen Township EMS was approved at the <u>"Expert level"</u> for the Pennsylvania Voluntary Pediatric Recognition program. This recognition requires continual personnel background checks, pediatric education, maintenance of specialized pediatric equipment, and enhanced community outreach. The Pediatric Voluntary Recognition Program application process was completed with no additional budgetary outlay and will not create a budgetary increase because of participating the program. The "<u>Expert level"</u> recognition is currently only held by 80 EMS agencies or 5% of the EMS agencies in the Commonwealth of Pennsylvania.

The on-going saga of the now 18-month long COVID-19 pandemic continues to take its toll on the residents of Lower Allen Township. Lower Allen Township EMS is completely focused on the residents of Lower Allen Township and is delivering the highest quality of patient care in safe and timely manner even when challenged by an on-going pandemic. Unfortunately, the COVID-19 DELTA variant continues to spread with numbers of new cases and hospitalizations now matching the number new cases and hospitalizations in November of 2020. Lower Allen Township EMS is well prepared and responding in an efficient, effective, and safe manner to possible and confirmed cases of the COVID-19.

In August Lower Allen Township personnel participated in the Advanced Stroke Life Support Course held in the EOC on Friday August 20, 2021. The Advanced Stroke Life Support class was a collaboration with the Penn State Health System. The students received advanced instruction in a wide variety of areas including the rapid evaluation and assessment, identification of large vessel occlusions, stabilization, and care for stroke patients.

Lower Allen Township EMS personnel supported the Lisburn Fire company Festival by providing EMS unit standby each night. Additionally Lower Allen Township EMS personnel also returned to supporting the Trinity high school by providing stand-by services for JV and Varsity football games.

Lower Allen Township EMs personnel participated in a COOP Exercise on Monday August 30, 2021, coinciding with a planned power outage required for repairs at the MSC.







### Monthly Request for Service 2020 and 2021




## August-Request for Service by Day of the Week




