During July, the COVID-19 pandemic practices placed in effect through the Public Safety Administrative Order 2021-01 at the end of May continued in effect. All staff were kept up to date with statistics of infection rates and hospitalizations. The Emergency Health Services Council continued with their weekly Wednesday morning COVID briefing via an online presentation. The captains continued to keep in contact with their staff and assisted in coordination of our prevention and wellness efforts. I continued to monitor the PEMA, FEMA, and county EMA releases daily. Public Safety Planner Strawser and I continued to meet via TEAMs as he works on various annex plans to our EOP.

Work continued with the Partnership for Priority Verified Alarm Response (PPVAR) and The Monitoring Association (TMA) efforts to develop an ANSI standard (AVS-01) that will provide an alarm scoring matrix for central alarm centers to provide information to 911 centers. This is a public private partnership with the alarm industry and public safety. The goal is to reduce false alarms being dispatched to police agencies nation-wide. I co-chair the committee working on the standard.

Work also continued with the new Cumberland County Radio System with the Radio Advisory Board meeting via Zoom bi-weekly. We are currently collecting public safety responder questionnaire data, working on subscriber unit options, and working to identify base network options. The goal is to have a new system operational by third quarter 2023.

The highlights of July included:

July 7th – Civil Service Commission met to approve a list of eligible applicants for police positions.

July 14th – Attended a Radio subscriber demo and presentat6ions at Cumberland County 911 for Motorola and Harris portable and mobiles.

July $18^{th} - 21^{st}$ – Attended the PA Chiefs of Police Annual Training Conference at Kalahari Resorts in the Poconos. The event presented legal updates, management information, and programs concerning risk management by prominent speakers.

July 27th – Completed year-to-date expenditure review and budget analysis to determine items budgeted to be purchased and progress on their requisition. All disciplines are doing an excellent job with cost control and expenditure management.

Attended numerous meetings throughout the month including Board of Commissioners, department head, Chiefs of Police, EMS Council, staff meetings, and alarm standards meetings for the AVS-01 TMA ANSI standard development.

The body-worn camera project continues. As familiarization with equipment and software evolves, policy tweaks are in progress. Overall, the devices are well-received, but not without some technical glitches. Lt. Sentman and Tech. Ickler are doing an excellent job of getting issues resolved.

Throughout the month, Captain Crone attended Police Command Staff meetings, a Police Department Supervisors' meeting, Board of Commissioners Meetings, Department Head Meetings, a County Chiefs' meeting, a Public Safety Captains' meeting, the monthly PPAC meeting, and various personnel-related meetings, including Civil Service Commission meetings.

During the month, the remaining hires were lined up. Officer Kell was sworn in and preparation for conditional offers to other candidates were made.

Officer of the month for July is Ofc Torrie Shiley is the officer of the month for July. He handled several calls that he was able to rely on prior experience for a successful resolution.

On July 11, 2021, Ofc Shiley responded to a suicidal subject that had left a note behind at his apartment. The subject was last to be seen in Upper Allen and he coordinated with them and Summit Search and Rescue. Summit was able to locate the subject on railroad tracks and Ofc Shiley was able to talk with him and get him to go to crisis prior to a 302 being issued.

On July 20, 2021, we got a call for a 911 open line with GPS locations. Based on the sounds the caller was making, Ofc Shiley remembered a prior call in the neighborhood, and we were able to track down the phone and found all was ok.





The EMS professionals of Lower Allen Township EMS are solely dedicated to the residents of Lower Allen Township this dedication and commitment provides the best Pre-hospital care for the residents of Lower Allen Township. Ensuring high quality excellent patient care is an essential component of the Lower Allen Township EMS mission. Lower Allen Township EMS provides the residents of Lower Allen Township with pre-hospital care exceeding the established Pennsylvania Department of Health standards.

Lower Allen Township EMS is continually working to advance patient care and ensure clinical excellence. In July the application process for the Pennsylvania Voluntary Pediatric Recognition program was initiated and completed. This process requires personnel background checks, pediatric education, pediatric equipment, and enhanced community outreach. The application has been submitted for review which typically takes 30 days. The Pediatric Voluntary Recognition Program application process was completed with no additional budgetary outlay and will not create a budgetary increase because of participating the program.

Development of a formalized and enhanced staff orientation has been progressing well. The program is currently being piloted with two employees. The program provides specific benchmarks in every aspect of Lower Allen Township EMS. The program will provide new staff with a solid foundation improving clinical competency and administrative knowledge specific to Lower Allen Township EMS

In late July EMS began the monitoring the COVID-19 DELTA variant. Lower Allen Township EMS has taken several actions to reduce the impact of another COVID-19 surge on the Lower Allen Township EMS staff and the citizens of the Lower Allen Township. Specific actions include verifying all supplies on hand and ensuring there are adequate Personal Protective Equipment on hand to handle a three (3) month COVID-19 surge with built in mechanisms to maintain Personal Protective Equipment supplies if a surge continues for longer than three (3) months. The work and planning of Lower Allen Township EMS during the initial COVID-19 response has reduced the fiscal impact and improved personnel safety. Fiscally the impact of a DELTA variant surge is limited to gloves. Gloves have been on-going supply chain issues since late in 2020. Glove shortages and limitations on purchases quantity and price increases are continuing. Specific actions such as obtaining specialized ENVO N-95 reusable mask for each staff member, equipment sterilizers, reusable gowns have greatly reduced the fiscal impact. The planning and preparation ensure that Lower Allen Township EMS will be able to provide the highest quality of clinical care to the residents of Lower Allen Township.


The Intermediate Advanced Life Support (IALS) and the Community Paramedicine partnership with UPMC are both going well and provided enhanced clinical care the residents of Lower Allen Township EMS.

Captain Deaven participated in several Emergency Health Services Federation (EHSF), PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute meetings and education to ensure the continued development of the EMS system in Lower Allen Township.


Request for Service 2015 to 2021





Monthly Request for Service 2020 and 2021




July-Request for Service by Day of the Week


July-Request for Service by Hour of Day
