During January, the COVID-19 pandemic practices placed in effect through the Public Safety Administrative Order 2021-01 continued in effect, but Cumberland County positive case reports began to decline. This trend continued throughout the month. No changes to persona protective devices (PPE) changed however and maximum precaution continued to be urged. All staff were kept up to date with statistics of infection rates and hospitalizations. The Emergency Health Services Council continued with their weekly Wednesday morning COVID briefing via an online presentation. Captain Deaven and I continued to monitor the PEMA (PA Emergency Management Agency), FEMA, and any county EMA releases daily. Staff were advised to continue strict protocols with personal protective equipment and sanitation. To date, public safety has had no work-related COVID infections of staff.

The highlights of January included: January 1st – 6th I was out of state. I did manage to handle work-related tasks remotely occasionally during this time through emails and Teams Video Meetings. Several ongoing projects required attention.

January 6th – I was back and attended the Director's meeting vis Teams and the bi-weekly Alpine software conference call with the vender and the working group.

January 10th – Organized and participated in a Captain's 2022 kickoff workshop where we discussed individual and mutual goals for public safety. The captains will work collaboratively on some of the goals to move them forward to success.

January 10th – Attended the Cumberland County Emergency Management Coordinator monthly meeting sponsored by the county DPS Staff.

January 12th – Organized and attended the South-Central Task Force Criminal Justice Subcommittee meeting where we discussed reactivating armed intruder ALERRT training for police. Fire, and EMS providers. The training had been stopped during the two years of COVID restrictions.

January 14th attended numerous meetings including the plan for Alternate EMS Response proposed by the county, the Lower Allen Fire recruiting working group call, and the Cumberland County Radio Advisory Committee meeting.

January 21st through February 6th I was off sick after testing COVID positive January 21st. The contact source was not believed to be work-related and was not identified.

EMS – JANUARY 2022 Captain Tony Deaven

In January EMS began laying the groundwork for 2022 projects such as daylight staffing of station 2, increasing public relations as COVID declines, navigating the continued supply shortages and a variety of projects to improve operational efficiency.

EMS like all of society continued to deal with the Omicron variant. EMS was able to maintain staffing with no significant impacts. Shortages of personal at the local hospitals and mutual aid EMS organizations did impact EMS operations daily. Hospital Emergency rooms continued to be overcrowded extending wait times for EMS to transfer care. EMS call volume was up because of mutual aid staffing shortages these factors combined created a busy month for the EMS staff.

The application for approval to use station 2 as an EMS station was submitted to the Department of Health and was approved. The updated licensure has been received. Licensure approval was the first part of multi-part plan to ensure a smooth operational transition to being using station 2 as part of daylight staffing in March of 2022. The plan was developed with staff input and will be adjusted as necessary as challenges occur.

A meeting was held with 3rd Element to address the IT requirements. Overall, most of the systems are in place. There are minor equipment purchases and upgrades which were planned. 3rd Element can meet the March deadline. Contingency plans are in place if issues arise because of the supply chain.

A comprehensive review and inspection of minor equipment in accordance with the equipment replacement plan is in progress. The plan was developed in 2020 and has been used to effectively to ensure operational efficiency.

Captain Deaven began working on details of the fall prevention program and contacting retirement communities and churches to schedule presentations. Staff has been provided an overview of the program and education for fall checklist and fall assessments is being developed. The program is off to good start with presentations scheduled.

Captain Deaven attended the second in a series of educations sessions for the "EMS Quality Improvement Partnership: Reducing Lights-and-Siren Use in EMS". This national initiative is aimed at improving the safety of the public and EMS personnel. LATEMS will begin reporting data in February of 2022.

Lower Allen Township EMS actively participates in state and regional EMS initiatives developing relationships and fostering partnerships to ensure the highest quality of pre-hospital care to the citizens of Lower Allen Township which demonstrates the excellent value of EMS to the citizens of Lower Allen Township. Captain Deaven actively participated in the Emergency Health Services Federation (EHSF), PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute and 911 commission meetings and education to ensure the continued development of the EMS system in Lower Allen Township.






Monthly Request for Service 2019 and 2022

January-Request for Service by Hour of Day



Items of discussion were 2022 goals, such as Company Officer Training and Driver/Operator Training on the new engine, and pre-planning of target facilities in the Township. Other miscellaneous items for good order of the PSO program were discussed.

On 1/20/2022 Public Safety Director Dave Holl, LCFC Fire Chief Greg Black, LCFC Deputy Fire Chief Bryce Landis, EMS Captain Tony Deaven, and Public Safety Fire Captain met to discuss future initiatives concerning Lisburn Community Fire Company, such as EMS responses in the Lisburn area and training of additional personnel in EMS. Also, discussed continued and expanding cooperation with the Township to improve emergency service to the Lisburn area.

Emergency Response Incidents:

On 1/27/2022 in the morning Lower Allen Fire Company responded to 101 East Main Street in the Borough of Mechanicsburg for a structure fire. Initial call was for smoke in a structure and upgraded to a structure fire. Squad 12 crews assisted in fire attack, conducted overhaul, and assisted with clean-up. The structure received moderate to major fire damage.

On 1/29/2022 in the evening Lower Allen Fire Company and its mutual aid partners responded to smoke in an apartment building at 1137 Columbus Avenue in the Township. Crews assisted with investigation to determine the cause of the smoke condition was from a faulty Radiant Heat Ceiling Panel. The panel was removed, and overhaul completed with moderate damage to the apartment.

On 1/29/2022 in the evening Lower Allen Fire Company responded to an apartment building fire at 111 Bucher Hill Road in South Middleton Township. Squad 12 arrived on the scene and assisted with defensive fire operations and overhaul on the third floor of the building. The building sustained heavy fire damage.

On 1/30/2022 in the evening Lisburn Community Fire Company responded to a report of smoke in the building at 925 Round Top Road (Main Lodge at Ski Roundtop) in Warrington Township. Upon arrival there was a heavy smoke condition with fire from the dryer. Engine 24 assisted with ventilation, securing power to the dryer, and clean-up. Tanker 24 held in staging. Minor damage to the building.

Live-In Firefighter Activities:

- Firefighter Brian Ariano completed training to be a Driver/Operator on Rescue 12.
