During the month of August, the COVID-19 pandemic problem continued to impact Department of Public Safety operations. Although the numbers of positive cases and seriousness of the virus impact declined, we continued to maintain the highest levels of universal precautions to safeguard public safety personnel who may be exposed to citizens infected with the virus. We also began to create a stockpile of sanitation products, masks, gloves, and other protective items to safeguard responders. With the unknown in terms of a resurgence of the virus, as well as a history of logistics supply failures, we saw a need to have an inventory to prepare for the worst if that should unfortunately occur. EMS was tasked with taking the lead on this and continued to assist with the procurement of N-95, surgical masks, sanitation supplies and hand sanitizers to coordinate all supplies for public safety.

During the month of August, Public Safety Planner Justin Strawser continued to work on the Township's updated Emergency Operations Plan with Justin as the primary architect. He and I continued to meet frequently to discuss and make adaptations and edits to the Plan. The goal continued to be the presentation of the final draft to the Board in September for review. The hope is to have the Plan adopted by the Board in late September. Overall call volume continued to increase throughout the month and return to pre-COVID levels. Much of the meetings scheduled for public safety continued to be online through Zoom or Web-ex, although we did resume some face-to-face meetings both within the department and externally. Most of my time, as Director and Emergency Management Coordinator, continued to focus on monitoring the public safety preparedness and response to the potential virus impact to the employees and the Lower Allen Community. I also monitored the PEMA, FEMA, and county EMA releases daily.

The highlights of August included:

August 1st and 2nd – We hosted the Cumberland County Chiefs Police Officer Consortium testing at Cedar Cliff High School. Dr Stolz and staff were gracious in allowing the use of the track for the physical agility portion and the high school cafeteria for the written testing. Masks, social distancing, and all safety protocols were required and enforced. The testing resulted in a list of candidates.

August 10th and 12th – Captain Deaven, Donn Paul, and I interviewed several EMTs and Paramedics for part-time employment to supplement current schedule needs.

August 19th and 20th – Capt. Crone, Lt Thomas, Sgt Foltz, and I interviewed candidates for the police officer positions open and available. At the conclusion of the interviews. The top candidates were submitted for background investigations.

Attended numerous staff meetings, the public safety coordination meeting the Captains meeting, and the Directors meeting on August 28th.

DEPARTMENT HEAD:

As we continue to adapt to ever-changing conditions, guidance and recommendations, the daily activity level, in terms of calls for service and criminal activity is meeting or exceeding pre-Covid levels.

Unfortunately, due to some staffing circumstances, August had the agency at minimum staffing for 61% of the patrol shifts for the month. This is difficult to sustain in terms of workload. The good news is that background checks are being done and we hope to have a hire list approved by civil service soon. As of this writing (in mid-September), we are unfortunately down to 12 candidates that have passed the examinations, are academy-certified, and are still in our background process. Candidates are quickly being hired by other agencies or eliminated in the background process, creating an urgency with respect to the hiring process.

Captain Crone assisted with organization of the Consortium Testing, which was held at Cedar Cliff High School due to loss of other facilities (a thank-you to the district and staff for helping make this happen). That process started with 140 applicants, with roughly 70 showing up. At the end of the process, we had 28 candidates able to move on to oral interviews. At the conclusion of that process we had 15 eligible to move on to backgrounds, which, as previously mentioned, are inprogress. Certainly, current events are making recruiting difficult, but we continue to strive to maintain the high standards of our selection process.

Throughout the month, Captain Crone attended Board of Commissioners Meetings, Department Head Meetings, budget preparation meetings, and a Pennsylvania Police Accreditation Commission meeting (PLEAC).

It was at the PLEAC meeting that the culmination of efforts to revise standards to reflect the challenges and mandates of current reform efforts were addressed. Several standards were modified to reflect new legal mandates and best practices, most of which were already a part of our agency policies and practices. At the national level, CALEA is adopting similar revised and additional standards to address these issues as well. Captain Crone also served as a very active member of the working group responsible for developing and revising these standards.

The Body Worn Camera Grant process is continuing. Captain Crone submitted proposed policies which were scrutinized at several levels and found to be in line with what the DOJ and PCCD are looking for. A revised budget is due for submission in September.

Captain Crone also attended a PLEAC Standards Committee meeting. During this meeting, the membership addressed several current police reform topics. It is expected that these discussions will result in revised or new standards added to the program at the August PLEAC Commission meeting.

Patrol Officer of the Month is Officer Kimberly Moore. During the month of August, Ofc Moore increased her traffic enforcement by making 27 stops. She issued 16 traffic citations and 11 warnings. One of her stops resulted in her seizing a small amount of marijuana and some paraphernalia. She also made an arrest from an attempted Retail Theft at Walmart of over \$800 where the suspect fled in a vehicle. In a team effort with the Detectives' office, the suspect was located and identified, and Ofc. Moore filed charges on him. Ofc. Moore also assisted Ofc. Rennie on another Retail Theft from Walmart where the suspects fled in a vehicle. Ofc. Moore identified the vehicle as it passed her and relayed the direction of travel to Ofc. Rennie who ultimately stopped the vehicle. Ofc. Moore and Ofc. Rennie detained and identified the suspects, and charges are forthcoming. Ofc. Moore's increased self-initiated activity, along with her team player attitude, earned her the Officer of the Month for our platoon. In addition to all of this, Officer Moore spearheaded participation in the Pink Patch Project, an event that you will hear more about in September/October.



MONTHLY TOP 40 INCIDENT COUNT BY TYPE and SELECTED OFFICER LOG FIGURES



Significant Open Investigations: Detectives are continuing to work through CHILDLINE referrals. Several were received for this month and several were cleared from previous months. Detective Coffey received a difficult Rape Case that took place while the victim was tubing on the creek with the suspect. It was reported to the LAPD CI Office and Detective Coffey started the investigation. He completed the investigation and concluded that the case was to be turned over to the Fairview Township Police Department. Detective Coffey contacted Detective Jackson and the transition of the case was done without incident or problem. Detective Jackson received a case that required little if any investigation to solve.

Detective Coffey also investigated an adult missing person case. The case was reported to LAPD CI again out of concern for the adult missing person who was to have mental and physical issues. Detective Coffey was able to locate the subject and ensure her safety. This case was handled extremely well by Detective Coffey as he followed credit card and bank activity to locate the missing person safely.

Homicide investigation from 2018 continues to be worked on with court documents and other activity.

Flex Position has picked up some investigations and has performed exceptionally well in the role that has been assigned. Flex position Officer Scarlato has picked up several credit card fraud cases, the Yamaha of Camp Hill Burglary, as well as other cases from patrol. Having this assistance is greatly appreciated and has brought some open cases to a close and given us a strong third investigator in the office.

EMS – AUGUST 2020 Captain Tony Deaven <u>SUMMARY</u>

LOWER ALLEN TOWNSHIP

Department of Public Safety

In August, EMS call volume continued to return to the expected levels. The EMS staff continues to meet the constant challenges of growing and adapting to the needs of the citizens of the Lower Allen Township. EMS is providing the highest quality of clinical care with compassion and is constantly evaluating and learning through continual performance improvement.

EMS is still treating and transporting suspected and positive COVID-19 patients. Support is being provided to Bethany and the Woods as needs arise. The stability of Personal Protective Equipment has improved but is limited by the inconsistent supply chain.

On August 11, 2020 at approximately 0345, Cumberland County Communications implemented a new Computer Aided Dispatch (CAD) system produced by Hexagon. EMS has experienced only minor issues with the implementation on going. The staff at Cumberland County Communications has been helpful and resolved issues in a timely manner. The new system will not be able to provide the detailed data reports in the first stage implementation. As data becomes available, it will be integrated into the monthly reports.

On August 18, 2020, the legal blood draw program with the Police Department was initiated. Two (2) request for EMS to obtain legal blood draws were successfully completed. The value of this program is the reduction the time officers are unavailable to handle other incidents. Reducing the time involved for offices handling DUI's reduces the pressure on officers who are not involved in the DUI, which improves response time and service to the citizens of Lower Allen Township. Officer safety is improved for the officers involved in the DUI due to reducing transport time and eliminating time in emergency departments. Officer safety for the officers not involved in the DUI is improved because of reduced time officers are committed to DUI's and the need for mutual aid assistance.

August saw the completion of the development of the Community paramedicine partnership with UPMC. The first community paramedicine visit was completed in August. Referrals and visits will continue to increase as the program develops and processes are refined.

Implementation of the American Safety Health Institute (ASHI) training center, which began in February and was delayed due to the COVID-19 pandemic, was completed. The first project of the training center was to provide CPR/AED and Basic First aid refresher training to the Police Department. The process was changed to a blended education model. The updated process eliminated the need for twenty-two (22) officers to be scheduled an additional four (4) hours to attend training and eliminated the need for the four (4) EMS staff to schedule and additional ten (10) hours for instructors. The blended educational process was well received and eliminated over 120 staff hours. The process reduces cost and increases effectiveness.

In mid-August, the 2021 Capital budget request was received from Director Grove. The EMS capital budget was reviewed and revised using historical data, ADHOC projections, and experience. Captain Deaven provided Director Holl an EMS Capital Budget plan for the period of 2021 to 2025, which reduced EMS expenditures by over \$400,000. Director Holl approved the plan.

In late August, the 2021 General Operating budget request was received from Director Grove. The EMS general fund budget was reviewed and developed within the parameters established by the Board of Commissioners in 2019 requesting public safety to develop budgets with increases of not more than 7.5% annually excluding capital expenditures. The 2021 budget provided to Director Holl was developed by comprehensively evaluating the level of service recommendations of the ADHOC committee, which were adopted in 2019. The budget prioritizes the most expensive aspect, which is personnel. EMS is using the most effective scheduling process for reduction of personnel. The same process is used by well over 95% of the EMS agencies in Emergency Health Services Federation to reduce the impact of the continual EMS personnel shortage.

The 2020 EMS budget was approved for eleven (11) full-time personnel. As a direct result of the COVID-19 pandemic, the eleventh (11th) full-time person was not hired. The 2021 budget DOES NOT increase the number of full-time personnel. The 2021 budget request eleven (11) full-time personnel. The ability to maintain the personnel at the same level in 2021 is due to a shift strategy on how to achieve level C service. The new strategy emphasizes professional development in 2021. A comprehensive update will be provided in the annual ADHOC update. The EMS budget submitted to Director Holl has an estimated 5.7% increase.

Captain Deaven and EMT Amy Nye meet with the Woods administrator to assist with N-95 fit testing. EMT Nye will be doing N-95 fit testing for the woods staff in September.

Captain Deaven continues to actively participate in EHSF, PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute.




Request for Service 2015 to 2020


August-Request for Service by Day of the Week
