DPS – FEBRUARY 2022 Director David L. Holl

LOWER ALLEN TOWNSHIP

Department of Public Safety

During February, the COVID-19 pandemic positive case reports continued to decline. No changes to personal protective device (PPE) requirements changed however and maximum precaution continued to be urged. All staff was kept up to date with statistics of infection rates and hospitalizations. The Emergency Health Services Council continued with their Wednesday morning COVID briefing via an online presentation. The frequency of those briefings however changed from weekly to bi-weekly due to the declining case counts. Captain Deaven and I continued to monitor the PEMA (PA Emergency Management Agency), FEMA, and any county EMA releases daily. Staff continues strict protocols with personal protective equipment and sanitation. To date, public safety has had no work-related COVID infections of staff despite numerous contacts and work-related exposure. This fact clearly illustrates out diligent proactive preventive measures work. The highlights of February included:

February 2nd - I attended a TMA (The Monitoring Association) Virtual Town Hall, where I participated in a report of the progress toward the TMA AVS-01 ANSI Standard. I chair the Public Safety Subcommittee in the development of the standard. The standard will define the way alarm central stations evaluate alarms and provide information concerning the alarm to 911 centers. The standard will be a gamechanger for law enforcement and is intended to reduce alarm dispatches and provide greater officer safety information.

February 8th – Participated in the Pennsylvania Chiefs of Police Association Accreditation Onsite for the police department. Two PLEAC Assessors visited our offices and conducted the onsite portion of the assessment. The assessment went extremely well, and we expect a stellar report. Captain Crone, as our Accreditation Manager, did an outstanding job preparing for the accreditation assessment. He was assisted in this effort by Accreditation Assistant Julie Echterling.

February 9th – Attended the Peyton Walker Press Conference for the Cumberland County 4 Minute City launch held in our station one EMS bays. Captain Deaven

February 14th – Met with Manager Vernau in the morning and then attended the Lower Allen Township BOC meeting with agenda items for the civil Service Commission Activation, LPR expansion projects, and PD vehicle capital purchases were approved.

February 25th – Attended the Cumberland County Radio Advisory Committee via Zoom. We continued to discuss the ongoing radio project as well as choices for subscriber units both portable and mobile. I will be scheduling an onsite session with Motorial to identify the radio models and features we need for the Township.

DEPARTMENT HEAD: (INCLUDES JANUARY 2022 REPORT)

Throughout the month of January, Captain Crone attended Command and Staff meetings, Board of Commissioners Meetings, Department Head Meetings, Public Safety Captains' meetings, and various personnel-related meetings.

Progress was made in evaluation of the suitability of another tow vendor to be added to our on-call rotation. They are currently addressing zoning issues before being permitted to conduct business, but it is likely that they will meet all requirements.

Director Holl and Captain Crone met with West Shore School District administration and other local police command staff to discuss the future of safety in our schools. There are several items on the table, in terms of a graduated approach with the goal of getting SROs into the schools that need them. Conversations are ongoing and positive in tone.

Officers Hughes and Lewis are continuing to do well in the academy. They will be graduating in March.

The Patrol Officer of the Year for 2021 award was presented to Officer Robert Fitzkee. In addition to the several Patrol Officer of the Month awards, documented in prior monthly reports, he had several nominations, led the agency in nearly every metric, and continues to be productive and proactive. His work ethic, competence, and work-rate were instrumental in garnering him this honor.

The January 2022 Patrol Officer of the Month was Alex Milletics. During the month of January, Ofc Milletics continued to handle his regular 'light duty caseload, handling 10 UCR investigations and assisting other officers' investigations as well. Of note was an investigation involving the theft of nearly \$30,000 from a victim's bank account. The suspect washed the money by wiring it to a bit coin wallet. Ofc Milletics was able to locate both bitcoin wallet ID's. He researched the IDs through a cryptocurrency website and found that there was 40 million dollars between the two accounts. He alerted the AG's office and will be referring the case to a federal agency.

Ofc Milletics also enjoyed the opportunity to be handling calls on the street once more. On 1/18, he responded to a heroin overdose call in which the patient did not have a pulse and was agonal breathing. Through quick actions, he was able to administer Narcan and timely CPR, giving the patient necessary medical assistance through which, she was able to regain a heartbeat and survive.

Both incidents highlight Ofc Milletics' well-roundedness as an officer and his consistency in working hard in whatever way is needed.

The February Patrol Officer of the Month was Officer Fitzkee. During the month of February Officer Fitzkee completed an investigation initiated from a traffic stop he made on 1/20/22 for a vehicle with dark window tint. Fitzkee served a search warrant this month on the vehicle which yield a large amount of marijuana and a stolen firearm. Evidence obtained through this investigation lead to PWI

arrests as well as possibly solving a firearm theft report in East Pennsboro and furthered an investigation in Dauphin County where the suspect resides.

Also, on 2/8/2022 Officer Fitzkee found a suspicious vehicle around the mall which he later stopped for violations of the vehicle code. This traffic stop also resulted in seizure of drugs and charges against the vehicle driver and passenger. On 2/12/2022 Officer Fitzkee located drug paraphernalia in a vehicle on another traffic stop. On 2/26/2022 Officer Fitzkee conducted a traffic stop on a suspicious vehicle observed leaving Sheetz. This traffic stop resulted in multiple traffic citations as well as an arrest for PFA violation as the driver was currently violating a PFA.

Overall, in the month of February, Officer Fitzkee handled 43 total IRF's, 10 UCR's with 4 already being closed with charges, made 3 DUI arrests, and made 51 traffic stops.

There was one Naloxone administrations by police personnel in Lower Allen Township in January and one in February.










Incident Frequency by TYPE (Top 40 of 91 Shown) (Using DATE RECD)



EMS – FEBRUARY 2022 Captain Tony <u>Deaven</u>

LOWER ALLEN TOWNSHIP

Department of Public Safety

In February EMS personnel provided <u>3,276</u> hours of readiness and service to the citizens of Lower Allen Township.

LATEMS staff provided a review of medical equipment for the PSO's. Live-ins and volunteers on Tuesday February 8, 2022, and Thursday February 10, 2022. EMS staff participate in scheduled daytime fire training when available, some EMS staff were able to attend the area familiarization training on Thursday February 24, 2022.

EMS staff completed a review and inspection of all EMS minor equipment using the established replacement plan. Items requiring attention were identified and a purchase plan for 2022 was established within all budget parameters.

February was American Heart Month. EMS used social media to reach out to the community with education. EMS hosted the 4-Minute City AED Project media events. Approximately 75 to 100 people attended the main event. LATEMS is a member of the steering committee for the Cumberland County 4-Minute City Project. Cumberland County will be the third location in the nation when the project becomes operation in the fall of 2022.



The initiative to improve coverage times in Lower Allen Township based on the station study in 2021 by moving a unit to the Rupp Avenue station temporarily as the station location plan evolves over the next few years continues to make progress. The current process involves working with IT to ensure the proper hardware is available with the network so existing software can be accessed. The next step in the process will be working with Cumberland County Communications to identify the station as a location and establish the proper dispatching protocols.

Captain Deaven continued to work on public outreach and education for the fall prevention program scheduling presentation at the Woods Retirement community in March of 2022 and meetings with the leadership at Bethany and follow-up with the churches in Lower Allen Township.

Captain Deaven began submitting data for the "EMS Quality Improvement Partnership: Reducing Lights-and-Siren Use in EMS". This national initiative is aimed at improving the safety of the public and EMS personnel. LATEMS will begin reporting data in February of 2022. The initial data indicates the current standard of classifying request service is over triaging calls based on outcomes. In the future LATEMS will be working with Cumberland County Communications and the Pennsylvania EMS Medical Director to research and identify practices to improve the safety of the public and EMS providers. Lower Allen Township EMS actively participates in state and regional EMS initiatives developing relationships and fostering partnerships to ensure the highest quality of pre-hospital care to the citizens of Lower Allen Township which demonstrates the excellent value of EMS to the citizens of Lower Allen Township. Captain Deaven actively participated in the Emergency Health Services Federation (EHSF), PA Bureau of EMS, Pennsylvania Emergency Health Services Council, Ambulance Association of Pennsylvania and Pennsylvania Fire and Emergency Services Institute and 911 commission meetings and education to ensure the continued development of the EMS system in Lower Allen Township.





Request for Service 2015 to 2022




Monthly Request for Service 2019 and 2022







February-Request for Service by Hour of Day




