

ORDINANCE 2016-01

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF LOWER ALLEN TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, AMENDING, MODIFYING AND CHANGING THE CODE OF THE TOWNSHIP OF LOWER ALLEN, 1997, BY CHANGING ALL REFERENCES FROM CHIEF OF POLICE TO “CHIEF OF POLICE OR EQUIVALENT OFFICIAL,” AND SECTIONS 15-3, POWERS AND DUTIES; SECTIONS 61-3(9), DEFINITIONS; SECTIONS 61-6, LISTING OF INSTALLATIONS; SECTION 61-7, LICENSING; SECTION 61-8, PERMIT FEE; SECTION 61-11, INSPECTION OF DEVICES; SECTION 61-14, ALARM REPORTING; SECTION 121-7, RECORDS; SECTION 151-8, ALCOHOLIC BEVERAGES; SECTION 155-7, PERMIT RECORDS; SUPERVISION OF ACTIVITIES, SECTION 187-67, VIOLATIONS AND PENALTIES; SECTION 209-4, EXPERIMENTAL REGULATIONS; SECTION 209-5, STREETS CLOSED OR RESTRICTED FOR CONSTRUCTION, MAINTENANCE OR SPECIAL EVENTS; SECTION 209-8, VIOLATION NOTICE ISSUANCE; PAYMENT; SECTION 209-41, PARKING RESTRICTIONS ON PRIVATE PROPERTY AND SECTION 209-47, PARKING BY HANDICAP PERSONS OR DISABLED VETERANS.

BE IT ENACTED AND ORDAINED by the Board of Commissioners ("Board") of Lower Allen Township ("Township"), Cumberland County, Pennsylvania, and it is hereby enacted and ordained by the same as follows:

SECTION I

As a part of the Lower Allen Township Board of Commissioners policy decision to create a civilian Public Safety Director with authority over the Police Department, the Fire Companies and the Emergency Medical Services Department, the purpose of this Ordinance is to change all references in the Lower Allen Township Codified Ordinances from “Chief of Police” to “Chief of Police or equivalent official”.

SECTION II

The provisions of this Ordinance, as far as they are the same as those of Ordinances in force immediately prior to the enactment of this Ordinance, are intended as a continuation of such Ordinances and not as new enactments. The provisions of this Ordinance shall not affect any such suit or prosecution pending or to be instituted to enforce any right or penalty or to punish any offense under the authority of any Ordinance repealed by this Ordinance.

SECTION III

The provisions of this Ordinance are severable, and if any of its provisions shall be held to be unconstitutional, illegal, or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provision not been included herein.

SECTION IV

This Ordinance shall take effect immediately.
