

ORDINANCE 2017-07

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF LOWER ALLEN TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, AMENDING, MODIFYING, AND CHANGING THE CODE OF THE TOWNSHIP OF LOWER ALLEN, 1997, BY: ADDING AN EXCEPTION FOR ALTERING A TRAFFIC CONTROL DEVICE AT SECTION 209-7; ADDING SPEED LIMIT RESTRICTIONS AT SECTION 209-50; ADDING TRAFFIC CONTROL SIGNALS AT SECTION 209-51; ADDING PROHIBITED TURNS AT INTERSECTIONS AT SECTION 209-53; ADDING LANE AND TURN RESTRICTIONS AT SECTION 209-57; ADDING STOP INTERSECTIONS AT SECTION 209-58; ADDING CLOSURE OF CERTAIN STREETS TO CERTAIN VEHICLES AT SECTION 209-60; AMENDING WEIGHT LIMITS AT SECTION 209-61; ADDING PARKING RESTRICTIONS AT SECTION 209-63; ADDING PARKING PROHIBITIONS FOR CERTAIN HOURS AND/OR DAYS AT SECTION 209-64; AND ADDING A SPECIAL PURPOSE PARKING ZONE AT SECTION 209-66.

BE IT ENACTED AND ORDAINED by the Board of Commissioners (“Board”) of Lower Allen Township (“Township”), Cumberland County, Pennsylvania, and it is hereby enacted and ordained by the same as follows:

SECTION I

A. Section 209-7.C (1), shall be added as follows:

209-7. Compliance; enforcement.

C.
(1) Temporary alteration of a Traffic Signal may be allowed, if such is necessary for construction or maintenance activities within a street right-of-way. A Permit for Temporary Alteration of a Traffic Signal is required from the Township Manger or his/her designee prior to commencing the temporary alteration.

SECTION II

A. Section 209-50, Schedule I: Speed Limits of the Code of the Township of Lower Allen, 1997, shall be amended to add the following:

SECTION III

A. Section 209-51. Schedule II: Traffic Control Signals of the Code of Lower Allen, 1997, shall be amended to add the following:

Hartzdale Drive (SR 2048) at Capital City Mall Drive (SR 2051)	29

SECTION IV

A. Section 209-53, Schedule IV: Prohibited Turns at Intersections of the Code of the Township of Lower Allen, 1997, shall be amended to add the following:

SECTION V

A. Section 209-57, Schedule VIII: Lane and Turn Restrictions, shall be amended to add the following:

Lisburn Road	Westbound	St. Johns Road	Right Lane must Turn Right to St. Johns Road

SECTION VI

A. Section 209-58, Schedule IX: Stop Intersections of the Code of the Township of Lower Allen, 1997, shall be amended to add the following:

Nina Alley at Lebanon Avenue	1 - Way

SECTION VII

A. Section 209-60, Schedule XI: Closing of Certain Streets to Certain Vehicles of the Code of the Township of Lower Allen, 1997, shall be amended to add the following:

Beaver Road	Lisburn Road to Creek Road	No trucks three or more axles, except local deliveries
Lowther Road	Carlisle Road to Letchworth Road	No trucks three or more axles, except local deliveries
Manor Drive	Southbound at Lena Drive	No trucks three or more axles, except local deliveries
Milltown Road	Shetter Lane to Lisburn Road	No trucks three or more axles, except local deliveries
Rana Villa Avenue	Cedar Avenue to Glenwood Avenue	No trucks three or more axles, except local deliveries
Shetter Lane	Lisburn Road to Milltown Road	No trucks three or more axles, except local deliveries
Shoreham Road	Norman Road to end of street	No trucks three or more axles, except local deliveries

SECTION VIII

A. Section 209-61, Schedule XII: Vehicle Weight Limits of the Code of the Township of Lower Allen, 1997, shall be amended to add the following:

<u>Name of Street</u>	<u>Location or Limits</u>	<u>Gross Weight Limit</u>
Green Lane Drive	Cedar Cliff Drive to York County line	8 tons

B. Section 209-61, Schedule XII: Vehicle Weight Limits of the Code of the Township of Lower Allen, 1997, shall be amended as follows:

St. Johns Road	Lisburn Road to Slate Hill Road	3 tons

SECTION IX

A. Section 209-63, Schedule XIV: Parking Prohibited at All Times of the Code of the Township of Lower Allen, 1997, shall be amended to add the following:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Carlisle Road	North	From Stafford Road to a point 58 feet west of the western curb line of Stafford Road
Lisburn Road	West	From Wentworth Drive to a point 85 feet north of the northern curb line of Wentworth Drive
Lisburn Road	West	From Wentworth Drive to a point 54 feet south of the southern curb line of Wentworth Drive
Poplar Avenue	West	From Beacon Hill Boulevard to Township line, parking prohibited off pavement

B. Section 209-63, Schedule XIV: Parking Prohibited at All Times of the Code of the Township of Lower Allen, 1997, shall be amended as follows:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Beacon Hill Boulevard	Both	From Township Line to Township line, except as noted in Section 209-64, Schedule XV.

SECTION X

A. Section 209-64, Schedule XV: Parking Prohibited Certain Hours and/or Days of the Code of the Township of Lower Allen, 1997, shall be amended to add the following:

<u>Name of Street</u>	<u>Side</u>	<u>Date/Day/Hour</u> <u>Parking Restriction</u>	<u>Location or Limits</u>
28 th Street	Even	12:00 midnight to 4:00 pm./ December and February	Gettysburg Road to Morningside Drive
Highland Circle	Odd	12:00 midnight to 4:00 pm./ January and March	20 th Street to end
Park Circle	Odd	12:00 midnight to 4:00 pm./ January and March	Letchworth Road to end
Beacon Hill Boulevard	South	Parking permitted, dawn to dusk	Poplar Avenue to a point 360 feet west of the western curb line of Poplar Avenue

SECTION XI

A. Section 209-66, Schedule XVII: Special Purpose Parking Zones of the Code of the Township of Lower Allen, 1997, shall be amended to add the following:

<u>Name of Street</u>	<u>Side</u>	<u>Authorized Purpose or Vehicle</u>	<u>Location</u>
Seneca Avenue	North	Handicapped reserved	4042 Seneca Avenue

SECTION XII

The provisions of this ordinance, as far as they are the same as those of ordinances in force immediately prior to the enactment of this Ordinance, are intended as a continuation of such ordinances and not as new enactments. The provisions of this Ordinance shall not affect any such suit or prosecution pending or to be instituted to enforce any right or penalty or to punish any offense under the authority of any ordinance repealed by this Ordinance.

SECTION XIII

The conditions of this Ordinance are severable, and if any of its provisions shall be held to be unconstitutional, illegal, or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provision not been included herein.

SECTION XIV

This ordinance shall take effect immediately.
