What are those marks on my sidewalk?

Lower Allen Township residents want a walkable Township. In the survey conducted in Spring of 2017 as part of the Comprehensive Plan, increasing and improving pedestrian and bike connections throughout the Township ranked as one of the top goals. That goal includes improving conditions on existing pathways, like our sidewalks.

"All owners shall keep the sidewalk immediately in front of his property in good order and repair," as stated in Chapter 187, Article II of Lower Allen's codified ordinance https://ecode36o.com/11212195.

This is for several reasons:

- Safety: deteriorating conditions or heaving can cause tripping hazards
- YOUR liability: if a person falls on the sidewalk on your property, YOU, the property owner can be personally liable
- **General upkeep**: well maintained properties look nice and hold their value
- Walkability: sidewalks encourage people to walk, offering an alternative means of transportation and exercise

Lower Allen Township Code Enforcement officers are tasked with inspecting sidewalks for:

- Heaving- uplifting or uneven surfaces
- Cracking- pieces of the sidewalk which have fallen away creating holes or pits
- Spalling- the top smooth layer of concrete has worn away exposing the bumpy aggregate

Unsafe conditions in the sidewalk are marked with pink spray paint using x's to mark where resurfacing is needed or dots where possible other solutions may work to remedy the situation

What happens after my sidewalk has been marked?

- You will receive a letter in the mail from Township staff, notifying you of the condition.
- You will have sixty (60) days to repair the sidewalk.
- You might need to hire a contractor to make the repairs or you might be able to make the repairs yourself, depending on the condition of the sidewalk and your skill level. Staff can advise you about potential solutions.

Costs

- You, the property owner, will be responsible for the cost of repairs.
- Repairs can range from \$5.95 for caulk to potentially \$130 per cubic yard for concrete replacement. A contractor might even be needed, depending on the type and square footage of the repair.

DECK SAFETY

RESIDENTIAL DECK SAFETY TIPS

A properly constructed and maintained deck can provide a great place to enjoy many hours of outdoor leisure time. A poorly constructed and/or maintained deck can cause bruises, sprains and fractures, or worse.

Deck failures are becoming more frequent in the U.S. due to aging structural materials on older decks, excessive loading (such as hot tub placement with inadequate structural support), and as a result of improper deck construction methods. A web search of "residential deck failures" will show you prime examples of what can go wrong with a deck. Thankfully, this same search will yield a wealth of information about code-compliant deck detion, as well as maintenance recommendations.



sign and installa-

If you have an existing deck, check for loose, corroded or missing connections. Inspect metal connector plates and joist hangers, screws, nails and bolts. Look at all locations where lumber components of the deck are connected to something—joist to house, joist to beam, beam to post, and post to footing. Also check for significantly cracked or rotten wood, loose deck boards, loose or improperly spaced fall protection (guards and rails), missing or hard-to-grasp handrails, and improperly built stairs.

If you are planning to reconstruct or alter an existing deck, or build a new one, here are some important requirements:

- Current wood preservatives are generally less toxic, but more corrosive than preservatives used when
 chemically decay-resistant lumber was first introduced. Aluminum flashing between the house and deck,
 and lightly galvanized steel connectors, can become badly corroded in just a few months. Ask your lumber and hardware supplier to verify compatibility of materials, or use stainless steel connectors and corrosion resistant flashing.
- Where no portion of a deck is greater than 30 inches above the surrounding ground surface, fall protection is not required; however, installation of guards and rails is still recommended.
- A construction permit is not required when a deck will be self-supporting (not attached to the house) and will have no portion greater than 30 inches above the surrounding ground surface; however, a zoning permit is required for all new decks and deck enlargements.
- A zoning permit is required to verify that the deck does not exceed allowable encroachment into required
 yards (too close to a property line). If the deck construction will not allow precipitation to pass through
 and soak into the ground, we also verify that the deck area will not cause property improvements to exceed the allowable limit of impervious lot coverage.
- A construction permit is required for new decks (except as noted above), structural repairs, additions, and alterations to required safety components. You will need to submit stair, rail and guard details, framing and load path connection plan, materials list, cost estimate and site plan.

You can download a General Permit Application and a code compliance checklist for decks on the Community and Economic Development Department (CED) page at www.latwp.org. The form and checklist should also be used to request zoning approval as explained above.

The American Wood Council publishes an excellent resource, the Prescriptive Residential Deck Construction Guide (DCA-6). This guide is compatible with the 2009 edition of the International Residential Code, the building code currently used in Pennsylvania. A free download is available at www.awc.org. Open the "Education" tab, then under the Codes and Standards heading, click "Free Publications". You will find DCA-6 under the heading "Design for Code Acceptance (DCA) Series".

POOL SAFETY

SWIMMING POOL SAFETY ALERT

Because the outdoor swimming season is approaching, we are urging our readers to become familiar with pool safety regulations. Whether you already own a pool, are thinking of purchasing one, or enjoy the pool of a neighbor or friend, observing these safety guidelines could prevent an accidental injury or death.

The PA Uniform Construction Code (UCC) regulations adopt standards published by the International Code Council pertaining to design, structural, electrical, plumbing and safety barrier aspects of swimming pools, hot tubs and spas. The Lower Allen Township



Community and Economic Development Department (CED) staff enforces these regulations through the plan review, permit and inspection process. Here are some essential UCC requirements:

- The UCC applies to any structure intended for swimming or bathing that contains water over 24" deep, including pools that are in, on or above-ground, hot tubs and spas. Portable and permanent installations are regulated.
- Providing and maintaining an adequate barrier is essential to restrict pool access, which minimizes the chance of accidental drownings. Many drowning victims are residents or guests of the household where the pool is located, so a barrier or door alarms are also required between the home and the pool.
- Many hot tubs and spas are sold with cover assemblies that provide the required safety barrier. Otherwise, a barrier of at least 4' high must be provided for all types of pools. Self-closing and self-latching gates must swing outward. Latch locations and fence openings are regulated to make it difficult for small children to open gates, or to climb through or over safety barriers.
- The side walls of above-ground pools do not meet this barrier requirement if they are less than 4' high, or if pool access is provided by an adjacent elevated deck. Please remember to remove ladders or lock them in the upright position when an above-ground pool is not in use.
- Code compliance for portable pools, hot tubs and spas can be as simple as assuring that the required barrier is provided, the water supply is protected from back-flow (no protection can cause contamination of drinking water), and the electrical supply is equipped with a ground fault current interrupter (protects against electrocution).
- In-ground pools and permanent above ground pools must also meet other standards for bonding of
 metallic parts (electrical safety) and plumbing requirements (to ensure proper sanitation by the filter
 system, and entrapment protection at suction outlets).
- Safety glazing is required for any glass areas near a pool, and there are restrictions on locations of electrical receptacles, fixtures and overhead power lines.

You can download a General Permit Application and a code compliance checklist for swimming pools on the Community Development Department page at www.latwp.org. The form and checklist also cover zoning regulations that apply to swimming pools, such as percentage of lot coverage, setback distance from side and rear lot lines, and location outside of flood hazard areas.


Sump Pumps Cause Big Sewer Problems!

Sump pumps connected to the sanitary sewer are illegal and cause big problems! Sump pumps are designed to pump groundwater and rain water. Sanitary sewer pipes are designed to carry sewage, not groundwater and rain water.

An eight-inch sanitary sewer pipe in the street will have a flow capacity of about 300 gallons per minute. If more water tries to flow through the pipe in the street, the seweage will back up in the main line and start filling up the sewer lateral pipes serving homes.

A half-horse power sump pump illegally connected to a sewer lateral will pump about 60 gallons per minute to the sewer. If five sump pumps are connected to the sanitary sewer; it will be full and start backing up the sewer system.

Sump pumps should be discharged to the yard or stormwater system not the sanitary sewer system.



Allendale Entrance Mall Upgrade Completed

Lower Allen Township has several well-known developments that have been in existence for many years. These developments add to the rich Lower Allen history.



One such development is Allendale which was started in the 1950's and is known for its landmark entrance. Although the infrastructure (electric, water) received needed upgrades, the overall entrance appearance became dated. The entrance wall was replaced in the recent past due to ongoing maintenance issues, but residents discussed a more comprehensive update. The existing trees were nearing the end of their lives and reducing overall long-term care/maintenance were key considerations. Creating an eco-friendly environment for pollinators was another interest. After much discussion, it was decided to formally explore options. Residents initiated a multi-year, self-funded effort for a more complete Allendale entrance update through their Association.

After reviewing several proposals, PA Landscape Group was selected as the landscaping partner. They helped guide the effort with design options and plant selections to achieve the desired outcome.

This two-year effort was completed late last Spring (2017). It is the result of great teamwork between neighbors. We hope everyone visiting Allendale enjoys the updated look of our welcoming, well-lit entrance. Allendale residents are proud of where we live, and work hard to keep our development attractive.

2018 CONSTRUCTION PROJECTS

Projects Planned for 2018 Construction Season

These are some of the more significant projects planned in Lower Allen Township during the 2018 construction season:

Township Projects

LACP Paving – pavement recycling and resurfacing of drives and some parking areas in Lower Allen Community Park.

Street Paving

Pavement recycling and resurfacing on Cedar Cliff Drive and Green Lane Drive

Pavement resurfacing on West Shore Drive, Westport Drive, a portion of Capital View Drive, and a portion of Beacon Hill Boulevard.

LACP Barn HVAC Upgrade – replacement of heating, ventilation and air conditioning equipment in the rental areas of The Barn at Lower Allen Community Park.

Gettysburg Road Relocation – Construction of a new roadway connection, from the Gettysburg Road/Audubon Road intersection to the Wesley Drive/Century Drive intersection. Construction is scheduled to start later in 2018, with completion in 2019.

Township Authority Projects

Fair Oaks – construction of sanitary sewer lines in the Fair Oaks neighborhood, including Colonial Drive, Kylock Road and Woodbox Lane.

Seneca Avenue – replacement of a portion of the sanitary sewer main in the 4000 block of Seneca Avenue

PennDOT Projects

Spanglers Mill Road Bridge – replacement of the bridge carrying Spanglers Mill Road (SR 2031) over the Yellow Breeches Creek.

Lisburn Road Bridge – replacement of the bridge carrying Lisburn Road (SR 2017) over the Yellow Breeches Creek.

Other Projects

Lisburn Road Roundabouts – construction of two single-lane roundabouts, at the intersections of Lisburn Road/Rossmoyne Road and Lisburn Road/Arcona Road.

Costs

- Often, the sidewalk repairs can feel like an unplanned expense. The Township does not wish to create undue hardship, but the Township is tasked with promoting safe conditions.
- If done properly and the underlying cause of the sidewalk deterioration is handled, then the sidewalk can last an average of 30 years.
- If you are concerned about an unplanned expense, review your own sidewalk conditions or call Engineering Technician Ray Allen (717) 975-7575 and ask him to inspect it, and then you can budget for the project in advance. There is no need to wait until the Township sends a letter.

Targeted Areas

Each Spring Lower Allen Codes Enforcement staff inspect sidewalk conditions in specific neighborhoods. The targeted neighborhood is often one about which staff has received complaints regarding sidewalk conditions. This spring Lower Allen will be inspecting the western portion of Highland Park, the area between 18th Street and Lowther Road.

Staff also responds to complaints about sidewalks anywhere in the Township and has the authority from the Code to request repairs to any unsafe sidewalk condition. If you see staff inspecting or marking the sidewalk, please be courteous. Their job is to keep the Township safe. They will be happy to answer any questions you may have.

In the year 2019 staff plans to focus on the eastern portion of Highland Park. In recent years, the Allendale and Rossmoyne neighborhoods have been reviewed for sidewalk safety.

Comprehensive Plan 2018

Lower Allen Township Commissioners adopted the updated Comprehensive Plan on February 26, 2018 at a Public meeting. The adoption was the final step in the year-long planning process. The main goals of the plan include:

- 1. Enhance the Township's existing residential neighborhoods and community parks
- 2. Promote a balance of open space preservation and the development and redevelopment of commercial and industrial areas
- 3. Expand pedestrian and bicycle connections throughout the Township
- 4. Improve and maintain the Township's existing transportation infrastructure

The goals were determined through a public engagement process which consisted of:

- A Citizen Advisory Committee which vetted the goals and was an advocate for the plan
- An online survey which received 650 responses
- Stakeholder and focus group meetings with Township staff, relevant agencies, and businesses
- Visioning Week which consisted of six public meetings held in various locations throughout the Township

Each goal consists of an action plan that identifies the party responsible for the implementation of that action item. Furthermore, the Township has been broken into four sections to highlight the goals in different areas of the Township. The four areas are named for the major roadways located in them:

- -Wesley Drive/Gettysburg Road Study Area
- -US 15/Central Study Area
- -Carlisle Road/I-83 Study Area
- -Lisburn Road Study Area

By breaking the Township into study areas, residents can easily locate the section of the Comprehensive Plan that is most relevant to them. The full Comprehensive Plan and the Executive Summary can be found on the Lower Allen Township Webpage under the Community Development tab. The 2018 Ambulance Subscription Renewals were mailed out in December. Ambulance Subscriptions are good for the calendar year of 2018. The Board of Commissioners set the Subscription rates for 2018 at \$70 for a Single Subscription and \$85 for a Household Subscription. If you did not receive a subscription form, or if you have any questions please contact Bev Putric at 975-7575, ext. 1205.

Why have a subscription? The cost of a trip in an ambulance is very high and insurance generally does not pay the full bill. By becoming a subscriber, if you call 911, are transported to a hospital and the transport is deemed medically necessary, Lower Allen EMS will accept the insurance company payment as payment in full for your first trip. Subscriptions do *not* cover routine transportation, transportation for stretcher or wheelchair, or transportation that is not medically necessary. You are responsible for additional mileage costs if you are transported past the closest appropriate facility.

Lower Allen Township announces a NEW 'Community Notification System'

In April 2017, we retired the old system used to make community notifications for emergencies as well as general notifications of Township activities. The retired system was largely based upon

landline phone numbers contained in the "White Pages" database. As landlines continue to decrease and become less reliable for immediate notifications, it became essential to shift to a mobility based system that provided for a resident's self-determination of a variety of contact options.

With the new system, referred to as "LA ALERTS", you will be able to add the phone numbers (landline and cell phones), email addresses, and text numbers where you wish to be contacted for various notifications. You will also be able to select groups you wish to be included in for emergency and/or routine messaging.

Subscribing is easy! Simply go the Township web page at www.latwp.org and click on LA Alerts under the Police & Public Safety News link. Here you will be able to create an account and list the phone numbers and email addresses you wish to be included as contacts. You can also then choose the level of contact and join contact groups. If you have any difficulty you can also subscribe by calling us at 717-975-7575 Ext. 1602 and we will assist you in registering. You may also choose to complete the form at the bottom of this page and mail to Lower Allen Township, 2233 Gettysburg Road, Camp Hill, PA 17011, Attn: LA ALERTS (or use the drop box near the flag pole in our parking lot).

APRIL IS PENNSYLVANIA 811 SAFE DIGGING MONTH


April 2017 is recognized as "Pennsylvania 811 Safe Digging Month" across our Commonwealth, an initiative supported by Pennsylvania 811, a utility notification information center more commonly known as Pennsylvania One-Call. PA811 is celebrating its 45th year of continuous service to the Commonwealth of Pennsylvania.

This unique service provides an easy to use one-call notification about excavation projects which may endanger workers and jeopardize utility lines while promoting workplace and public safety, reducing underground utility damage and minimizing utility service interruptions while protecting the environment.

The Pennsylvania One-Call System began with only six utility companies in Western Pennsylvania and now serves more than 100,000 excavators and 3,600 critical underground infrastructure owners throughout the Commonwealth. The service annually receives more than 800,000 notification requests and transmits more than six (6) million notifications, providing protection to utility companies, their employees, customers, and the general public.

With economic development throughout Lower Allen Township and Pennsylvania growing, it is important to minimize the damage to underground utility lines, danger to workers, environmental pollution, and the loss of utility services. We encourage all residents, engineers, designers, excavators and homeowners to Dial 8-1-1 at least three business days in advance of an excavation project such as planting a tree, installing a mailbox post, building a deck or swimming pool or replacing a driveway.

EMPLOYEE PROFESSIONAL RECOGNITIONS

TOWNSHIP EMPLOYEES LEADING THE WAY

The Board of Commissioners has always encouraged training and participation in professional associations for Township employees. They understand the importance of ongoing education, and what that can mean to the governance of the Township in terms of knowledge, ideas, and technique.

The Board recently recognized several staff members for appointments/elections to important positions in various boards and associations:

Daniel Flint, Township Engineer and Public Works Director. Dan was elected President of the Capitol Branch of the American Public Works Association. The APWA is a not-for-profit professional association of public works agencies, private companies, and individuals dedicated to promoting professional excellence and public awareness through education, advocacy and the exchange of knowledge. BULK ITEMS · TRASH · YARD WASTE

BULK ITEM DISPOSAL

One bulk item per week can be picked up curbside by your trash hauler. For residents' convenience, four loads per household per calendar year, can be brought to the Public Works facility. **A \$25.00** fee will be assessed for households exceeding their 4 load limit. The business hours for dropping off items at Public Works is Monday – Friday between the hours of 7:00am – 3:00pm. For residents' convenience, the facility is open the second Saturday of the month 8:00am – 1:00pm, from April through November.

Bulk items - Household appliances, furniture, carpet and wooden items - (outdoor furniture, swings and landscaping timbers). Lawn mowers, will be accepted and must have the oil and gas and tires removed before disposal.

<u>Shingles, concrete, dirt, paint, tires, oil, fuel, glass, pressurized tanks, TV's and Computer Equipment WILL NOT be accepted.</u>

Please refer to the Cumberland County website, <u>www.ccpa.net</u> for recycling guidelines and disposal locations for electronics and hazardous materials.

Trash/Sewer Bill Payment Options

- Mail: Mail your payment with your remittance stub. If paying through your bank's online bill pay, please remember to include your sewer/trash account number on your check.
- **In Person**: Visit the Township building and pay by cash, check or credit card. If you don't have time to stop in, just swing your car around to our drop box located in the front of the building by the flag pole and drop your payment there. The mail is gathered from the box by 8am each weekday morning.
- **Credit Card**: Visit our website at www.latwp.org, call or stop in to pay by credit card. If paying on our website, enter GovPay in the search bar to find the link; there is a processing fee that applies to all credit card payments.
- **Automatic Payment**: An authorization form can be obtained on our website at www.latwp.org or by calling or visiting the Front desk at the Township building. By choosing this option, the Township will automatically deduct the quarterly bill from your account on time, every time. Just submit the signed authorization form along with a voided check and we will take care of the rest!

Curbside Yard Waste Collection

The Townships' yard waste recycling program will be starting in April and will be collected by your trash hauler on your regular trash day. Yard waste collection will proceed through the last week in November. Residents may bring their yard waste directly to the Public Works facility, located at 1400 St. Johns Road, Monday through Friday, between the hours of 7:00am – 3:00pm. The second Saturday drop off will be offered starting in April and ending in November. Lower Allen households are limited to four loads of brush (yard debris) brought to Public Works per calendar year. A \$25.00 fee will be assessed for households exceeding their 4 load limit.

Landscape Contractors working at properties in the Township may haul yard waste generated at those properties to the Public Works facility when accompanied by the resident, or with prior approval. A contractor's yard waste permit is required to be purchased by contractors using the facility.

Yard waste consists of garden debris, leaves, sticks and branches and stumps (no larger than 14 inch diameter). <u>Grass clippings and sod are NOT considered yard waste</u> and should be bagged and put out with regular garbage, or composted.

Yellow yard waste bins should be used for smaller manageable amounts of debris. No trash bags or garbage may be mixed in with the yard waste. Branches must be bundled with twine or string, and not exceed 6 feet in length or 4 inches in diameter. Maximum weight is 45lbs. Yellow yard waste bins can be picked up at the Municipal Services Center during regular business hours. Unlimited amounts of yard debris may be placed curbside, using the previously stated guidelines.

Pet Waste and Stormwater

Pet waste is a health risk to pets, people, and especially children. Pet waste is full of bacteria that if not properly disposed of can end up in our streams, lakes, and rivers. The bacteria can ultimately end up in our fish and aquatic life. The pathogens in pet waste can lead to a high biological oxygen demand in our streams and rivers causing algal blooms which deplete oxygen from the water and deprive aquatic life making it difficult to survive.

What can you do?

- Pick up your pet waste and place in a plastic bag. Ensure the bag is tied shut and dispose of properly.
- Clean up pet waste from your yard and dispose of properly. Pet waste is **NOT** a fertilizer.
- Avoid walking your pet near streams and waterways.

We love our animals but we must take responsibility for the waste they generate. Be proactive in protecting our environment! Pick up after your pet and dispose of the waste properly to make a positive impact on water quality in Lower Allen Township.

Consultant Conducting Stormwater Fee Study

The Township has contracted with Arcadis U.S., Inc. to conduct a study of the feasibility and implementation of a stormwater fee. This is in response to financial burdens placed on municipalities by regulations from U.S. Environmental Protection Agency and the Pa. Department of Environmental Protection regarding stormwater discharges.

As the study progresses throughout 2018, residents and property owners are encouraged to check for updates on the Township website and Facebook page. New information will be posted there as it becomes available and will also be presented at one or more meetings of the Board of Commissioners.

LEAF COMPOST AND WOOD CHIPS

Leaf compost and wood chips are available to Township residents for delivery or for self-loaded pick up, at the Public Works facility. All leaf compost and wood chip deliveries will be made on Thursday and Friday mornings, April through early November.

Deliveries will be made only on a prepay bases. Payment must be made prior to setting up a delivery date. All payment are to be made at the Municipal Services Center. When your payment is processed, you will be contacted for a delivery date. Delivery forms can be found on the Township website or can be filled out at the time of payment.

QUARTERLY TAX TIPS

It's time to spring into action, if you haven't already...The 2018 Township and Cumberland County real estate taxes were dated March 1st and mailed. You might've noticed a significant increase in the township real estate and fire services tax. The township hasn't had an increase since 2013.

Due to constant reselling of mortgages and frequent homeowners refinancing, we mail all real estate taxes to the property owner. If your taxes are in an escrow account, we ask that you write your loan number on the tax bill and promptly forward one copy to your bank or mortgage company, so they can pay your real estate taxes during the discounted period.

2018 Dog Licenses are available in the Tax Office during regular hours. By law, dogs three (3) months and older must be licensed. We issue dog licenses for Cumberland County only. If you wish to purchase a life-time dog license John Gross, Treasurer at the Cumberland County Courthouse is the only person able to sell life-time dog licenses for Cumberland County residents.

Spring Bargains for Seniors...Property Tax Rebate – Rebates are offered to Pennsylvanians 65 and older who are homeowners and total income from all sources is less than \$35,000 (including ½ of your social security). If you are a senior 65 and older and are renting, your total income must be less than \$15,000 from all sources (including ½ of your social security). Funds for the tax rebates come from the Pennsylvania State Lottery. Forms are available in the Tax Office. If you desire assistance in completing the forms, please call me at (717) 737-5671.

TAX OFFICE HOURS: Monday, Tuesday and Thursday from 10 a.m. to 2 p.m. or by appointment

If you stop by the Tax Office during the days it is closed, feel free to drop your payments in the mailbox outside the tax office door or in the gray box located next to the flagpole. If you would like a paid receipt for your taxes, PLEASE include both copies of your tax bills and a self-addressed stamped envelope, so I can mail your receipt back to you.


