

# TOWNSHIP SERVICES UNDER THE COVID-19 EMERGENCY

The staff of Lower Allen Township began COVID-19 emergency preparations back in February, as news of the spread of the virus took center stage. We attended meetings held by public and health officials to learn as much as we could about the virus. A meeting was held with employees to instruct them on what to do to avoid exposure to the virus.



On March 13<sup>th</sup> we learned of a possible case of COVID-19 in Cumberland County, the County's first. That day the Commissioners and staff made

the decision to close the municipal buildings to the public and cancel all public meetings for a period of 30 days. Employees still reported for work but had no contact with the public. On March 17<sup>th</sup>, the Commissioners declared a disaster emergency so that certain emergency purchasing procedures could be implemented and the Township would be eligible for disaster funds. They also adopted procedures to implement the recently enacted Families First Coronavirus Recovery Act to provide for employees who could be put on leave during the pandemic.

On March 27<sup>th</sup>, the decision was made to keep all non-essential personnel at home for the next week as the situation was monitored. Those who had the ability to work from home were asked to do so. The administrative and Community Development departments took home laptops and learned to use the Teams app to conduct business and keep in contact with each other. Public Works was asked to stay home but was on call to respond to emergency situations. Of course, our dedicated Public Safety personnel – Police, Public Safety Officers, and EMS – were considered essential and stayed on the job 24-7 during the crisis. On March 30<sup>th</sup>, Cumberland County was added to the Governor's "Stay at home" order, so non-essential personnel were ordered to stay home until further notice.

Staff learned new ways to do things. In addition to teleworking, public meetings were moved to the popular Zoom platform. Staff prepared well, and the meetings went off without a hitch. Those meetings were recorded and are available on the Township's YouTube channel. Guidelines were developed so that neighborhoods could bring in food trucks with a reasonable assurance of safety.

The biggest impact to the Township will be in loss of revenue. The mass unemployment and commercial closures mean that certain revenues such as earned income tax, local services tax, building permit fees, real estate transfer taxes and facility rentals, to name a few, would evaporate or be severely reduced. Thanks to the Township's healthy fund balance, there was no need to furlough any employees, but the decision was made to freeze hiring for the remainder of the year. Staff is also looking at other areas of the budget to see what projects can be postponed or cut in order to offset the revenue losses brought about by the statewide shutdown.

We are glad to be in the Green phase of recovery, as full Township operations have resumed, including the opening of all parks, playgrounds, and recreational facilities. We are not out of the woods yet, and the Commissioners and staff encourage everyone to continue practicing social distancing and masking when appropriate.

#### **OUTDOOR FIRE SAFETY · UTILITY PAYMENT OPTIONS**

#### **Outdoor fire safety**

- Move the grill away from siding, decking, and other things that can catch fire.
- Stay with the grill the entire time you're cooking.
- Use long-handled barbecue tools when cooking on the grill.
- Use a metal screen over wood-burning fires to keep sparks from floating out.
- Turn off or put out fires before you leave the backyard.
- Build campfires at least 15 feet away from tent walls, shrubs or other things that burn.
- The best way to stay safe from fireworks is to not use them.



#### **Trash/Sewer/Stormwater Bill Payment Options**

- Mail: Mail your payment with your remittance stub. If paying through your bank's online bill pay, please remember to include your sewer/trash account number on your check.
- **In Person**: Visit the Township building and pay by cash, check or credit card. If you don't have time to stop in, just swing your car around to our drop box located in the front of the building by the flag pole and drop your payment there. The mail is gathered from the box by 8am each weekday morning.
- **Credit Card**: Visit our website at <a href="www.latwp.org">www.latwp.org</a>, call or stop in to pay by credit card. If paying on our website, enter GovPay in the search bar to find the link; there is a processing fee that applies to all credit card payments.
- **Automatic Payment**: An authorization form can be obtained on our website at <a href="www.latwp.org">www.latwp.org</a> or by calling or visiting the Front desk at the Township building. By choosing this option, the Township will automatically deduct the quarterly bill from your account on time, every time. Just submit the signed authorization form along with a voided check and we will take care of the rest!

# open Burning: What's allowed in the Township?

With summer here, we are getting numerous calls regarding open burning in the Township.

Statewide recycling in Pennsylvania began in 1988 with the "Municipal Waste Planning Recycling and Waste Reduction Act" or "Act 101". This act requires all larger municipalities to recycle. Consequently, leaves and yard waste cannot be burned. The Pa Solid Waste Management Act requires disposal of construction and demolition waste at approved landfill sites, so these materials also cannot be burned.

#### <u>Listed below are the regulations for open burning within the Township.</u>

The International Fire Code, as adopted and amended, allows for open burning when compliant with the following conditions.

2009 Edition International Fire Code Section 307—Open Burning, Recreational Fires and Portable Outdoor Fire Places:

- Open burning that is offensive or objectionable because of smoke emissions or when atmospheric conditions make such fire hazardous shall be prohibited.
- An operational permit shall be obtained prior to starting a silvicultural, range or wildlife management fire, fires to prevent or control disease or pests, or a bonfire.
- The Code Official, Community Service Officer, Public Safety Officer, Police Officer or Fire Official shall be authorized to require the extinguishment of any fire that is considered offensive, objectionable or unsafe.
- Recreational fires shall not be conducted within 25 feet of a structure or combustible material. Conditions which could cause a fire to spread within 25 feet of a structure shall be eliminated prior to ignition.
- Portable outdoor fireplaces shall be used in accordance with the manufacturer's instructions and shall not be operated within 15 feet of a structure or combustible material.
- All open burning, recreational fires, bonfires and portable outdoor fireplaces shall be constantly attended until the fire is extinguished.
- A minimum of one portable 4-A rated fire extinguisher or other approved fire extinguishing source shall be available for immediate utilization.

Please contact the Community Development Department to discuss any other open burning questions you might have.



#### **Ambulance Subscription Renewals**

The 2020 Ambulance Subscription Renewals were mailed out in December. Ambulance Subscriptions are good for the calendar year of 2020. The Board of Commissioners set the Subscription rates for 2020 at \$75 for a Single Subscription and \$95 for a Household Subscription. If you did not receive a subscription form, or if you have any questions please contact Bev Putric at 975-7575, ext. 1205.

Why have a subscription? The cost of a trip in an ambulance is very high and insurance generally does not pay the full bill. By becoming a subscriber, if you call 911, are transported to a hospital, and the transport is deemed medically necessary, Lower Allen EMS will accept the insurance company payment as payment in full for your first trip. Subscriptions **do not** cover routine transportation, transportation for stretcher or wheelchair, or transportation that is not medically necessary. You are responsible for additional mileage costs if you are transported past the closest appropriate facility.

#### **MS4 UPDATES**

#### Stormwater Pollution Prevention

**Automotive Maintenance** – Oil, grease anti-freeze and other toxic automotive liquids often make their way into the storm drain system and are not treated prior to reaching the Yellow Breeches Watershed. This contaminates waterways, making them unsafe for people and wildlife. Follow these best management practices below to prevent pollution and protect public health.

#### Cleaning Auto Parts

Scrape parts with a wire brush rather than liquid cleaners. Do not wash parts or equipment in a sink, parking lot or driveway.

#### Cleaning Spills

Use dry methods for spill cleanup such as sweeping and absorbent materials. Sweep spill material into an appropriate receptacle and dispose of properly.

#### Storing Hazardous Waste

Keep your liquid waste separated. Many fluids can be recycled via hazardous waste disposal companies if they are not mixed. Store all materials under cover with spill containment or inside to prevent stormwater runoff.

#### Proper Disposal of Hazardous Waste

Dispose of used motor oil and oil filters, anti-freeze, and other hazardous automotive fluids properly. Cumberland County has a hazardous waste disposal program. More information is available at: https://www.ccpa.net/3499/2020-HHW-Disposal-Program

#### Preventing Leaks and Spills

Place drip pans underneath vehicles to capture fluids. Use absorbent cleaning agents instead of water to clean work areas.



#### **Black Fly**

#### TOWNSHIP SERVICES VISIONING COMMITTEE FORMING

Like so many businesses, the COVID-19 shutdown effected the delivery of Township services. The massive unemployment during the shutdown will mean severe reductions in certain revenue collections, including earned income tax, local services tax, building permit fees and real estate transfer taxes. #### LEAF COMPOST AND WOOD MULCH

Public Works has begun to deliver product and will continue delivering on Thursday and Friday mornings, through the first week in November. Order forms and payment must be submitted at the Township's Municipal Services Center, prior to delivery scheduling.

Lower Allen residents are welcome to come and self-load wood mulch, free of charge, during business hours, Monday – Friday, between the hours of 7:00am – 3:00pm.

#### **Wood Mulch delivered**

3 cubic yards (small load) – \$5.00 8 cubic yards (large load) – \$10.00

#### **BULK ITEM DISPOSAL**

One bulk item per week can be picked up curbside by your trash hauler. For residents' convenience, four loads per household per calendar year can be brought to the Public Works facility. **A \$25.00 fee will be assessed for households exceeding their 4 load limit.** The business hours for dropping off items at Public Works is Monday – Friday between the hours of 7:00am – 3:00pm. For residents' convenience, the facility is open the second Saturday of the month 8:00am – 1:00pm, from April through November.

**Bulk items** - Household appliances, furniture, carpet and wooden items - (outdoor furniture, swings and landscaping timbers). Lawn mowers, will be accepted and must have the oil and gas and tires removed before disposal.

Shingles, concrete, dirt, paint, tires, oil, fuel, glass, pressurized tanks, TV's and Computer Equipment WILL NOT be accepted.

Please refer to the Cumberland County website, <u>www.copa.net</u> for recycling guidelines and disposal locations for electronics and hazardous materials.

#### **CURBSIDE YARD WASTE PICK UP**

The Townships yard waste recycling program started in April and will be collected by your trash hauler on your regular trash day. Yard waste collection will proceed through the last week in November. Residents may bring their yard waste directly to the Public Works facility, located at 1400 St. Johns Road, Monday through Friday, between the hours of 7:00am – 3:00pm. The second Saturday drop off will be offered, starting in April and ending in November. Lower Allen households are limited to four loads of brush (yard debris) to Public Works, per calendar year. A \$25.00 fee will be assessed for households exceeding their 4 load limit.

*Landscape Contractors* working at properties in the Township may haul yard waste generated at those properties to the Public Works facility when accompanied by the resident, or with prior approval. A contractor's yard waste permit is required to be purchased by contractors using the facility.

**Yard waste** consists of garden debris, leaves, sticks and branches and stumps (no larger than 14 inch diameter). Grass clippings and sod are NOT considered yard waste and should be bagged and put out with regular garbage, or composted.

Yellow yard waste bins should be used for smaller manageable amounts of debris. No trash bags or garbage should be mixed in with the yard waste. Branches must be bundled with twine or string, and not exceed 6 feet in length or 4 inches in diameter. Maximum weight is 45lbs. Yellow yard waste bins can be picked up at the Municipal Services Center during regular business hours. Unlimited amounts of yard debris may be placed curbside, using the previously stated guidelines.

# LOOKING FOR VOLUNTEERS FOR A PARKS & RECREATION AD HOC COMMITTEE

The Township will be convening an Ad Hoc Committee to study and provide some future direction on parks and recreation in Lower Allen Township. We initially asked for committee volunteers in the Spring edition of *The Township News*, but the COVID-19 shutdown temporarily put the brakes on this initiative.

Parks and recreation are important to the quality of life in Lower Allen Township, and in a time of more competition for limited resources parks and recreation should not be forgotten. Current and future needs may not be the same as what was provided in previous years.

Residents who are interested in providing input into future parks and recreation resources are sought to sit on a committee being formed to study these resources. Meetings will be held on a monthly basis for about a six-month period beginning this Summer.

#### **TOWNSHIP EXTENDS REFUSE CONTRACT**

Lower Allen Township is currently served by Penn Waste for household refuse, recycling, and yard waste. Our first contract extension was set to expire on December 31, 2020. Per the original contract from 2015, we are allowed one more extension for up to three (3) years.

On April  $30^{th}$ , we received a proposal for a contract extension from Penn Waste for the period 1/1/21 to 12/31/23. Penn Waste offered the following rates:

2021 - \$60.63 per quarter

2022 - \$63.84 per quarter

2023 - \$67.02 per quarter

These rates represent increases of 22.3% in the first year, followed by increases of 5.3% and 5%, respectively. While nobody wants a fee increase, the first-year increase actually came in far below the 52% average increases received by other West Shore communities for FY 2020. Additionally, all terms in the current contract would remain the same, meaning that Penn Waste will continue unlimited pickup with no additional restrictions on household recycling.

Feeling it to be unlikely that we could do better seeking competitive bids, the Board of Commissioners at their May 11<sup>th</sup> Public Meeting approved a three-year extension of refuse & recycling service with Penn Waste, commencing 1/1/2021.

Tax Office Hours: Monday, Tuesday, and Thursday from 10 a.m. to 2 p.m. or by appointment. If you stop by the Tax Office during the days it is closed, feel free to drop your payment in the gray box located next to the flagpole or the black pedestal mailbox outside my office door. You may also mail your payment. If you would like a paid receipt for your taxes, PLEASE include both copies of your tax bill and a self-addressed stamped envelope, so I can mail your receipt back to you.

The Lower Allen Township tax office will remain closed until the Cumberland County is in at least the "Green Phase." I take the COVID-19 Pandemic very seriously, as I am taking care of my aging parents and my baby granddaughter and to ensure our community's well-being.

This is a decision no one wants to make, but our community's safety and health comes before any important choice we make. It only takes one person to infect staff or an entire area. Important Dates and Info to Add to Your Summer Calendar...

The last day to take advantage of the face period for your March 1<sup>st</sup>, Lower Allen Township and Cumberland County real estate tax bill has been extended until Saturday, October 31st. Please remember that a 10% penalty will automatically be added on November 1<sup>st</sup>, 2020.

School real estate tax bills for the fiscal year 2020-2021 will be dated July 1<sup>st</sup> and mailed to homeowners. If there is an escrow account, it is the homeowner's responsibility to mail one (1) copy to your mortgage company. Write your loan number on the tax bill and send it to the attention of the Tax Escrow Department, keeping one (1) copy for your records. YOU WILL NOTICE THERE IS NO LONGER A PER CAPITA TAX BILL.


You should have received a \$7,074 Homestead Exclusion on your July 1<sup>st</sup>, 2020 West Shore School District Real Estate tax bill, if you did not, perhaps you are a new homeowner or didn't apply for it, the next window to apply for the Homestead Exclusion is December 15, 2020 through March 1, 2021. You can obtain that form on Cumberland County's website, ccpa.net. If you take the \$7,074 Homestead Exclusion amount and multiply it by 12.32 mils it equals \$87.15. Your assessment on your house will go back to the original assessment before the Homestead Exclusion since that only applies to the West Shore School District real estate tax bill.
