Last of Lower Allen Commons Properties Sold

The Lower Allen Township Development Authority recently sold the last of six units in the commercial condominium known as Lower Allen Commons. Here's what's you'll find there: unit #1 is being developed; unit #2 is a Chick-Fil-a site under construction; and business underway at units #3 Trader Joe's, et. al; #4-SpringHill Suites; #5 Texas Roadhouse; and #6 Bonefish Grill. The Development Authority's mission was to redevelop the site after the Bon-Ton closed in 2019. The goal was to guide development to bring investment into the Township, not to become a long-term landlord. The Development Authority has slowly been disinvesting itself of the above units since early 2021. (CONTINUED on page 4)

(CONTINUED from front page) Last of Lower Allen Commons Properties Sold

The sale of a property is different than leasing a property. For example, Texas Roadhouse has a lease that says it can use the building and parking area as a restaurant for an established number of years. Whoever owns the property that Texas Roadhouse leases, must still honor the lease. So, to the public, it appears that no changes were made because the Texas Roadhouse was there before, is there now, and will continue to be there, but the Development Authority no longer owns the property where Texas Roadhouse is located. With the help of a broker, it negotiated a sale of the property to an investor. Funds from each sale were used to capitalize the construction cost of Unit-3 (Trader Joe's, Sports Clips, Apricot Lane, and The Good Feet) which the Development Authority constructed on their own.

The last piece was to sell Unit-3. That unit, because it has four (4) tenants which paid monthly lease payments, sold for the highest price because it brought in the most revenue through leases. The sale of Unit-3 provided enough revenue for the Development Authority to pay off its bank loan for the project and retain some funding for reinvestment into another Township property, though it currently does not have plans for a specific project.

The redevelopment project was successful in a number of ways: 1) it improved the tax base by not having a vacant commercial property; 2) it guided development towards something meaningful to the community; 3) it did not use taxpayer money for the project; 4) it spurred new development and investment in the community from other developers; and 5) it created a fund for reinvestment for the Development Authority.

*This project was recognized for Excellence in Local Government for Intergovernmental Cooperation between the Development Authority and the Lower Allen Township Board of Commissioners.


ACT 57 - TAX PENALTY EXCEPTIONS

Act 57 was signed into law on July 11th of this year. Act 57 amends the Pennsylvania Local Tax Collection Law and requires taxing authorities to waive additional charges for taxpayers who did not receive notice of real estate taxes when a property or mobile home transfer took place within the previous twelve (12) months.

Taxpayers who fail to receive a tax notice during their first year of occupancy may apply for a waiver from penalties and additional costs from the tax collector. The state Department of Community and Economic Development is required to make a standard waiver form available.

All municipalities that levy real estate taxes must adopt a resolution or ordinance directing their tax collector to implement its provisions. JOHN EBY RETIRES AFTER 37.5-YEARS OF SERVICE



John Eby, the Township's longstanding Building and Zoning Coordinator set his retirement for January 13th, 2023, after 37.5-years with the Township. John was first hired as Code Enforcement Officer I back in 1985 and has served the Township in numerous roles and capacities. He was the appointed Zoning Officer, the Sewage Enforcement Officer, the Building Code Official, the Deputy Local Emergency Management Coordinator, Assistant Township Secretary, Secretary of the Township Development Authority, liaison to the Yellow Breeches Watershed Association, and Chair of the Cumberland County Blighted Property Reinvestment Board.

Unofficially he was the Township's historian. John's attention to detail helped him remember outcomes of hearings, reasons for development patterns, the evolution of a policy, and the location of a file in archives untouched for decades. No matter the question John was the man with the answer.

He brought professionalism to each of his roles and made it a point to stay abreast of trends in his field. John's professional association service includes numerous terms as a director, officer, and committee chair for the Pennsylvania Building Officials Conference (PENNBOC) state and regional chapters and the Pennsylvania Asso-

ciation of Building Code Officials, and many years as a PA delegate to the International Code Council (ICC) Mid-Atlantic Region, including chair in 2021. PENNBOC recognized John as the Building Official of the Year in 2001 and presented him with its inaugural John Eby Excellence in Leadership Award in 2022. He has been instrumental in crafting laws and regulations in Pennsylvania related to building safety and code implementation and has regularly participated in the ICC code development process.

The Lower Allen Township Board of Commissioners will recognize John at their first meeting in January with a resolution and plaque honoring his years of service and commitment to the Township.



NEW BRIDGES OPEN IN LOWER ALLEN TOWSHIP

After being closed for more than a year, the Slate Hill Rd. bridge opened for travel in August. The bridge, which crosses the Yellow Breeches Creek and connects Cumberland and York Counties, was closed in February 2021 after a safety inspection revealed compression fractures in the piers. The bridge, originally built in 1860, was completely rebuilt with modern techniques and materials, but in the same stone arch design as the original.

Also opened, on November 6th, was the new Creek Road bridge which passes over the Cedar Run near Eberly's Mill.

LOWER ALLEN TOWNSHIP EMS ANNUAL SUBSCRIPTION



In December the annual Lower Allen Township EMS Subscriptions were mailed to residents. The annual EMS subscription drive helps to cover the cost of delivering Emergency Medical Services.

Lower Allen Township EMS provides Basic Life Support, Intermediate and Advanced Life Support and responds to life-threatening emergencies such as heart attacks, trouble breathing, diabetics, allergic reactions, unconscious person, overdoses, falls and auto accidents. These emergencies always require Basic Life Support services and often require the services of Intermediate and Paramedic Advanced Life Support services. EMS is also the tip of the medical response spear for medical emergencies, traumatic injuries, pandemics, and disasters.

Lower Allen Township EMS faces continual challenges because of uncontrolled inflation affecting every aspect of health care including rising labor cost associated with inflation and a severe EMS workforce shortage. These challenges are further compounded by the insurance industry refusing to pay EMS for the services they provide. State and Federal government programs pay far less than the cost of providing EMS services. In 2022, Lower Allen Township EMS met the challenge of increased call volume and reduced availability of EMS resources, and continues to selflessly serve as the medical safety net for the citizens of Lower Allen Township.

EMS subscriptions help to provide the highest quality of basic, intermediate, and advanced life support. The annual subscription cost is \$80.00 for an individual and \$100.00 for a household. EMS subscriptions cover 100% of the co-pay or co-insurance for the <u>first</u> ambulance transport within the calendar year. EMS subscriptions do not cover routine transports, wheelchair van transports, or mileage beyond the closest appropriate facility.

WINTER TRASH REMINDERS



Winter Trash Reminders for Residents

As the temperatures start to fall and the precipitation begins to accumulate, it is helpful to assist the trash collection workers to ease the collection process.

- * Cover all trash and recycling bins with lids. Accumulation of water inside the trash or recycling bin will add weight, just like those extra cookies over the holidays!
- * Should water accumulate in your trash bins, please empty it onto the grass. Trash cans could have loose trash at the bottoms which often enters into storm drains if emptied onto a sidewalk or street.
- * If snow should be in the forecast this winter, please clear it from your pickup location. Although we all want to walk in a winter wonderland, trash cans and recycling bins that are buried in snow will be difficult to empty and can cause a hazard during collection.
- * Be safe when placing your bins out for collection. Ice and snow can be treacherous when trying to maneuver a large trash container or an armful of recycling.

As always, your safety and the safety of the collection crew is the most important. If the weather is treacherous, wait until the next week to put out your trash containers. Christmas Tree Collection 2023

The Township will be picking up Christmas trees from January 3rd through the 14th on your regular trash collection day. Please make sure you remove all ornaments, garland and lights. No bagged trees will be picked up.



BULK ITEM DISPOSAL

One bulk item per week can be picked up curbside by your trash hauler. For residents' convenience, four loads per household per calendar year can be brought to the Public Works facility. The business hours for dropping off items at Public Works is Monday – Friday between the hours of 7:00am – 3:00pm. For residents' convenience, the facility is open the second Saturday of the month 8:00am – 1:00pm, from April through November.

Bulk items - Household appliances, furniture, carpet and wooden items - (outdoor furniture, swings and landscaping timbers). Lawn mowers, snow blowers and trimmers (with all fluids removed) will also be accepted. A \$25.00 fee will be assessed for households exceeding their 4 load limit.

Shingles, concrete, dirt, paint, tires, oil, fuel, glass, pressurized tanks, TV's and Computer Equipment WILL NOT be accepted.

Observed holidays are noted in RED. Collection days that fall on or after the holiday will be delayed one day. EXCEPTION: If holiday falls on a Saturday or Sunday, there is no change in service prior to or after the holiday.

BASIC RESIDENTIAL GUIDELINES

- . Trash, Recycling, and one bulk item must be curb side by 7:00 AM on your scheduled collection day.
- Yard Waste must not exceed 6 feet in length, 4 inches in diameter and must be bundled or placed in a Township-provided container.
- Yard Waste will be collected on the same day as trash and recycling beginning in April and continuing through November. (See Calendar Above)
- · Call Penn Waste to schedule collection of appliances containing freon (air conditioners, refrigerators, freezers, etc.)
- · No construction debris will be collected curb side.

2023 Commercial Recycling Challenge



Local businesses, did you know that your recycling efforts can help Lower Allen Township? The amount of recycling that your business contributes to the recycling stream directly assists Lower Allen Township with the yearly state recycling grant information. Here is your challenge for 2023, pick one of the following suggestions to improve or increase your recycling efforts at your business.



- Identify that your waste is being sorted. Are all your employees recycling eligible items? Is a recycling dumpster available at your location? Do your employees know what can be recycled?
- Choose one item to focus on recycling this year, cardboard for example, and have a designated location for all employees to place cardboard boxes that need to be recycled.
- Give an employee the responsibility to breakdown all carboard boxes and to ensure they are recycled. Choose a reliable and dedicated employee, maybe they are the most excited about recycling.
- Is paper consumption high in your business? Focus on reducing your paper consumption by setting printers to double-side printing or encourage the use of recycled paper whenever possible.

Wood chips

Wood chips are available to Township residents year round for self-loaded pick up at the Public Works facility. Wood chip deliveries can be made for a nominal fee Thursday and Friday mornings, starting in April, 2023.

CURBSIDE YARD WASTE PICK UP

The Township's yard waste recycling program will start in April 2023 and will be collected by your trash hauler on your regular trash day. Yard waste collection will begin in April and run through the last week in November. Residents may bring their yard waste directly to the Public Works facility, located at 1400 St. Johns Road, Monday through Friday, between the hours of 7:00am – 3:00pm. The second Saturday drop off will start in April and end in November. Lower Allen Township households are limited to four (4) loads of brush (yard debris) brought to Public Works, per calendar year. A \$25.00 fee will be assessed for households exceeding their 4-load limit.



Yard waste consists of garden debris, leaves, sticks, branches and stumps (no larger than 14 inches in diameter). Grass clippings and sod are NOT considered yard waste and should be bagged and put out with regular garbage, or composted. Branches must be bundled with twine or string, and not exceed 6 feet in length or 4 inches in diameter. Maximum weight is 45lbs.

Yellow yard waste bins should be used for smaller manageable amounts of debris. No trash bags or garbage should be mixed in with the yard waste. Yellow yard waste bins can be picked up at the Municipal Services Center during regular business hours. Unlimited amounts of yard debris may be placed curbside, using the previously stated guidelines.

Yellow Yard Waste Recycling Containers are available at the Municipal Services Center, 2233 Gettysburg Road, Camp Hill, PA 17011 Between the hours of 8 am and 4 pm, Monday-Friday.

Limit one per residence. Additional or replacement containers available for a \$13 fee.

Winter Ice Maintenance

Pennsylvania waterways do not take a break from collecting runoff during the winter season. Runoff from driveways and sidewalks contain increased sodium from the ice melt that is used to create safe travels. The increase in sodium in the runoff ends up in Pennsylvania waterways. Salt is the biggest pollutant of waterways during the winter months in the Chesapeake Bay Watershed.

Residents can use alternative measures to reduce the amount of salt used. Consider the following suggestions to reduce the use of salt. Some local municipalities are experimenting on alternative sources to pretreat roads before snow and ice events. What can you do as an alternative to excessive ice melt or Sodium Chloride use on your property?

Check the Temperature

When the temperature is lower than 15 degrees skip the salt. Salt works by lowering the freezing temperature so ice crystals cannot form. Traditional salt will only work when temperatures are above 15 degrees. Consider alternatives such as Calcium Chloride or even sand for traction on sidewalks and driveways.

Sweep It Up!

After a snow or ice event, sweep up leftover ice melt granules to eliminate the possibility of salt being washed into stormwater drains. Just a teaspoon of salt in 5 gallons of water can alter an ecosystem and cause harm to fish and other aquatic plants and animals.

Slow Down & Use Less

When winter travel is necessary slow down. Reducing your speed on wet or icy roads can lessen the likelihood of an accident. One pound of de-icer is all that is needed to clear a 20-foot driveway or 10 squares on a sidewalk or 250 square feet. That is the equivalent to one heaping coffee mug!

QUARTERLY TAX TIPS

"Professional, Yet Personal...That's My Bottom Line"

Winter greetings from Bonnie Miller, Tax Collector. I hope this finds you safe and healthy and full of the Christmas spirit. Sorry to have to bring this up, but if you are delinquent on your 2022 Lower Allen Township/Cumberland County and/or West Shore School District real estate taxes you will be contacted by Cumberland County Tax Claim mid-February. They automatically add \$15 to the tax bill and add interest February 1st along with affecting your credit and a lien goes on your property with your mortgage company. If you receive a delinquency notice and you believe it was an error, please research with either a stamped paid receipt or cancelled check and provide to me and I will research it in the tax office with my records.

You should have received a \$8,557 Homestead Exclusion on your July 1st, 2022 West Shore School District Real Estate tax bill, if you did not, perhaps you are a new homeowner or didn't apply for it, the next window to apply for the Homestead Exclusion is December 15, 2022 through March 1, 2023. You can obtain that form on Cumberland County's website, www.ccpa.net. If you take the \$8,557 Homestead Exclusion amount and multiply it by 13.0569 mils it equals \$111.728. Your assessment on your house will go back to the original assessment before the Homestead Exclusion on your 2023 Lower Allen Township County/Cumberland County tax bill since that only applies to the West Shore School District real estate tax bill and not your Lower Allen Township/Cumberland County tax bill.

2023 Lower Allen Township and Cumberland County Real Estate taxes dated March 1, 2023 will be mailed on March 1st.

If you need paid receipts (\$1 per copy) for your rebate and/or tax return please send a self-addressed stamped envelope with a note requesting it and a check for the number of copies and I will return the receipts to you via mail or email. Residential \$83.00 per quarter

Non-residential \$83.00 per quarter base fee



A smart way to shovel your drive

How to reduce the possibility of getting a huge pile of snow in your driveway opening when snowplows clear your street:



Tips for Weathering the Winter

- *Consider using non-toxic de-icing substances such as clean clay cat litter, sand, or fireplace/stove ash to prevent hazardous waste from chemicals. Chemical deicers can be hazardous to your pets, your trees and shrubs, and the environment. Antifreeze that leaks from car engines and chemical snow melters on driveways, roads, and runways can pollute surface waters and groundwater through the soil.
- *Winterize your vehicle by checking your air filter and fluid levels, checking tires for tread wear and proper inflation, and checking the condition of your windshield wipers. Ensuring your vehicle is ready for weather changes will reduce damage, which prevents waste from broken parts, and will keep you safe on the road.
- *If you have a wood-burning fireplace, save your ashes in a tin instead of throwing them away. Cold wood ashes can be mixed in your compost heap to create a valuable soil amendment that provides nutrients to your garden.
- *Close the recycling loop. Many articles of clothing, such as jackets, scarves, gloves, and boots, are now made from recycled materials. Most fleece products are made from recycled plastic soda bottles, and certain clothing and shoe manufacturers use recycled cotton scraps and rubber tires to make their products.
- *Winter storms often cause power outages. Prevent waste by keeping rechargeable batteries rather than disposable ones stored throughout your house with your flashlights. If you do use disposable batteries, prevent hazardous waste by buying batteries with low mercury content.
- *To make sure your heating system (boiler, furnace or heat pump) is operating at its most efficient level, it is a good idea to have a contractor perform a routine check-up and any necessary maintenance on the equipment before freezing weather drives up your energy bill.

WEATHER EMERGENCIES

Weather emergencies may be declared whenever there is a forecast or accumulation of 3 or more inches of snow or when conditions are dangerous. A Snow Emergency will be declared and announced in the media giving a time (not less than 6 hours) by which **ALL VEHICLES** must be moved off all the streets.

The Public Works Department's initial priority is keeping major arteries and feeder roads open. As the emergency subsides and crews become available, the plows will clear curb to curb and move into residential areas.

Vehicles left on the street during a weather emergency are subject to being ticketed and also towed and stored at the owner's expense. Please adhere to the above regulations so emergency personnel can focus on recovery and returning life to normal in the Township.

WINTER DEICING • WINTER PARKING

Winter Deicing

Winter deicing, or de-icing, is a common practice to manage ice and snow in cold climates by businesses and homeowners alike. Winter weather often leaves us dealing with snow and ice on our sidewalks and driveways. Currently the most common substances used for this are salts. However, the salts can be harmful for the environment; as they kill plants, ruin soils and are toxic to many species within stream ecosystems. Shoveling is the best form of snow and ice removal. The old standard of using sand for traction is good but must be used sparingly. The sand can clog storm drains, destroy habitat in streams through the increase in sedimentation in the waterways.

Homeowners do have some choices when it comes to the kinds of deicing <u>chemicals</u> but the important thing to remember is to choose carefully and use sparingly.

Removing Snow & Ice Responsibly

The increased use of salts for deicing over the last 50 years has this country currently using over ten million tons on the roadways annually. There are alternatives to using salts even for the homeowner. Deicers are designed to loosen the ice so that it is easier to shovel. All substance options should be used sparingly to minimize the damage to waterways and the environment.

- *Shoveling- Very effective but can be back breaking and is the least damaging to the overall environment.
- *Snow blower— Easier on the back. Best if used before any deicers are used so as not to throw the <u>chemical</u> onto plants.
- *Sand—best for traction. Use sand <u>sparingly</u> as it can clog storm drains and choke waterways. Be sure to sweep up excess to minimize the amount of sand that gets into storm drains and waterways.
- *Bird seed— another traction method and it is biodegradable, or even better, birds will enjoy eating it in the winter months!
- *Safe Paw™— Is not a salt but an amide/glycol mixture that is safe for the environment and is biodegradable.
- *Calcium chloride— works at very low temperatures, and you can use less. It is also easier on vegetation than regular Rock salt (sodium chloride). This is still a salt and can be toxic to waterways. Use Properly and SPARINGLY!
- *Liquid deicer chemicals—For areas that experience large occurrences of snow and ice, deicing chemicals are necessary. The liquid deicers works best when used BEFORE a storm hits, this is called Anti-icing. A thin layer of liquid deicer applied to sidewalks and driveways prevents the formation of ice. Timing is key to minimize the wash-off potential from rain. This method requires less product than granular forms of deicers which can be more economical.



Winter Parking

The Police Department would like to remind residents about parking regulations during the upcoming winter season. Beginning December 1 through March 31 along posted streets residents may only park their vehicles on one side of the street as indicated by the street signs. The side that is permitted for parking alternates on a monthly basis. Please be sure that you are parking on the correct side of the street. Your compliance with this Ordinance allows the Public Works Department to get into the developments to quickly clear a travel lane without weaving between vehicles parked on opposite sides of the street. SNOW AND ICE REMOVAL AFTER STORMS

Please remember that there is an Ordinance that is enforced for snow removal in Lower Allen Township:

- Sidewalks must be clear of ice and/or snow within 24 hours after the precipitation stops.
- Snow shall not be thrown into the roadways when clearing sidewalks and driveways,
- Snow may not be pushed into the yards of other residents and businesses when clearing driveways, sidewalks and parking lots.
