#### Department of Public Safety

The Department of Public Safety continues to move forward in our mission to provide for the safest community possible through service to our residents and visitors. We are looking forward to continuing implementing a variety of outstanding programs thanks to the budget approved by the Board for 2019.

Monday, June 3<sup>rd</sup> – Attended the FBI National Academy restrainer in Lancaster.

**Tuesday, June 4**<sup>th</sup> – Attended the FBI National Academy restrainer in the morning. In the afternoon attended the CD staff meeting, and in the evening participated in the Public Safety Ad Hoc Committee meeting at LA Fire Station 2.

**Wednesday, June 5**<sup>th</sup> – Attended the COBRA records management system project implementation meeting at Central Penn College. This project, through Cody Systems, brings together various police records management systems into a common sharing platform. The Cumberland County police departments and the Dauphin County police departments have come together to form a node on the system they are calling CAPE. That stands for Capital Area Police Exchange. It will allow disparate records systems to be shared for query by police officers through a secure web browser. This project supports officer investigative effectiveness and efficiency as well as officer safety.

**Thursday, June 6**<sup>th</sup> – In the morning attended the Commonwealth of Pennsylvania 911 Advisory Board meeting at PEMA. I serve as the representative from the PA Chiefs of Police to the Advisory Board. This is a natural offshoot since while I was at PEMA I supervised the 911 Office as one of the areas of my responsibility.

**Friday, June 7**<sup>th</sup> – Met with the Civil Service Commission in the morning where they authorized the hiring list for officers. After that, drafted the Board Agenda item for hiring two new officers July 1<sup>st</sup> from the list approved by Civil Service.

Attended a lunch meeting with Capt. Deaven and an EMS operations expert to discuss the LA EMS direction and strategic initiatives.

In the afternoon participated in a conference call with the project manager for the COBRA CAPE system. I serve as a member of the Executive Implementation Committee for CAPE as the Cumberland County Chief's representative.

**Monday, June 10**<sup>th</sup> – Completed time sheet approvals and submission in the morning and then administrative reports in the afternoon.

In the late afternoon I also attended a CD plan review meeting with the Fire Company's conducted by Dan Flint and then the Board of Commissioners meeting in the evening.

**Tuesday, June 11**<sup>th</sup> – Attended the Department Head meeting in the morning and then a National Response Framework (NRF) webinar hosted by FEMA in the afternoon.

**Wednesday, June 12**<sup>th</sup> – Met with Justin Strawser, the new part-time Public Safety Planner, to discuss the future vision for the Township's emergency management program. Justin will be working on the updates to the Emergency Operations Plan as well as various training exercises.

**Thursday, June 13**<sup>th</sup> – Traveled to Maryland with Lt Thomas and Charlie Reynolds to attend a Ford Motor company 'drive and learn' symposium for the new 2020 police cruiser packages. Of interest was the new Explorer police package hybrid being released in 2020. The data on the new hybrid as well as the driving experience suggested we should seriously consider these as an option for our 2020 police SUV replacements. Their performance meets or exceeds the current gas only models.

**Friday, June 14**<sup>th</sup> – Conducted a public safety coordination meeting in the morning and met with Dr Modi, the new EMS Medical Director, in the afternoon.

**Monday, June 17**<sup>th</sup> – Attended the Cedar Cliff High School exercise planning meeting. This exercise and training education event will be conducted Saturday, August 3<sup>rd</sup> at Cedar Cliff High School. It will include all Lower Allen public safety disciplines as well as our mutual aid responders for the police, fire, and EMS disciplines. The goal is to train for the integrated response model which is what has emerged nationwide as the operational response model to mass casualty and care events following a hostile action event.

In the evening attended the Capital Region Council of Governments meeting at Hampden Township for a presentation on human trafficking.

**Tuesday, June 18**<sup>th</sup> – Met with Capt. Deaven and Life Team representatives to discuss the transition of ALS services. Then met at Cedar Cliff to prepare the library for the evening's Public Safety Ad Hoc Committee meeting.

In the evening participated in the Ad Hoc Committee meeting.

**Wednesday, June 19**<sup>th</sup> – Attended a meeting in the morning with the PUC and Norfolk Southern to discuss the railroad's dual crossing closure.

During lunch attended the employee picnic in the fire bays.

#### **DEPARTMENT HEAD:**

During the month of June, Captain Crone attended a Uniform Committee meeting, a Civil Service Commission meeting, BOC Meetings, Public Safety Ad Hoc meetings, Department Head meetings, a Roundabout preconstruction meeting, a Public Safety Coordination Meeting, and an exercise planning meeting. Captain Crone also presided over the monthly PPAC meeting, participated in a meeting regarding the Accreditation Status of the Attorney General's Office, several policy development discussion meetings, and various impromptu meetings.

Captain Crone attended range training, including qualifications missed during light-duty time earlier in the year. He also attended training sponsored by the FBI National Academy, along with Director Holl.

Patrol Officer of the Month honors go to Bryan Rennie. During the month, Ofc Rennie made seven criminal arrests (this included 2 Retail Thefts, 3 Disorderly Practices, and 1 Public Drunk). He also issued seven traffic citations and fourteen warnings.

Ofc. Rennie did an excellent job on a self-initiated incident on 6/5/19 where he observed a vehicle on Gettysburg Rd. being driven erratically. Ofc. Rennie ran the plate and identified the driver as being DUI suspended. He had pulled up beside the vehicle at a traffic light and was able to positively identify the driver when the PennDOT photo came back. When Ofc. Rennie attempted to stop the vehicle, the driver failed to stop, and a brief pursuit occurred. Since Ofc. Rennie had already run the plate and identified the driver, so he was able to terminate the pursuit after a few seconds. Ofc. Rennie received approval from the D.A.'s Office to charge the driver with two felonies, a misdemeanor, and a summary. A warrant was obtained for his arrest.

During the month of June 2019, LATPD made arrests or filed criminal charges on 36 individuals, issued 14 non-traffic citations, 120 traffic citations, 112 warnings, and 11 parking tickets.

Dr. Ruppen Modi was selected as the Medical Director. Dr. Modi is a great addition to the team. Dr. Modi's clinical approach aligns with the vison for the future of Lower Allen Township EMS and his expertise will enhance Lower Allen Township EMS to clinical excellence as we move forward.

Director Holl and Captain Deaven met with Chief Barry Albertson and Deputy Chief Joel Hocking from UPMC Pinnacle Community Life Team on multiple occasions to facilitate a seamless transition. An excellent relationship with UPMC Pinnacle Community Life Team exists and will continue in the future.

Multiple challenges were overcome to meet the July 1, 2019 deadline to start Advanced Life support Services. The Lower Allen Township EMS Team completed all preparations for the launch of Advanced Life Support Services in 45 days. ALS services usually require months of preparation to set-up and begin delivering Advanced Life Support Services. The entire Lower Allen Township EMS Team and Department of Public Safety contributed.

Beyond the implementation of Advanced Life Support Services, all aspects of the EMS Division are being evaluated with an emphasis on Safety, Teamwork and Integration within the Public Safety Department.

Multiple personnel attended a variety of training in June involving Active shooters, EMS innovations and Left Ventricular Assist Devices (LVAD). EMT Beishline continues to coordinate EMS continuing education. Additionally, she is continuing her summer safety series and has significantly increased the number of people being reached by Social Media. Positive feedback has been received regarding the increased social media presence.

Supervisors Hivner and Calman are continuing with their assigned task. Supervisor Hivner is assisting with the on boarding of new personnel.

Due to unforeseen circumstances, multiple schedule challenges occurred during June. All challenges have been met and all units remained staffed. Improved use of the scheduling program, communication and coordination with Captain Wirth decreased the impact to the PSO program while maintaining EMS staffing levels. There is considerable future work to be done in this area as we move into the future.

Data points are continually being refined to ensure the delivery of EMS services is provided at the highest level and meeting the expectations of our residents.


"Missed Calls" are high priority and in-depth analysis of the data to determine the leading causes will be completed by the end of the summer. The process of data collection has been enhanced with additional reports from Cumberland County Communications as well as improved use the ESO reporting features.

The Pennsylvania Department of Health released updated scope of practice for Emergency Medical Technicians, Advanced Emergency Medical Technicians and Paramedics. New protocols were released for Emergency Medical Technicians and Paramedics. The updated scope of practice will facilitate the implementation of Advanced EMTs (A-EMT). Providers with this certification can perform certain higher-level skills including IV administration and limited drug therapies under certain circumstances. State and regional protocols, and dispatch criteria, will need adjusted to make this level of certification an operational reality. An adjustment to the salary matrix would also be required if we were to implement this option. Currently Marie Calaman and Ashley Beishline are Advanced EMT's.






