The Department of Public Safety continues to move forward in our mission to provide for the safest community possible through service to our residents and visitors. We are looking forward to completing our implementation of some outstanding programs and services in 2018 and continuing our pursuit of excellence in 2019.

Below are the highlights of the Director's daily activities. Not included are the various functions and responsibilities that are managed every day administratively to coordinate the multiple public safety disciplines through our strategy of mutual consultation and collaboration. All these efforts are intended on making the Lower Allen Department of Public Safety exceptional in providing services to the community.

Thursday, January 3rd – Met with John Eby in the morning to complete the county Hazard Mitigation Plan survey for the Township. Cumberland County is currently working to update their hazard mitigation plan by meeting with the municipalities and soliciting information through surveys both public at large and municipal entries.

In the afternoon began drafting the Public Safety Ad Hoc Committee White Paper.

Friday, January 4th – Continued drafting the Public Safety Ad Hoc Committee White Paper and worked on developing the EMS Captain position adverting flyer.

Monday, January 7th – Completed time sheets in the morning and then attending the Alpine software development conference call. In the afternoon conducted a CrimeWatch Planning discussion and participated in the Police Supervisor's meeting.

Tuesday, January 8th – Reviewed the EMS County Mutual Aid Agreement in the morning and then drafted Board Agenda Items for the 2/24 meeting. In the afternoon attended the Cumberland County EMS Council meeting at the 911 Center and then the Police Communications meeting at the same location.

Wednesday, January 9th - Attended the Lisburn Tanker delivery in the morning and attended to administrative activities in the afternoon. In the evening attended the LA Fire Company monthly meeting.

Thursday, January 10th – Met with Life team Director Barry Albertson and his Operations Manager in the morning to discuss an Advanced Life Support transition strategy when we implement Lower Allen EMS Advanced Life Support. In the afternoon Capt. Wirth and I traveled to York Area regional United Fire Rescue to meet with their fire chief concerning their organization and operation. YARUFR is a combined fire service for Springettsbury and Spring garden Townships in York County organized through an Intergovernmental Agreement. It is one model to look at in the future as resources as volunteer staffing becomes critical.

Friday, January 11th – Continued drafting the public safety Ad Hoc Committee White Paper.

Monday, January 14th – Met with the Manager in the morning. Following that attended the Alpine software development meeting. In the afternoon worked on the 2019 projects spreadsheet for planning. In the evening attended the Board of Commissioners meeting.

Tuesday, January 15th – Attended the department head meeting in the morning and then worked on the iPad plan for implementing mobile reporting for EMS.

Wednesday, January 16th – Attended the Cumberland County Chiefs meeting in the morning and then a CrimeWatch meeting in the afternoon.

Thursday, January 17th – Attended the South-Central Task Force Exercise Working Group meeting at Lancaster County Public Safety Training Center in the morning. In the afternoon met with Roger Morrison from NDI Recognition Systems, Lt Thomas, and Sgt Foltz concerning a possible technology project.

Friday, January 18th – Worked on a Draft of the Public Safety Planner position flyer and then a final draft of the Ad Hoc Committee White Paper. In the afternoon joined a conference call on the COBRA RMS data-sharing project, a joint venture of the Cumberland County police departments and the Dauphin County Police Departments, supported by Dauphin County IT. Cumberland County removed themselves from the project.

Monday, January 21st - Attended the Alpine fire software implementation working group meeting and then headed to HIA to catch a flight to attend a Partnership for Priority Verified Alarm Response (PPVAR) Board meeting in Denver.

Tuesday, January 22nd – Attended the PPVAR Board meeting. PPVAR is working with the national alarm company associations to develop improved protocols and procedures for alarm company interfaces to 911 Centers to reduce false alarm calls through "verified alarms". This then triggers priority response by law enforcement.

Wednesday, January 23rd – Flight back to HIA.

Thursday, January 24th - Off

Friday, January 25th – Participated in a conference call with Alpine software project manager to develop an improved path forward in getting to a "Go Live" point with the fire software.

Saturday, January 26th – Attended the Cumberland County Department of Public Safety Symposium at the 911 Center. The purpose of this symposium is to provide awareness to our County First Responder Line Officers and Local Emergency Management Coordinators (EMC) on collaboration and integration with the County 9-1-1 Center and Emergency Management. Any/All First Responders are welcome to attend.

Monday, January 28th – Met with the Manager in the morning. Following that attended the Alpine software implementation meeting. In the afternoon met with Bill Fox concerning the purchase of the LifePak Monitors and Lucas CPR device from the 2019 budget. Worked on Human Resources follow-ups after that and in the evening attended the Board of Commissioners meeting.

Tuesday, January 29th – Attended the department head meeting in the morning and then conducted administrative follow-ups in the afternoon.

Looking forward to 2019

This will be a busy year for the Department of Public Safety and its various disciplines. The police department will be participating in the Cumberland County Chiefs of Police Testing Consortium this spring and then working with the Civil Service Commission to develop a new eligibility list. From that list, the department will be adding two additional officers to supplement and enhance patrol staffing response capabilities. The police department will also be implementing CRIMEWATCH to replace Crime Mapping.com.

EMS will be taking delivery of a replacement ambulance late spring, bring on board a new EMS Paramedic Captain to work with the Director in hiring paramedics, and implement a Lower Allen Township Advanced Life Support service for the community.

Police, LA Fire, Lisburn Fire, and EMS will be participating in the proposed Public Safety Ad Hoc Committee, if approved by the Board, to examine the Lower Allen Public Safety Services and develop recommendations to the Board for a 5-10 year plus strategic vision of public safety services for Lower Allen Township. This will greatly assist in long term budget planning and projections.

All public safety services will also be heavily committed to training all discipline staff in the South-Central Task Force provided training for the Active Attack Integrated response (AAIR) course. This course presents a response strategy directed at two primary components. First is to "Stop the Active Aggression" by an active intervention to neutralize any shooter(s) or any other active assault mechanism. Second, to "Stop the Dying" by rapid assessment, treatment, and evacuation for treatment and transport of injured persons assaulted in the aggression.





EMS continues ongoing efforts in improvements to organization and service delivery. EMS Supervisors Hiver and Calaman continue to coordinate EMS personnel and operational responsibilities under the Director's oversight.

EMT Beishline continues to develop and coordinate service training. She is also working on the implementation of mobile patient care reporting (PCRs) using iPad devices to access the ESO PCR software. This software is cloud based and funded through a region wide grant to the Emergency Health Services Federation (EHSF). We have been advised the current grant ends this summer and there is an ongoing negotiation by EHSF on how to continue funding.

We continue to integrate part-time providers into the schedule in order to provide a robust delivery of services and staff EMS vehicles to the maximum considering the days and times of service demands. Following the Board's action to increase the starting hourly rate for EMT-I part-time positions, a number of applicants have been trained and are now actively being scheduled to assist in delivering EMS services to the community. Additional interviews for part-time staff are pending in February.

The EMS Supervisors continue to meet with the Director on a monthly basis as we work toward a philosophy of continuous improvement for operations and overall EMS processes.

EMS staff met with the representative from Life Line ambulances to complete a final review of the specifications for the 2019 purchase of the replacement unit for 2-74. The Board approved the purchase of a Lifeline Ambulance in late December so that the chassis could be ordered by the vender and save on a pending year end price increase. That ambulance will be delivered in late May, early June, and be placed in service shortly thereafter.

We continue to examine the content and presentation of the EMS Monthly Report to the Board. Also, we continue to look at management monitoring documents that will assist in that process.

One of the areas we have been looking at is the numer of "missed calls" where our ALS or BLS is not available for service calls in the Township and outside EMS units are dispatched instead. This is usually due to one or more of our LA EMS units already being on a call for service. EMT Supervisor Calaman has been tracking those statistics for me. A copy of her report is attached as the last page of this report. As you can clearly see by the numbers, our EMS service missed 53 calls in the Township in January. 35 of them were ALS and 18 were BLS; mostly during the 7 a.m. to 7 p.m. time frame. At this point, it appears that this continues to be at least one call per day on the average, and at times 2 or more calls per day. Most of these calls were with BLS in service.

A more detailed analysis will be underway to see if those impacts could be mitigated by an additional unit staffing given the days and times of occurrence. One consideration is expanding the hours of coverage and providing a BLS unit overlap shift from 4 p.m. to midnight mainly during the Monday through Saturday time frame. Another option is to maintain two BLS units and run the ALS service in a "chase truck" environment with the Captain's vehicle. The issue often is the call is dispatched ALS with the MICU and upon arrival the patient can be managed BLS. At this point the medic is committed to the

call in the MICU despite the downgrade. Splitting the crews would allow for more versitility and flexibility. We will be examining these options during first quarter of 2019.


Another area we continue to explore is the addition of Advanced EMTs (A-EMT). Providers with this certification can perform certain higher level skills including IV administration and limited drug therapies under certain circumstances. State and regional protocols, and dispatch criteria, will need to be adjusted to make this level of certification an operational reality. An adjustment to the salary matrix would also be required if we were to implement this option. Currently Marie Calaman and Ashley Beishline are certified as Advanced EMT's.

EMS will also be transitioning to new uniforms hopefully in February 2019. They will be a more comfortable relaxed unitorm shirt but remain well marked as EMS providers fr4om Lower Allen EMS. We are also examining high visibility outwear for all staff so they are highly visible on and around the roadways when they have responded to calls for service.

In 2019 we will continue to be looking at the overall concept of EMS operations as we move forward with service deployment strategies for improved quality of care and fiscal efficiencies.

The following pages contain tables that provide an overall summary perspective of the monthly calls for EMS service. As is clearly evident, EMS continues to be very busy and steady on a daily basis.




