The Department of Public Safety continues to move forward in our mission to provide for the safest community possible through service to our residents and visitors. We are looking forward to completing our implementation of some outstanding programs and services in 2018 and continuing our pursuit of excellence in 2019.

Below are the highlights of the Director's daily activities. Not included are the various functions and responsibilities that are managed every day administratively to coordinate the multiple public safety disciplines through our strategy of mutual consultation and collaboration. All these efforts are intended on making the Lower Allen Department of Public Safety exceptional in providing services to the community.

Friday, February 1st - Met with Sgt Dave Miller of Carlisle PD and Gary LeGore (FBI Retired/Planning Specialist for the South-Central Task Force Criminal Justice Subcommittee to discuss and determine the Cumberland County police, fire, and EMS instructors for the Integrated Response Train the Trainer (TtT – AAIR)) program being held in April by the Task Force. This cadre of instructors will train the 8-county region's police, fire, and EMS providers in the concept and practical application of the Integrated Response to Active Aggressors framework. Captain Wirth and I will be among those instructors trained.

Also, in the morning, continued to finalize the draft of the Public Safety Ad Hoc Committee white paper. In the afternoon joined the weekly COBRA RMS sharing conference call where I participate with the steering group between Dauphin and Cumberland County as the representative from the Cumberland Co Chiefs of Police. **Sunday, February 3rd** – Attended the Hazmat Operations Refresher with members of the LA and Lisburn Fire Companies. This is an annual training required for firefighter members.

Monday, February 4th – Attended the PennTIME Quarterly meeting at the PA Turnpike Commission. This group is working toward operationalizing roadway safety for first responders and tow operators on the highway for traffic incidents and sponsoring the TIM training program.

In the afternoon, attended the Police Supervisors' meeting.

Tuesday, February 5th – Reviewed the Lifeline Ambulance Final Specification document for the 2019 ambulance on order and ready to begin the build at the factory.

In the afternoon, attended the Steering Committee meeting for the Cumberland County Hazard Mitigation Plan update with John Eby.

Wednesday, February 6th – Drafted Board Agenda items in the morning for the 2/11 meeting. In the afternoon attended the Cumberland County Commissioners Finance Committee meeting concerning CRIMEWATCH. Members of various Cumberland County police departments were also present to support the county purchasing CRIMEWATCH county-wide at a reduced rate.

Thursday, February 7th – DRAFTED the Public Safety Coordination Meeting Agenda for the 2/8 meeting and finalized Board Agenda Items for the 2/11 meeting.

In the afternoon finalized the PPT for the Ad Hoc Committee presentation to the Board. In the evening attended the Lisburn Fire Company meeting.

Friday, February 8th – Prepared for the Traffic Incident management class Capt. Wirth and I will be presenting to the Fire Companies.

Monday, February 11th – Met with the Manager in the morning and then attended the Alpine Fire/Inspection software implementation meeting.

In the afternoon drafted a letter to Cumberland Co 911 requesting to add an Engine to fire boxes 15, 581, and 83 for medical assists. Chief Murdoch requested these changes. These boxes include Rt 15, Rt 581, and I-83. This addition is to support increased safety for first responders on the four-lane roadways and is practiced elsewhere in the county on I-81 and other locations.

In the evening, attended the Board of Commissioners meeting.

Tuesday, February 12th - Met with Life Team Manager Barry Albertson to discuss ALS transition planning. Then, attended the Department Head meeting in the EOC.

In the afternoon drafted EMS Captain Interview Questions.

Wednesday, February 13th – Attended an SCTF AAIR meeting in Gorgas A in the morning and then the full Criminal Justice Subcommittee meeting later that morning in the EOC.

In the afternoon worked on the Public Safety Planner position advertisement.

In the evening, attended the LA Fire Company meeting.

Thursday, February 14th - Continued to draft interview questions for the EMS Captain position. In the afternoon, attended the Civil Service Commission Meeting for their review on the updated Civil Service Rules and their vote to approve Thereafter, continued with the EMS Captain interview question development.

Friday, February 15th – Worked on a draft for an EMS policy concerning refusals and required Patient Care Reporting.

In the afternoon finalized the Ad Hoc Committee PPT for the 2/25 Board meeting.

Monday, February 18th - HOLIDAY

Tuesday, April 19th – Attended the Alpine fire software implementation workgroup conference call with the group and vender.

Wednesday, February 20th – Worked on various administrative items including the Ad Hoc PPT, Dunbar and Kidd's probation satisfaction Agenda Items, and the January monthly report.

Thursday, February 21st – Completed the January Monthly report and attended the Cancer Presumption policy working group meeting. This is a working group of Lower Allen police, fire, and EMS

representatives to draft a unified policy that develops and implements prevention strategies for cancer in concert with the Presumption Act. The theory in developing the multi-discipline approach was to have a unified and consistent approach to the potential problem in practices, equipment, and training.

Friday, February 22nd – Attended the Director's meeting in the morning.

In the afternoon began drafting the Property Maintenance Program PPT for PSOs and CSOs assisting code enforcement.

Monday, February 25th – Attended meeting with the Manager in the morning. Then attended the Alpine software implementation group conference call late morning.

In the afternoon, joined a conference call on the HAAS Alert system with LA Fire Chief Murdoch. The HAAS program uses a device in emergency vehicles that alerts traffic management devices and Apps such as WAZE of an approaching emergency vehicle before they would see or hear the vehicle. It plots a GPS coordinate of that vehicle on the personal device while responding, thus allowing the vehicle operator to take advanced action to clear the roadway. This product was discussed at a recent TIM meeting at the Turnpike.

In the evening attended the Board of Commissioners meeting.

Tuesday, February 26th – Attended the Department Head Meeting in the morning. Then, continued drafting the Property Maintenance PPT in the afternoon.

Wednesday, February 27th – OUT of the OFFICE during the day.

Presented Part 1 of the Traffic Incident management Training program to LA and Lisburn Fire with Capt. Wirth in the EOC. Capt. Wirth and I are certified instructors for the program and will be conducting multiple 4-hour training sessions for public safety personnel over the spring/summer time frame.

Thursday, February 28th – In the afternoon conducted the EMS captain interviews.

DEPARTMENT HEAD:

During the month of February, Captain Crone presided over the monthly PA Police Accreditation Coalition meeting, attended the police supervisors' meeting, attended a Board of Commissioners meeting, department head meetings, a PLEAC Standards Committee meeting, and a police all-hands meeting.

Civil service regulations and amendments were consolidated and presented to the Civil Service Commission for review, revision, and approval. These were later approved by the board and Civil Service activated for the 2019 hiring cycle. Physical agility and written exams are to take place on 3/30 and 3/31.

Captain Crone and Sergeant Foltz attended training with PowerDMS to enhance skills as system administrators.

The monthly Coffee with a Cop event was held at Starbucks and was well received.

Wheels were set in motion for a stationary license plate reader trial. The agency was selected as a beta test site for the vendor and will be the first from that group in PA. Lt Thomas is leading the charge on this project.

Captain Crone attended both fire banquets and has participated as part of the Cancer Presumption/Prevention policy development group, initiated by LA Fire.

Captain Crone also participated in the EMS Captain selection process interviews.

The officer of the month for February was Officer Kimberly Floyd. In a field of very active nominees, Officer Floyd distinguished herself when she stopped to check on a vehicle pulled over on Rossmoyne Road. The subject she ended up speaking with was planning to jump from a bridge. She was able to talk him into seeking help and likely saved his life.

Officer of the Year honors for 2018 went to Officer Alex Milletics. He distinguished himself with more officer of the month awards than any other officer for the year.







EMS - FEBRUARY 2019

<u>SUMMARY – By Director Holl</u>

Department of Public Safety

EMS continues ongoing efforts in improvements to organization and service delivery. EMS Supervisors Hiver and Calaman continue to coordinate EMS personnel and operational responsibilities under the Director's oversight.

EMT Beishline continues to develop and coordinate service training. She is also working on the implementation of mobile patient care reporting (PCRs) using iPad devices to access the ESO PCR software. This software is cloud based and funded through a region wide grant to the Emergency Health Services Federation (EHSF). We have been advised the current grant ends this summer and there is an ongoing negotiation by EHSF on how to continue funding.

We continue to integrate part-time providers into the schedule in order to provide a robust delivery of services and staff EMS vehicles to the maximum considering the days and times of service demands. Following the Board's action to increase the starting hourly rate for EMT-I part-time positions, a number of applicants have been trained and are now actively being scheduled to assist in delivering EMS services to the community. Additional interviews for part-time staff are pending in February.

The EMS Supervisors continue to meet with the Director on a monthly basis as we work toward a philosophy of continuous improvement for operations and overall EMS processes.

Interviews were conducted this month for EMS Captain. Hopefully that psotion can be appointed by the Board in March of 2019 to begin the ALS Program implementation.

We continue to examine the content and presentation of the EMS Monthly Report to the Board. Also, we continue to look at management monitoring documents that will assist in that process.

One of the areas we have been looking at is the number of "missed calls" where our ALS or BLS is not available for service calls in the Township and outside EMS units are dispatched instead. This is usually due to one or more of our LA EMS units already being on a call for service. EMT Supervisor Calaman has been tracking those statistics for me. A copy of her report is attached as the last page of this report. As you can clearly see by the numbers, our EMS service missed 45 calls in the Township in February comparewd to 53 in January. 20 of them were ALS and 22 were BLS; again mostly during the 7 a.m. to 7 p.m. time frame. At this point, it appears that this continues to be at least one call per day on the average per day. Most of these calls were with BLS in service.

A more detailed analysis will be underway to see if those impacts could be mitigated by an additional unit staffing given the days and times of occurrence. One consideration is expanding the hours of coverage and providing a BLS unit overlap shift from 4 p.m. to midnight mainly during the Monday through Saturday time frame. Another option is to maintain two BLS units and run the ALS service in a "chase truck" environment with the Captain's vehicle. The issue often is the call is dispatched ALS with the MICU and upon arrival the patient can be managed BLS. At this point the medic is committed to the call in the MICU despite the downgrade. Splitting the crews would allow for more versitility and flexibility. We will be examining these options during first quarter of 2019.


Another area we continue to explore is the addition of Advanced EMTs (A-EMT). Providers with this certification can perform certain higher level skills including IV administration and limited drug therapies under certain circumstances. State and regional protocols, and dispatch criteria, will need to be adjusted to make this level of certification an operational reality. An adjustment to the salary matrix would also be required if we were to implement this option. Currently Marie Calaman and Ashley Beishline are certified as Advanced EMT's.

EMS will also be transitioning to new uniforms hopefully in the March/April 2019 timeframe. They will be a more comfortable relaxed unitorm shirt but remain well marked as EMS providers fr4om Lower Allen EMS. We are also examining high visibility outwear for all staff so they are highly visible on and around the roadways when they have responded to calls for service.

In 2019 we will continue to be looking at the overall concept of EMS operations as we move forward with service deployment strategies for improved quality of care and fiscal efficiencies.

The following pages contain tables that provide an overall summary perspective of the monthly calls for EMS service. As is clearly evident, EMS continues to be very busy and steady on a daily basis.




