DEPARTMENT HEAD:

During the month of January, Captain Crone attended BOC meetings and Department Head meetings. A Public Safety Captains' meeting was attended and a direction-setting meeting regarding the future of PD/PSO interaction was attended. Lower Allen played host to the monthly meeting of the Pennsylvania Police Accreditation Coalition.

January was a data and analysis-intensive month. For the February report, the intent is to share some of that information in summary, in conjunction with the usual month-to-month data.

Patrol Officer of the Month was Bryan Rennie - During the month, he made nine arrests. Two of these were self-initiated incidents. One started as a suspicious vehicle with an "RT" tag at Walmart that had been occupied by three younger looking individuals. Ofc. Rennie observed their suspicious behavior and made a mere encounter with two of them. The third had fled. Ofc. Rennie's initial and follow-up investigations on this incident resulted in discovering that the vehicle had been stolen from Hampden Township. The vehicle was recovered, and the involved juveniles were identified and charged.

Ofc. Rennie's second self-initiated incident resulted in five fraudulent inspection stickers being seized from vehicles parked in front of a known drug / problem residence. While on routine patrol in the area, Ofc. Rennie observed the fake stickers on one of the vehicles parked curb side in front of the house. Contact was made with the homeowner, and four more of their vehicles were found to have fake stickers. Charges were filed.

Ofc. Rennie was assisted Ofc. Scarlato and other officers on an active retail theft where the suspects fled on foot. The suspects were located in the mall lot and again fled from Officers Rennie and Walters. Ofc. Rennie properly used his Taser to subdue one of the suspects which led the other one to surrender.

The totals are in and Officer Rennie was also selected as Patrol Officer of the Year. The selection was a difficult choice due to the fine work being done by many officers, but as you have likely seen in previous monthly reports, Officer Rennie's work stood out.

The Lower Allen Twp. Police Dept. (LATPD) had 1,258 dispatched calls for service from Cumberland County Communications in January 2020. Of those calls, 112 were UCR related.

During the month of January 2020, LATPD made arrests or filed criminal charges on 74 individuals, 25 non-traffic citations, 74 traffic citations, 107 warnings, and 49 parking tickets.

There were 41 crashes reported to LATPD in January 2020. Of those 41 crashes, 10 were reportable crashes and 31 were non-reportable crashes.

The New Year started with staff working hard to select equipment for several new patient care enhancements approved in the 2020 budget. Staff was actively involved in providing feedback and recommendations for the replacement of ambulance 1-74. The staff continues to adapt to change quickly and provide feedback to ensure positive outcomes. The staff's effort and hard work are greatly appreciated.

Much of the staff have had an opportunity to learn the revised peer review performance improvement process to ensure the process can be fully implemented in February. The number of errors requiring correction continues to decrease. When fully implemented in February, peer review for documentation will be done on all the shifts as a regular duty of all staff.

The Patient Refusal Focused Performance Improvement program will transition from Paramedic Quenzer to Paramedic Houser in February due to Paramedic Quenzer changing status. The program will not be affected due to the extensive experience and background of Paramedic Houser.

The schedule continues to be successfully managed in a positive direction. The staff have done an excellent job in covering the openings. The staff's hard work and dedication are commendable and greatly appreciated.

EMS outreach at the Capital City Mall continues weekly. In late January, EMT Chambers received the following information.

While at the mall doing blood pressure checks this morning, one of the customers came up to me to thank us for doing our checks. They stated that one day there were two females doing checks (this was sometime within the past 4 weeks), "a short one and a tall one." (EMT Jackie Dougherty and EMT Amy Nye) One of the females noticed that her husband had an irregular heart rate and asked if they had A-fib. The husband said "no," but this was enough for him to check with his PCP about it. The man does not have A-fib, but after going to his PCP they found some occlusions in one of his coronary arteries, and he had to go to the Cath-lab and get a stent. They said they may not have noticed it until it was too late, but thanks to "those two" her husband is healthy and still walking the mall with his wife.

They wanted me to extend their thanks.

In January, EMS evaluated the blood pressures of 43 mall walkers and discussed a wide range of concerns listed below:

- Orthopedic injuries/falls
- Possible causes of low BP
- Chronic back pain
- COPD
- Cardiac issues (decreased heart rate, arrhythmias, AICD placement)


The Staff, Captain Deaven, and Director Holl continue to work on new ideas and concepts to deliver the highest possible quality of care and continuous improvement for EMS operations.

Request for Service 2015 to 2020 YTD





January-Request for Service by Hour of Day




