There were several critical incidents that were professionally resolved as a result of our dedication and training across all the public safety disciplines. The work that went into the Public Safety Ad Hoc Committee was one of those tremendous accomplishments.

As we move into 2020, the work of the staff and Committee members has laid a solid foundation for the ongoing success of the Department of Public Safety and the volunteer fire departments. We hope to build on that foundation as we continue to serve the residents and visitors to Lower Allen Township.

In the evening attended the New Cumberland Borough Council meeting where officers from Lower Allen Police Department were among those officers that responded to the shooting incidn4t in New Cumberland where officer were under gun fire as a part of a domestic violence incident.

Thursday, December 5th – Attended the Pennsylvania Emergency Management Agency 911 Advisory Board meeting. I serve on that Board as the representative from the PA Chiefs of Police Association.

In the afternoon attended the Boisey Preliminary Hearing at DJ Clement's Office. Boisey is the defendant in the New Cumberland Shooting incident. He was bound over to County Court on all charges, including multiple counts of Criminal Attempt Homicide for firing at the victim, as well as Lower Allen and New Cumberland Police Officers.

Captain Crone presided over his final Pa Police Accreditation Coalition meeting as President, stepping away to allow the next generation of leadership to drive the organization after more than a decade on the executive board.

December was a good month for "feel good" activities, rewarding to both officers and participants alike. First, we were able to present that No-Shave November check to a very appreciative Pink Hands of Hope charity. Several staff participated in handing out coats to kids at Hillside elementary school. Several officers also participated in Shop with a Cop, facilitated by Walmart, providing a positive holiday shopping experience to several kids in need.

Captain Crone was on leave for the later part of December, leaving the agency in the able hands of Lt. Thomas and Sgt. Foltz, both of whom performed admirably, as always.

Patrol Officer of the Month was Officer Alex Milletics. Per the nomination submitted by his supervisor: "During the month of December, Ofc Milletics made four self-initiated drug arrests, conducted two felony vehicle stops, recovered a stolen vehicle which also involved an active PFA violation, located four suspended vehicles, assisted agencies on 11 different incidents, and single-handedly located and apprehended an armed robbery suspect. The suspect had fled on foot during a traffic stop and was later found with a firearm hiding in a dumpster. Ofc Milletics is a leader not only in his squad but in the entire department in consistently displaying a high level of work ethic, job skill, and confidence in engaging criminal activity."

The Lower Allen Twp. Police Dept. (LATPD) had 1,248 dispatched calls for service from Cumberland County Communications in December 2019. Of those calls, 100 were UCR related.

The holidays are always a stressful time of year. Staff did a great job of meeting the communities needs and working hard to move the organization forward in a positive direction. The staff continues to adapt to change quickly and provide feedback to ensure positive outcomes. The staff's effort and hard work are greatly appreciated.

Teamwork, and the integration of EMS continues to strengthen improving the overall performance of EMS.

In December we worked on developing the changes made in ESO with the CAD import feature as well as continued development of the peer review quality assurance for the purposes of documentation. Staff access was expanded providing greater transparency and ability to learn from other staff members. The staff's understanding of the common errors has increased reducing the number of errors.

The Patient Refusal Focused Performance Improvement program continued to develop in December. The program involves the review of all patients who refused care. All patient refusals are reviewed by a senior paramedic. Attempts are made to contact the patient and speak with them to ensure they were satisfied with the service they received and have no additional medical concerns. This program also includes public service request such as lift assists. Updates were made to processes to ensure accuracy.

The expansion of existing technology capabilities in the PlanIT scheduling software continued to improve with new features being added to the system. EMS is continuing to enhance the use of existing technological resources, such as PowerDMS and Guardian. Use of the existing technological resources improves efficiency and effectiveness in administration and operations. The importance of technology in EMS cannot be overstated.

The schedule continues to be successfully managed in a positive direction. The staff has done an excellent job in covering the openings. The staff's hard work and dedication are commendable and greatly appreciated.

LATEMS was approved as a member of the Pennsylvania Emergency Health Services Council (PEHSC) which serves as a statewide advisory board. Captain Deaven will be the PEHSC representative and will be working with the PEHSC staff and other council members across the state on EMS education, the Vision 2050 project, Community Paramedicine and REPLICA. Captain Deaven was elected to the Board of Directors of the Pennsylvania Fire and Emergency Services Institute (PFESI) as an EMS representative. PEHSC and PFESI are state advisory boards providing information to decisions makers and helping to shape policy.


The staff, Captain Deaven, and Director Holl continue to work on new ideas and concepts to deliver the highest possible quality of care and continuous improvement for EMS operations.

Request for Service 2015 to 2019 YTD





December-Request for Service by Month




December- Request for Service by Day of the Week







PMH: HLD, HTN, prior valve replacement and former tobacco abuse. Patient had a new LBBB on EKG which prompted Code STEMI. Patient was in pulmonary edema/CHF with respiratory failure prior to being taken to the cath lab. She had normal coronaries with an EF of 20%. Patient is being evaluated for any further valve issues and cardiomyopathy.
