

LOWER ALLEN TOWNSHIP DOG PARK RULES AND REGULATIONS

NO ATTENDANT ON DUTY. USERS OF THIS FACILITY DO SO AT THEIR OWN RISK. LOWER ALLEN TOWNSHIP SHALL NOT BE LIABLE FOR INJURIES TO DOGS, THEIR OWNERS/HANDLERS, OR OTHERS THAT USE THE DOG PARK. THIS AREA IS FOR DOGS AND THEIR OWNERS/HANDLERS ONLY.

The owner/handler is 100% responsible for any injuries inflicted by their dog. Prevent injuries by supervising your dog(s) closely at all times. Dog owners/handlers are legally and financially responsible for their dog's behavior.

OWNERS CAN BE FINED FOR NON-COMPLIANCE OF THE FOLLOWING RULES

1. All Dogs must be spayed or neutered.
2. All Dogs must be legally licensed, vaccinated and shall wear a visible dog license and identification.
3. Absolutely no dogs over thirty (30) pounds are permitted in the small dog area.
4. Aggressive dogs are prohibited from this park and surrounding area. Dogs exhibiting aggressive behavior must be removed from the park immediately, without debate.
5. All dog(s) owners/handlers are solely responsible and liable for injuries or damage caused by their dogs.
6. All dog(s) waste must be cleaned up by owners/handlers and placed in the proper receptacles. This is the single most important thing dog(s) owners/handlers can do to help ensure the ongoing success of the dog park. Leave the area cleaner than it was when you arrived.
7. All dogs must be leashed and under control by their owners/handlers at all times outside of the fences Dog Park. This includes when entering and leaving the Dog Park and the dog(s) owners/handlers must have a leash in their possession at all times within the dog park.
8. Absolutely no dogs under four (4) months of age are permitted in the dog park. No exceptions
9. Absolutely no animals other than dogs are permitted in or around the Dog Park. This park is designated for the use of registered Dog owners/handlers and their dogs; no other animals are allowed.
10. All dog owners/handlers must be in the Dog Park within view and voice control of their dog(s) at all times. You may not use the Dog Park as a babysitter for your dog(s) or your children. You need to be in control of your dog(s) at all times.
11. All Children under the age of twelve (12) must be closely supervised at all times by a Guardian. It is strongly recommended that young children are not brought into the Dog Park for their own safety.
12. Absolutely no more than three (3) dogs and/or children are allowed per owner/handler or Guardian.
13. Absolutely no food, treats (human or animal), alcoholic beverages, strollers, bicycles, or children's toys are allowed in the Dog Park.
14. Absolutely no personal property to be left unattended in Dog Park. Personal items left in or in around the Dog Park will be removed by Lower Allen Township staff at their discretion and disposed of. Lower Allen Township and their Employees are not responsible to replace any personal items that are disposed of.
15. All Owners/Handlers must stop their dogs from digging and fill any of the holes that the dog(s) dug.
16. All excessive Barking is prohibited by Lower Allen Township Ordinance.
17. First Time Dog Park users should consider visiting the Dog Park during non-peak times.
