

**ORDINANCE NO. 2022-07**

**AN ORDINANCE OF LOWER ALLEN TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, AMENDING MODIFYING AND CHANGING THE CODE OF THE TOWNSHIP OF LOWER ALLEN, AT CHAPTER 23 INTERGOVERNMENTAL COOPERATION AT ARTICLE I BY SECTIONS 23-3, 23-4, 23-5, 23-6, 23-7 AND BY ADDING A NEW SECTION 23-3 AND DELETING ARTICLE V AND ARTICLE XIII IN THEIR ENTIRETY TO PROVIDE FOR IMPLEMENTATION OF INTERGOVERNMENTAL COOPERATION AGREEMENTS BY RESOLUTION OR ORDINANCE**

**BE IT ENACTED AND ORDAINED** by the Board of Commissioners (“Board”) of Lower Allen Township (“Township”), Cumberland County, Pennsylvania, and it is hereby enacted and ordained by the same as follows:

**ENACTED AND ORDAINED AS FOLLOWS:**

**SECTION I**

Lower Allen Township Code Chapter 23 Intergovernmental Cooperation is amended by deleting current Sections 23-3, 23-4, 23-5, 23-6, 23-7 and by adding a new Section 23-3 as follows:

Pursuant to Section 2305(a) Ordinance and Resolution of the Intergovernmental Cooperation Code, (53 Pa.C.S. Section 2301 et seq.) Lower Allen Township shall enter Intergovernmental Cooperation Agreements through the passage of a Resolution by its governing body. Where the Intergovernmental Cooperation Code requires adoption by Ordinance, the procedure will be followed accordingly.

**SECTION II**

Lower Allen Township Code, Chapter 23 Intergovernmental Cooperation Agreement is amended by deleting Article V – Lower Allen Township/Shiremanstown Borough, Walnut Street Cooperative Agreement and Article XIII – Capital Region Council Governments’ Building Code Department in their entirety. The remaining Articles in Chapter 23 shall be renumbered.

**SECTION III**

The remaining Sections of Chapter 23 will remain in full force and effect.

**SECTION IV**

The provisions of this Ordinance, as far as they are the same as those of ordinances in force immediately prior to the enactment of this Ordinance, are intended as a continuation of such ordinances and not as new enactments. The provisions of this Ordinance shall not affect any such suit or prosecution pending, or to be instituted to enforce any right or penalty, or to punish any offense under the authority of any ordinance repealed by this Ordinance.

**SECTION V**

The provisions of this Ordinance are severable, and if any of its provisions shall be held to be unconstitutional, illegal, or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provision not been included herein.

**SECTION VI**

This Ordinance shall be effective upon the enactment date.
