#### **ADD ITEMS TO AGENDA**

Mr. **EBY** made a motion to add two items to the agenda: (1) the quarterly financial report from the Finance Director and (2) the discussion of Form 990. Mr. **MARONE** seconded the motion. Motion carried, 5-0

#### **APPROVAL OF MEETING MINUTES**

Mr. **EBY** made a motion to approve the minutes of September 15, 2025, with one correction to a township personnel title. Mr. **MARONE** seconded the motion. Motion carried, 5-0.

#### **SOLICITOR'S REPORT**

Solicitor Miner stated he has nothing to report.

#### **FINANCE DIRECTOR'S REPORT**

Director Knoll discussed Form 990 and presented the quarterly Finance Report for the Development Authority stating the following:

- Director Knoll explained that since the Development Authority is categorized as a 501(c)(3) organization, Form 990 must be filed each year. The forms for 2023 and 2024 are going to be filed.
- Director Knoll presented the Financial Report for July, August, and September.
- Questions from the Board:
  - Secretary Eby asked for clarification on the form filings.
    - Director Knoll clarified that there are two separate filings for the years 2023 and 2024. She assured that this will bring everything back on schedule and that the 2025 form will be filed at the beginning of 2026.

#### **DIRECTOR OF COMMUNITY AND ECONOMIC DEVELOPMENT REPORT**

- Status of development projects in the Township
  - Director Sweeney reviewed the following:

- Liberty Forge submitted a revised plan and received review from the Township Engineer. They will be going before the Planning Commission at the November 18<sup>th</sup> meeting for possible approval or recommendation.
- Allen Middle School submitted a revised plan and received review from the Township Engineer. They will be going before the Planning Commission at the November 18<sup>th</sup> meeting for possible approval or recommendation.
- Staff have received a subdivision plan submission for 960 Century Drive to subdivide the lot into two separate lots.
- There was a brief discussion on the beginning of construction for Cedar Run Business Park.
- There was a brief discussion on the Dairy Farmers of America parcels. They approached the Township to vacate a portion of the public street; the Township obliged and had a hearing. This will give them enough land to extend their parking area.
- Secretary Eby mentioned that the Hempt Brothers parcels still have not transferred over to New Enterprise in the Cumberland County property filings.
