SLD 2024-01 Preliminary/Final Land Development Plan for Trinity High School Band Room Addition

Mr. Adam Anderson spoke about constructing a 2,055 square foot room addition onto the existing school for a band room. He showed the Board the plan on the screen. He stated there would be no new utilities and landscaping would be done.

Mr. Knouse went over a few of the comments included in his letter about the plan. He noted a lighting and photometric plan needs to be provided, all certificates need to be completed prior to recording the plan, street trees need to be provided unless they would request a waiver and stormwater requirements. The applicant did request a waiver for landscaping with the trees.

Mr. Bennett stated they received the County's comments and there were three standardized comments on the letter.

Commissioner Swartz mentioned the waiver for sidewalks and the location of the school with the Township looking to keep on top of sidewalks throughout the Township. Mr. Anderson noted they had the sidewalks installed with the plan for their wrestling room addition.
