

ORDINANCE 2026-03

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF LOWER ALLEN TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, AMENDING, MODIFYING, AND CHANGING THE CODE OF THE TOWNSHIP OF LOWER ALLEN, 2023, BY: ADDING SPEED LIMITS AT SECTION 209-50; ADDING STOP INTERSECTIONS AT SECTION 209-58; ADDING PARKING RESTRICTIONS AT SECTION 209-63.

BE IT ENACTED AND ORDAINED by the Board of Commissioners (“Board”) of Lower Allen Township (“Township”), Cumberland County, Pennsylvania, and it is hereby enacted and ordained by the same as follows:

SECTION I

A. Section 209-50, Schedule I: Speed Limits of the Code of the Township of Lower Allen, 2023, shall be amended to add the following:

<u>Name of Street</u>	<u>Speed Limit (MPH)</u>	<u>Location or Limits</u>
Creekwood Drive	15	From Winding Way to terminus at Creekwood Park
Locust Road	25	From Locust St to terminus at cul-de-sac

SECTION II

A. Section 209-58, Schedule IX: Stop Intersections of the Code of the Township of Lower Allen, 2023, shall be amended to add the following:

<u>Intersection</u>	<u>Type of Device</u>
Locust Road at Locust Street	1-way
Stephenson Road at Locust Road	1-way

SECTION III

A. Section 209-63, Schedule XIV: Parking Prohibited at All Times of the Code of the Township of Lower Allen, 2023, shall be amended to add the following:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Ruth Way	North	From the intersection of Emerson way to a point 20 feet East on Ruth Way

SECTION IV

The provisions of this ordinance, as far as they are the same as those of ordinances in force immediately prior to the enactment of this Ordinance, are intended as a continuation of such ordinances and not as new enactments. The provisions of this Ordinance shall not affect any such suit or prosecution pending or to be instituted to enforce any right or penalty or to punish any offense under the authority of any ordinance repealed by this Ordinance.

SECTION V

The conditions of this Ordinance are severable, and if any of its provisions shall be held to be unconstitutional, illegal, or invalid, such decision shall not affect the validity of any of the remaining provisions of this Ordinance. It is hereby declared as a legislative intent that this Ordinance would have been adopted had such unconstitutional, illegal or invalid provision not been included herein.

SECTION VI

This ordinance shall take effect immediately.
